Harold grew up in Philadelphia. After finishing school, he went to work at Gimbels for 33 years. At the time of his retirement, he finished his career as a "buyer," traveling throughout the Orient for Gimbels. Instead of retiring, Harold purchased a Jitney license (small bus for public transportation) and operated in Atlantic City for 18 years. In 1998, he and his wife, Gloria, moved to South Florida, settling in Wynmoor community.

For more than a decade, Harold volunteered and served the Wynmoor community as President of the Wynmoor Community Council and as President of his association (Nassau). He led the Wynmoor Village through Hurricane

Wilma in 2005 and worked daily for many years with the council management committee and administrator, Bruce Bandler. During his reign as President, Harold hosted Vice President Biden and Governor Charlie Crist to Wynmoor.

Harold was known to always have an open-door policy for all residents of Wynmoor. He would go out of his way to help those in need. He was married for over 50 years to his wife Gloria and had two children, Wendy and Mitch. Harold will be missed by all those who knew him and never forgotten.

# Signs Of Unsafe Driving In Older Adults

(NAPS)—The National Highway Traffic Safety Administration (NHTSA) estimates that there are more than 38 million drivers age 65 and older. Age is not the only factor that can impact driving abilities, but it is an important one. There is evidence that most people experience age-related declines in physical and mental abilities. These changes—which can affect everything from vision to how quickly you can make decisions—influence how well you can drive. They can also be difficult to address for yourself or with older people you know, since driving often represents freedom, independence and control.

But transitioning from driving doesn't mean you have to lose these things. Your health care providers or Area Agency on Aging ([www.eldercare.gov](http://www.eldercare.gov)) can point you toward a range of transportation alternatives in the community. The first step toward finding those tools is recognizing when you might need them.

## Signs that an Older Adult's Driving Skills Need Testing

So how do you know whether you or an older adult you know is developing difficulties as a driver? These issues can be warning signs that suggest that an older driver may need to be tested or evaluated:

- Getting lost in familiar areas
- Ignoring traffic signs and signals
- Becoming easily agitated or angered
- Falling asleep or being unable to concentrate when driving
- Reacting too slowly to dangerous situations
- Forgetting or ignoring driving basics (like yielding to the right of way)
- Having trouble judging distances



Are medicines affecting your driving? Some medications can make people feel drowsy and less alert or can limit the ability to pay attention. Some prescriptions even warn against driving. Review medications with your primary care provider or a pharmacist to see whether certain medicines might impact driving.

I was one of four of Sean's closest friends. We had been hanging out together since seventh grade. Let me see, that would have made us twelve years old. In spite of the intervening years, we maintained as close a relationship as distance and work obligations would permit. Now, with Sean's passing and the combat death of Fred in Korea, Earle and I were last of the foursome. Caribou, Maine was on the other side of the world from Earle who was living in Hawaii. That left me to fulfill the promise.

Sean had lost both his parents at an early age. No youngster should have to face the trauma of losing one parent; it's worse when you lose both. At age seventeen, this was what Sean faced. As unfortunate as this was, his

grandparents took on the responsibility of his care. It was a difficult time but Sean adjusted well.

The four of us often spoke of the happiest times of our lives and we all came to the same conclusion. During our formative years, through college and the military, we agreed that the best time of our lives, to date, were the carefree years of our youth at Revere Beach.

In retrospect, we were probably right. It was there we were preparing for the coming of age. It was there we came of age, and it was there that we met and eventually married the love of our lives. Reflecting on our conclusions, we were right. It was the happiest days of our lives

"You have to promise," Sean said to all of us. We didn't ask, "promise what?" He made his wishes known to each of us. We had the rapport and understanding that no further dialogue was necessary.

I left New Jersey about five thirty in the morning and arrived at Sean's home in Caribou, Maine a little after one in the afternoon. Paul was a gracious host and a gourmet cook. He apologized that his wife was not able to accompany him, but, as he explained, someone had to care for their four children. We talked, ate, drank and reminisced for hours. It was close to 12:30 AM. Although he urged me to spend the night, I told him that I wasn't tired and probably wouldn't be able to sleep anyway. There was sadness everywhere...we hugged. He knew, as I did, what I had to do.

He gave me the unadorned bronze container and I gently placed it in a small box on the backseat of my car. There was a small sealed envelope taped to the bottom of its square base. I debated going back and giving it to Paul, but all the lights were off. I decided, rather than disturb him, I'd just leave. If it turned out to be important, I'd mail it.

I nearly ran over the FOR SALE sign as I backed out of the leaf-encumbered driveway. The clock

on the dashboard read 12:45 AM, but I was wide-awake in spite of the twenty-seven plus hours I had been awake. I made my way to route #1 and headed South.

About four in the morning I was wiped out. I approached Brunswick, Maine and stopped at an all night DUNKIN DONUTS. Other than several students wearing Bowdoin College sweaters and a couple of truckers, I was the only one there. They ignored me as I wolfed down a Boston Crème and a large coffee. I went to the restroom and was startled at the face I saw in the mirror. The image looked like a survivor from the Alaskan 1500 mile IDITAROD. It dawned on me that the face was mine.

I filled my gas tank and continued on my way. I was partially rejuvenated..."hang in there," I told myself, "hang in there." The last stanza of a Robert Frost poem kept going through my mind:

**STOPPING BY THE WOODS ON A SNOWY EVENING...**

*The woods are lovely, dark and deep,  
But I have promises to keep  
And miles to go before I sleep,  
And miles to go before I sleep*

The only thing missing was the snow. The skies opened up and it poured. Three hours later, about 7:30 in the morning, I reached my destination... Revere Beach, Massachusetts. The rain was very heavy and the beach was absolutely empty.

I am not a particularly a religious person, but I must confess, I am spiritual. I had a warm feeling that Sean had much to do with the weather. I pulled my car over close to where the four of us spent many days, weeks, even years enjoying the sun, sand, and ocean. I thought back to the frivolity only the young can truly appreciate. I walked to where the ocean meets the sand, opened the urn and watched as its contents mingled with the wind and rain.

I was soaked through and through and cold, but I didn't care. There was no way I could go the two hundred plus more miles to New Jersey so I checked into the local Ramada Inn and booked a room. The hotel clerk looked at me oddly. "I can give you a room but you'll have to be out by 5:00 PM. We don't book usually in the morning."

"No problem," I answered.

I was so disheveled, I couldn't blame him. I took my overnight bag from the trunk. It was then that I noticed that the envelope was still attached to the urn. I brought everything into my room, shaved and showered, put on my pajamas and settled in for a few hours' sleep before starting the final junket of my trip. I didn't think of food; I was more tired than hungry.

I felt better after going through the cleaning cycle. I opened the envelope and read the handwritten note. The message was in Sean's handwriting, legible, but in a shaky script. I surmised it was given to Paul with instructions to include it with his remains. It was addressed to noone in particular but it was obviously intended for one of us.

*"Thanks for being my friend and keeping your promise to me...S."*

Before retiring for a few hours' sleep, I watched the ending of the movie, "STAND BY ME." For the readers who are not familiar with the film, briefly it relates to an experience of four close friends, all twelve years old, that would have a lifelong impact on their lives. The author, who was one of the four youngsters, narrates, many years later, the meaning and significance it had on each of them. He ends his story with a poignant conclusion:

*"I never had any friends later on, like the ones I had when I was twelve... Jesus.... does anyone?"*

I thought about this for a few moments and fell asleep with the TV still on. I awoke from a deep sleep around 4:00 that afternoon, dressed, ate, and I left for New Jersey relaxed and at peace with the world.

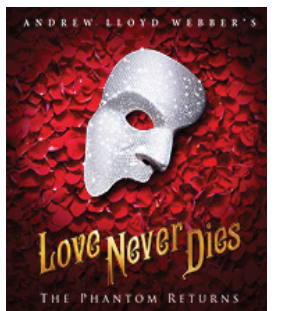
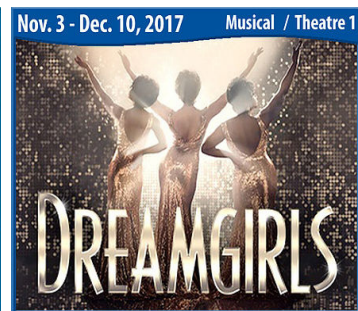
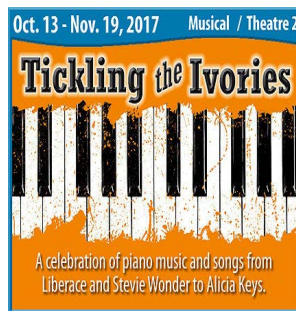

# YOUR COUNTY COMMISSIONER

## THE ON-GOING WAR AGAINST THE FLORIDA TURNPIKE

As most of you know, the Turnpike officials decided that they wanted to expand the turnpike an additional four lanes for approximately four miles starting at Wiles Road and extending to Atlantic costing in excess of \$1 billion dollars. Most troubling is that they want to put all four lanes on the west side of the turnpike where the sound wall would only be 5 feet from the property line of Wynmoor.

What is interesting to point out is that the Turnpike officials never told any of the local elected officials of their plans. The Turnpike officials purposefully did not disclose their plans to your Congressman, your State Representative, your State Senator, your Coconut Creek City Commissioners or me, your County Commissioner. The Turnpike officials demonstrated that they have no care and no concern about you or your opinions of their plans.

Two weeks ago, I sponsored a Resolution before the Broward County Commission opposing the expansion of the Turnpike as it is currently planned. My fellow County Commissioners voted unanimously to oppose this expansion. Also, your Coconut Creek City Commissioners

voted against the expansion as well. Lastly, and most importantly, the Metropolitan Planning Organization, which is influential in roadway expansion projects, agreed to “table” and take off the turnpike expansion in its future plans.

Besides organizing different local governments to oppose the expansion plans, both Broward County and the City of Coconut Creek have been consulting with attorneys to take this fight to court if necessary. Also, considering that next year is an election year, I will actively seek out candidates running for Governor who will agree to publicly oppose the turnpike expansion.

Based on the above, the Turnpike officials decided to cancel their public hearing. I expect that they will come back at a later date and try again to push their agenda of expansion. However, what I can promise you is that we will fight this expansion (as it is currently proposed) in court and in government. Please let me know your thoughts by emailing me at Mbogen@Broward.org

away from our city. If you had any inconveniences, they were short lived and by now, our roads have been cleared and most of the debris has been picked up. Our schools have reopened and our lives restored. However, please do not forget our American citizens in the US Virgin Islands, St. Thomas, St. John, St. Croix and Puerto Rico. Most of those Islands, including the Caribbean Islands, Houston and the Keys are still feeling the aftermath. Some still do not have electricity, mail delivery, hospitals, schools and the commodities that we were able to enjoy so quickly. We are thankful that many lives have been spared, although many lives lost.

Our budget has been set. We will see a very small raise in our taxes, but for that, we offer you more police, better 911 response and a beautifully maintained city. We will replant, refurbish and keep our residents active, with pickleball tournaments, football, basketball and other activities for children.

# When People Are In Trouble, BSO Is Here To Help

When disaster strikes, the Broward Sheriff's Office is ready, willing and able to lend a helping hand to those in need at a moment's notice—no matter where it occurs. From the heart of Broward, to the people in need in the Florida Keys and Puerto Rico, BSO was there to assist in whatever manner was needed during this deadly and catastrophic 2017 hurricane season.

Ensuring the safety and security of Broward residents and visitors is always BSO's top priority, even in the face of battering winds and flooding rains. This hurricane season, the hardworking men and women of this agency gave all they had to keep Broward safe. However, we also answered the call for help from our neighbors and friends who were in desperate need of assistance. We didn't do this because we had to. We did because it's the right thing to do. Public safety is about helping those in need, even if disaster doesn't touch us personally. And as this devastating hurricane season showed, there were many far less fortunate than us here in Broward that required the kindness and assistance of outside help.

In the immediate aftermath of Hurricane Irma in September, BSO sent a unit of BSO deputies, specialists and communications equipment to Monroe County, where some of the worst damage from the hurricane occurred. The Communications on Wheels (COW) vehicle we set up there allowed first responders in the Keys to coordinate their relief efforts and assist the storm-weary residents of Monroe County.

Our civilian dispatchers also answered the call for help. Monroe County,

from the Everglades to Key West, received some of Irma's nastiest winds and weather and needed a lot of help recovering. They asked for dispatchers to help field some of the emergency calls they were receiving, and we sent some of our finest.

Seventeen of our fire rescue personnel also made the trip to the Florida Keys to assist residents, whose way of life forever changed because of the storm. In one instance, a weakened and thirsty Key Deer was given a second lease on life, thanks to a member of BSO Fire Rescue who hand-fed the animal four bottles of water and helped it recover. BSO also sent a contingent of fire rescue personnel to Puerto Rico to assist local authorities in handling the devastation caused by powerful Hurricane Maria.

None of this would have been possible, however, had it not been for the amazing residents of Broward County. I am so incredibly proud of you. I was amazed by your incredible acts of kindness and selflessness, and impressed by how you followed the direction of public safety professionals to the best of your abilities, keeping your families safe during the worst of the storm. Property and possessions are replaceable; lives are not. Your response made Broward safer and allowed us to help those in dire need elsewhere.

Here's hoping for a quiet final month in the tropics. However, please know we are ready to assist anyone who needs us at the drop of a dime. When people are in trouble, we try to help. We are BSO, and that's what we do.

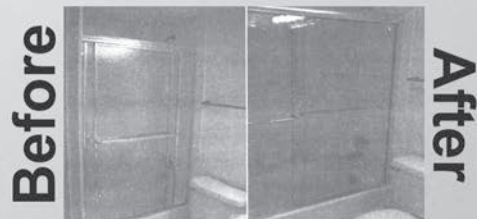

# Dear Dr. Joy...

Dear Dr. Joy,

I am facing a life change with my mom right now. She is 83 years old and she had a bad fall in April. Ever since then, I feel like (and I am sure she feels the same) as if her life has gone downhill. Before her fall, she had started developing early signs of dementia but she was functioning, driving (an hour North to see myself and my children), shopping, caring for her animals and eating quite well. I have seen a significant digress in the past few months. Since her fall and since we've noticed these symptoms with her, my two brothers and I have decided that an independent living facility would be a very good choice for her in this stage of her life. As you may know, in these facilities, help is offered in two other stages, as needed; Assisted Living and Full Nursing Care. Amazingly, she agreed to sell her house of 50 years and move. The facility is 10 minutes from my home so encouraging her that she would see her two granddaughters (her pride and joy) everyday brought happiness to her and made that "talk" a little easier. In addition, her home of 50 years is very very damaged and distressed, which became another persuasive perspective on our part; that she could no longer maintain a house with termites, possible mold, leaky roof, fleas, and who else knows what.

To begin, my husband and I toured at least 10 facilities. We narrowed it down to 4, then finally showed her 2. The whole time, I kept referring to these places as "apartments." She had a smile on her face the whole time and chose her favorite from the last two.

Now came the hard part; sorting through her home and minimizing her things and belongings to about 10% that she would be able to take with her and would fit in her new apartment. We only have spent one day thus far on her closet alone. She was more accepting of giving away clothes than of her glass wears, antiques and figurines that my husband and brother tackled in the other room. She went from accepting this day, even helping, to shortly yelling at us and saying, "what are you doing with my things?" It was very stressful and very overwhelming for me; can you imagine how she must feel? I am dreading going back to her house to continue this process. My older brother who is power of attorney wants to move her first then deal with the house and her "stuff" after she's moved out. I don't think that is right either. I think she needs to have a say, a choice, and the most positive and less stressful experience with this transition as possible.

I would gladly accept any advice you may have for me as well as other residents and their families who may be facing this same transition I am with my mom. How do we make her feel confident that she is making the correct decision at this point in her life, while still gaining her independence? The very last thing I want for my mom is to feel like she gave up everything and this is the end of her life. The facility offers so many activities and new experiences for her, not to mention a 5-course meal every day!

I appreciate you writing for our paper and taking the time to address these issues. I think many readers will benefit from your experience and expertise, including myself.

*Dear Concerned Daughter,*

Thank you for your timely and important question. I will try to answer it with the level of sensitivity with which it was written. Firstly, I am so sorry that you are going through this difficult time. My own parents didn't live to be old enough for me to have to deal with this issue but I have gone through it many times, with friends, other family members and clients.

You are dealing with many interconnected facets of the situation. Let's see if we can break them down into their components. You have you and your sibling's psychological perspectives as well as the practical ones. There is your mom's psychological issue as well as the practical one for her.

I have taken the liberty of discussing the practical side with someone who used to be involved in this from a business standpoint and I think I received some good advice which we can address first. You spoke of the logistics of cleaning out your mom's things. One of the suggestions I received was to not involve her in all of it at once. I agree because from a psychological standpoint, it is just too overwhelming for her. She can take what is necessary for the move and tell her you are going to rent a small storage unit for the rest of her things that you or one of your brothers will go through with her slowly at her leisure. Since you mentioned the possible onset of dementia, after some time, she may not even miss any of these things and then they can be discarded. Knowing she still has access to them will allow her to feel secure about their safety. Regarding the dementia, are you sure this is what her forgetfulness is about and not a more common symptom of anxiety, change and the disorientation due to the move?

If she is going into a "step" facility, does she bring her own household items and furniture? This will be helpful in allowing her continuity. Can she spend time in the facility before she moves in? Can she meet her neighbors? If she can move in already feeling like a part of the new place, she will feel safer.

Remember, emotionally, she is afraid. Not only is she giving up her home which after 50+ years is her security, she also knows this change has greater meaning. She is not just changing residence, it means she is growing older and although you say she will be going into an independent living facility, she can readily see that the next step to Assisted Living looms large. This is frightening and she needs her family even more now to understand that and be supportive. It is most likely frightening for you as well, as you see you are losing your independent "young" mother and this is a new next step for you too. Please be patient with her, while at the same time, stay grounded with your own family. I recognize this is a thin line to walk. You and your family will need to be supportive of each other, with no one person taking all of it on.

I mentioned continuity earlier and it is very important. If you mom has a favorite restaurant or a place she likes to visit, maybe you can continue to take her out to these places so it doesn't feel as though everything has changed and she is thrown all at once into a new life. Let her spend as much time as possible with the family outside the residence, especially the grandchildren. As she acclimates more to her new surroundings and gets more involved in new activities, this time will probably decline spontaneously.

If you would like to ask a follow up question, I will do my best to help. Best of luck to you, your family and your mom.

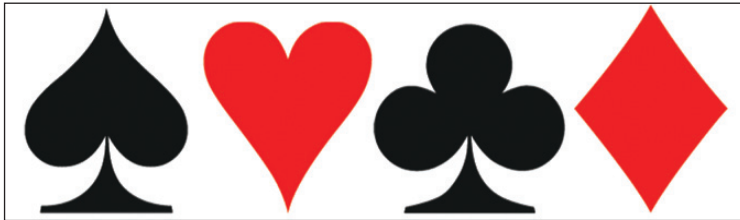

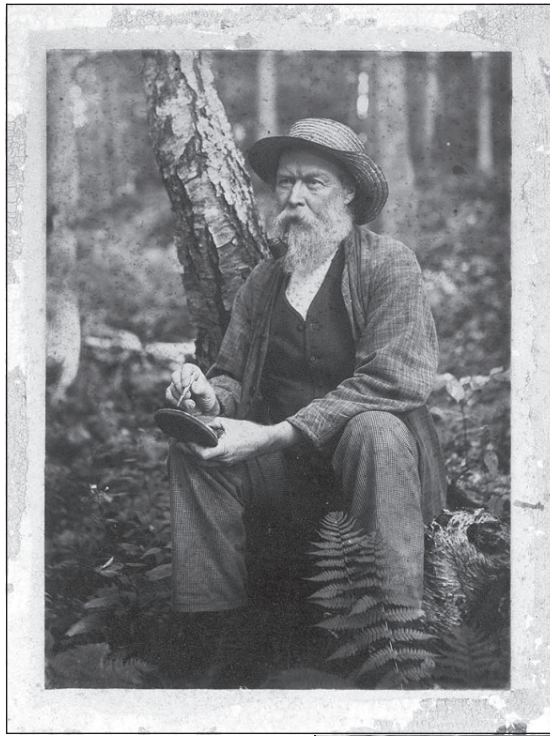
# The Promotion of Social Justice in a Small Vermont Community

This summer, I returned to Vermont and visited the Rokeby Museum for the first time. The Rokeby Museum is located in a small Vermont community, Ferrisburgh. Ferrisburgh is about a forty-minute car ride from the summertime hustle and bustle of Vermont's largest city, Burlington. Ferrisburgh has a tradition of supporting better treatment of Americans of color. During the Antebellum Period and Civil War, it had a strong Abolitionist Community. Abolitionists associated with Ferrisburgh at that time included William Lloyd Garrison, Rowland Robinson (owner of Rokeby Home and Farm), Joseph Carpenter, Charles Burleigh, and Frederick Douglass, a prominent Afro-American Abolitionist. Ferrisburgh was part of the Underground Railroad System which helped people of color escape slavery, during the Antebellum Period and Civil War.

I visited the home of the Four Generations of Robinsons, Rokeby. The Robinsons, when they came to Ferrisburgh in 1791, were farmers of the Quaker religion who raised Merino Sheep. Rowland Robinson, the son of Thomas Rowland Robinson, was a Quaker farmer who strongly believed in the Abolitionist ideals of William Lloyd Garrison and housed in his home, people of color escaping Slavery (Jessie). Rowland Robinson was prosperous and he also raised horses besides Merino Sheep.

At the Rokeby Museum, adjacent to the Rokeby home, I learned about the horrors of Slavery and the devotion of the White Abolitionists to abolish

this evil institution, especially Rowland Robinson. The curatorial work at Rokeby is superb and it includes fine dioramas depicting the evils of Slavery. In 2017, Rokeby promotes peace and justice for all Americans, regardless of race, color, creed, religion and sexual orientation.

Vermont is also the birthplace of prominent Abolitionist and former President of the United States, Chester Alan Arthur (East Fairfield, Vermont). However, Chester Alan Arthur promoted Abolitionism in Albany, New York when he was an attorney, during the Antebellum Period and Civil War. Annette McKinney and I were honored to be guests of this fine Historic Museum Complex.

# HISTORY CORNER

## Black Moses / Harriet Tubman

It doesn't get any better than this. It is no wonder that the Secretary of the Treasury in 2016 choose Harriet Tubman, of all the great women in the United States, to grace the front of the new twenty-dollar bill. She was only five feet two inches tall, could not read or write, and packed a gun. Besides all the remarkable things this woman did, she was the only woman in the Civil War or any other American War, to lead an armed raid against the enemy. She was born a slave, escaped, and then returned time and time again to help others escape. Tubman became a scout, spy, nurse, cook, and leader of an armed raid for the Union Army. She became known as the "*Moses of her people*" by both slave and free.

Harriet Tubman was born into slavery in 1820, and lived for 93 years through some of the most incredible changes in America. At an early age, she was beaten on a regular basis. One of the most dramatic times was when she was whipped five times before breakfast. She received a life-long injury when an overseer hit her in the head with a two-pound lead weight for not helping restrain a runaway slave. From this injury, Harriet suffered headaches and seizures for the rest of her life. Eventually, she had brain surgery to relieve the pain. Instead of crippling or breaking her, this injury made her more ardent to fight against slavery and oppression.

Hearing rumors that her family was to be separated, Harriet and her two brothers ran away. Her brothers, fearing capture and severe punishment, returned to their Master. Harriet made the journey back with them, but then escaped later by herself to Pennsylvania, with the help of abolitionists. She fell in love with freedom and the opportunity to wake up each morning and make her own choices, without being whipped. However, her love for family and friends drove her with an intense passion to help them gain their freedom. Thirteen times she risked her life returning to the plantations she knew in Maryland and led her family and friends through the "underground railroad" to freedom in Canada. During one of these trips, a man had second thoughts about running away and started to turn back. To protect the others and the secrecy of the escape route, Harriet pulled a pistol from her dress, pointed it at his head, and said, "Dead men don't talk." They all made it safely to Canada. They chose Canada as their destination, because in 1850, a new law was passed that gave bounty hunters the right to come into free states, arrest runaway slaves and return them to their owners. By law, Northern sheriffs and marshals had to assist the bounty hunters.

When the Civil War broke out, Harriet made the decision to do all she could to help the Northern War effort. She joined the Union as a cook, nurse, and became a scout for the military. She infiltrated critical locations, gathered information from local slaves, and passed it on to the army.

The Union had invaded Beaufort, South Carolina and established a military base in and around Beaufort. The North wanted to control the rivers and disrupt communication and destroy supplies intended for the Confederates. Col. James Montgomery was to lead the raid at Combahee Ferry. Because Harriet had spied out the area and helped plan the raid, Montgomery asked her to participate in the raid and lead some of the black troops who had been former slaves. With her trusty pistol and toting a rifle, she led one of raiding parties that fought Confederate outposts. She destroyed bridges, captured needed supplies, burnt houses, mills, and any supplies they could touch and took over 700 slaves back with them. The raid was so successful that it was followed by many more, and these raids struck fear among all coastal towns in the South.

When the war ended, she continued to serve others. Tubman became a spokesperson for women's rights and was a champion for minorities, disabled veterans, the handicapped, and the aged. In her later years, she bought a house in Auburn, N.Y. and turned it into a nursing home for elderly African Americans. After her death, her fearlessness, determination, and fight for justice was recognized by all. Schools, parks, streets, movements and organizations have been named after her. Soon, we will all be carrying a reminder of Harriet Tubman in our wallets.

# Vaccination Safety-- No Question About It

After we noticed the safety of vaccines here in the U.S. being called into question, we wanted to let YOU know the facts. Not only is the quality and integrity of your vaccines held to the highest standards, but every year the Centers for Disease Control and Prevention goes to great lengths to provide an easy-to-follow, appropriate vaccine schedule that's as safe as possible for children, adolescents and adults.

Perhaps you weren't aware that you're also the beneficiary of a robust National Vaccine Plan that's administered by the office of the secretary of health from Health and Human Services. This has helped greatly to improve vaccine safety over the past three decades.

## Getting a Vaccine Approved

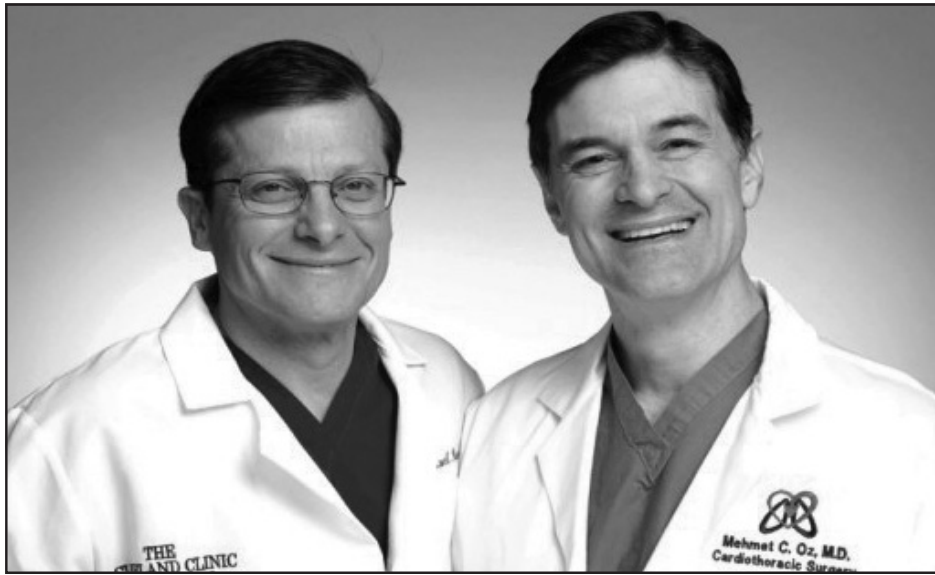
It all starts with the Food and Drug Administration. No vaccine can be administered unless it's approved by the FDA. That means it goes through extensive and expensive phase I, II and III clinical trials. Next, the Advisory Committee for Immunization Practices, chaired by the director of the CDC, weighs in. The ACIP is an advisory panel made up of 15 voting members (mostly M.D.s), eight ex officio members and 29 liaison organizations.

The ACIP was established in 1964 by the surgeon general to help ensure safety in vaccine manufacturing, not long after Jonas Salk developed the first effective polio vaccine. To become part of the recommended vaccine schedule, the vaccine not only must go through clinical trials, but the developers must subject their vaccine to the lengthy process of data presentation and review. It can take months or years before an ACIP vote is even considered.

To gain a recommendation, the ACIP requires the use of an explicit evidence-based format. All meetings are open to the public.

## Protection from Adverse Reactions

A representative from ACIP also serves as a liaison on the National Vaccine Advisory Committee, which was created in 1987. As a division of the Office of Health and Human Services, the NVAC is the federal advisory committee that is responsible, not only for recommending



ways to achieve optimal prevention of human infectious diseases through vaccine development, but also for providing direction to prevent adverse reactions to vaccines.

The NVAC is made up of 11 members with various degrees, from M.D.s (six) to M.B.A.s and Ph.D.s. Their recommendations go to the National Vaccine Program Office. The NVPO is responsible for coordinating and ensuring collaboration among the many federal agencies involved in vaccine and immunization activities to make sure the goal of the National

Vaccine Plan (the prevention of infectious diseases through immunizations) is met. The National Vaccine Plan was created in 2010.

Other federal agencies that are involved in making sure your vaccinations meet the highest standards include: the Agency for Healthcare Research and Quality, the Health Resources and Services Administration; the Department of Defense, the U.S. Agency for International Development; the Veterans Health Administration and the Department of Veterans Affairs. There are many state and local agencies involved too.

Since the ACIP was established, the number of vaccines included in the recommended child/adolescent immunization schedule (for birth through 18 years) has increased from six to 16. Only one vaccine was removed from the schedule, and that was in 1972, when smallpox was declared eradicated.

If you still have doubts about the safety of vaccines, we hope this will put them to rest: We (Drs. Roizen and Oz) spent a month reviewing every study on vaccine safety and interviewing 150 experts on all sides of the issue. Our conclusions: Vaccines aren't perfectly safe, but the chance that the childhood vaccines will effectively and safely prevent disease is more than 40,000 times greater than the chance that they will cause any serious side effects. So getting your childhood vaccines is like winning the lottery!

## Retirees Need A “Longevity Strategy”

The late, great Yogi Berra supposedly said, “The future ain’t what it used to be.” The same could be said of retirement. Due to several

factors, such as advances in health care, today’s retirees are living longer and more active lives than their predecessors. In fact, you could spend two, or even three decades in retirement. This means you need a “longevity strategy.”

Such a strategy needs to be part of your overall retirement income strategy. Here are five key areas you’ll need to address:

**\*Lifestyle** – What do you plan to do during your retirement years? Travel the world? Stay close to home and pursue your hobbies? Volunteer? Open a small business or do some consulting? Your choice of lifestyle will probably affect every aspect of your longevity strategy.

**\*Income** – Your biggest threat to an enjoyable retirement is the possibility of running out of money. This fear is apparently widespread. In a survey commissioned by Allianz, a life insurance company, more than 60% of respondents said they were more scared of outliving their assets than they were of dying. This last item is especially important, because the annual average cost for a private room in a nursing home is more than \$90,000, according to the “2015 Cost of Care Survey,” produced by Genworth, a financial services company. A financial professional can suggest ways of meeting these long-term care costs.

**\*Caregiving** – It’s possible, at least early in your retirement years, that you could still be a caregiver to aging parents. If so, you might need to factor in these costs to your financial strategy. Later, you may need some caregiving yourself, such as that provided by a home health aide. So, you’ll need to consider these potential expenses.

## Roasted Potatoes, Carrots, Parsnips and Brussels Sprouts

Recipe courtesy of Giada De Laurentiis

**Ingredients**

- 1/3 cup extra-virgin olive oil
- 3 medium carrots (about 3/4 pound), cut into 1-1/2-inch thick circles
- 1-1/2 cups Brussels sprouts (about 1/2 pound), halved
- 4 cups red bliss potatoes (about 1 pound), cut into 1-1/2-inch thick slices
- 3 medium parsnips (about 1 pound), cut into 1-1/2-inch thick slices
- 1 cup sweet potatoes (about 1 pound), cut into 1-1/2-inch thick slices
- 1 tablespoon dried oregano
- 1 tablespoon dried rosemary
- 1 teaspoon dried thyme
- 1 teaspoon dried basil
- 1/4 teaspoon sea salt
- 1 teaspoon freshly ground black pepper



**Directions**

Preheat oven to 400 degrees F.  
 Grease an 11 by 17-inch baking sheet pan with extra-virgin olive oil. Place vegetables in baking sheet and add the dried herbs, salt and pepper. Toss well, evenly coating all the vegetables with the seasonings and oil. Add more oil if the vegetables seem dry.  
 Spread the vegetables evenly on a large baking sheet. Place on middle rack in oven and bake for 35 to 40 minutes.

## Apple Crisp

Recipe courtesy of The Neelys

**Ingredients**

- Filling:**
- 5 Granny Smith apples, peeled, cored, chopped small
  - 1/4 cup finely chopped pecans
  - 3 tablespoons all-purpose flour
  - 1/2 cup brown sugar
  - 2 tablespoons maple syrup
  - 1 tablespoon lemon juice
- Topping:**
- 3/4 cup all-purpose flour
  - 1/3 cup brown sugar
  - 1/4 teaspoon ground cinnamon
  - 1/4 teaspoon salt
  - 6 tablespoons chilled butter, cut into pieces
  - 1/4 cup coarsely chopped pecans



**Directions**

**For the Filling:**  
 Mix all the ingredients together. Place into 7 to 8-ounce ramekins.  
**Topping:**  
 Preheat oven to 350 degrees F.  
 Mix the flour, brown sugar, cinnamon and salt in large bowl. Blend the butter into the mixture until it forms pea size lumps. Stir in pecans and sprinkle over filling.  
 Bake crisps for 35 to 40 minutes. Cool 10 minutes before serving.

## World's Simplest Thanksgiving Turkey

Recipe courtesy of Food Network Kitchen

**Directions**

Preheat the oven to 325 degrees F. Pull the neck and giblets out of the cavity; ditch the liver and save the rest of the giblets for gravy. Dry the turkey with paper towels, then season inside and out with salt and pepper. Fill the turkey with aromatics like chopped onions, carrots, apples and herbs, then place breast-side up in a roasting pan and brush with melted butter. Tent with foil and roast for 2 hours (for a 10- to 12-pound turkey; add an extra 15 minutes per pound for larger birds). Remove the foil, baste with more melted butter and crank the oven to 425 degrees F. Roast for another hour or until the meat at the thigh registers 165 degrees F. Let rest while you make the gravy.

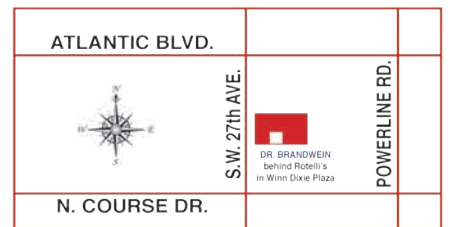

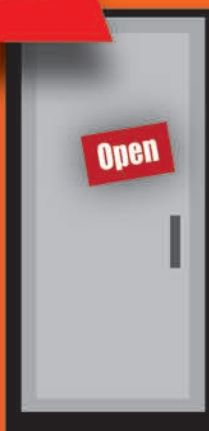

## Three Reasons Not To File A Claim For That Fender Bender

(NAPS)—Although you'll almost

certainly want to have your insurance company cover the cost of a car accident involving multiple cars and serious damage, with plenty of other crashes, you may want to simply cover the cost yourself. Here are some conditions and situations when that option can make sense. The more of these that apply, the more you should consider simply paying the damage yourself.

### The Damage Cost Is Close To Your Deductible

Any damage you do to another vehicle is covered under the liability component of your policy, while damage you inflict on your own car will be handled through your collision or comprehensive insurance, assuming you have such coverage (some people drop it for older vehicles).

If you estimate the damage inflicted to your car to be below your deductible, or even slightly above it, you should just handle the repairs out of pocket. If the damages are \$300 but the deductible is \$200, you would save just \$100 by filing a claim and your premiums could easily rise by more than that in the long run.

### You Alone Are Involved

In an accident with no more than two drivers, where neither is injured and the damage appears to be minimal, you can both agree to not call the insurance company. There are, however, several reasons to be cautious about doing that.

The first is that the other driver can at any time renege on the agreement to not involve the insurance companies. A second is that even seemingly minor fender benders involving two cars can be far pricier to fix than most drivers would expect—in the thousands of dollars, for even a slow-speed (say, 10 mph) collision.

The upshot here? Not involving the insurance company is best reserved for mishaps that involved your vehicle alone, or one in which you know, or have other reason to trust, the other driver.

### You've Filed For Other Accidents

Going it alone on a minor solo crash can spare you long-term pain. That's because filing too many claims through your insurer can cause your rates to soar, possibly costing you hundreds if not thousands over the years following the claim.

The effect of making a claim varies by the state, the insurer and how long it is since you submitted a claim, if at all. But the hikes can be hefty—20 percent or more, according to research by the finance experts at ValuePenguin.

## Woodshop Club

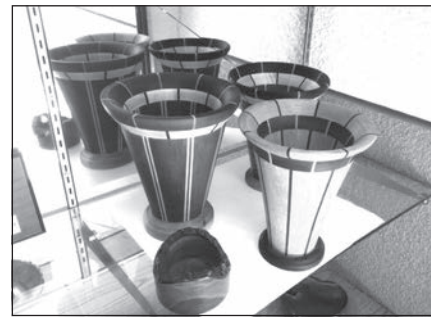

The Woodshop fared well in the face of the hurricane last month. All the woodcrafts in the display windows were removed prior to the storm and the shop doors were shuttered for three days.

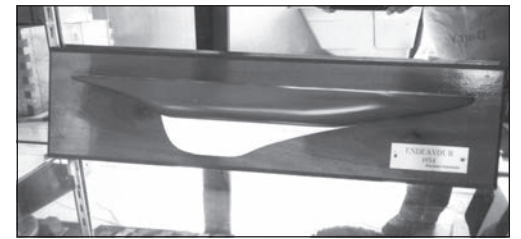
The woodshop hours are 8:00 AM-8:00 PM. A reminder that all members must sign in and out, have a shop badge and return the key.

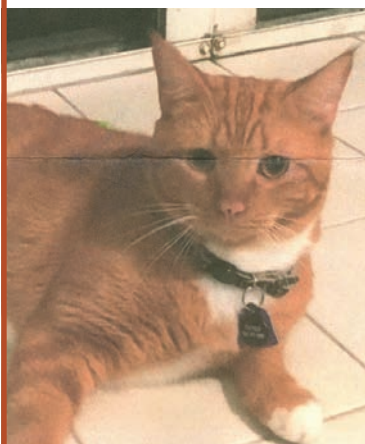

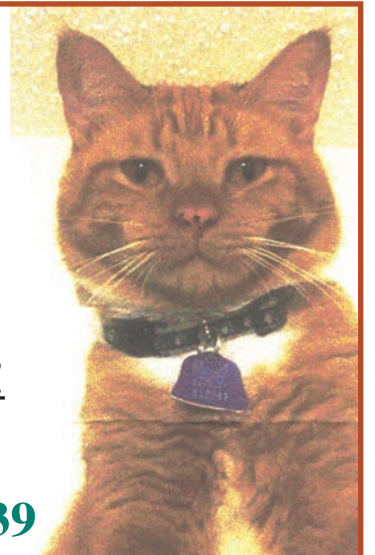

# Out of State Legal Documents: Are They Valid in Florida?

As many of our snowbirds come back to Florida, a common question is: do my legal papers from another state work in Florida? With some exceptions, the answer is no. There are three main documents that protect you in Florida if you become incapacitated: Designation of Health Care Surrogate, Written Declaration, also known as Living Will and the Durable Power of Attorney. Other states may have different names for these documents, but their substance is similar. You are designating one or more persons to take care of making medical decisions for you if you are unable to communicate, as well as take care of your legal and financial affairs if you become incapacitated. Every state is like a different country.



Each state has its own laws and regulations regarding these three documents. The law in Florida is very clear regarding language, required references to specific Florida Statutes, HIPAA compliant language for the Health Care Surrogate and requirements for initialing specific powers for which the Durable Power of Attorney will apply. It is unlikely that you can find online, the appropriate language that is necessary to create documents that will be effective in Florida. Our current Durable Power of Attorney document is 26 pages to be sure that it conforms to the new Florida law. If you have similar documents from another State, it is likely that they will not be valid in Florida.

Therefore, for my snowbird clients who divide their time primarily between two states, I recommend a set of documents for Florida and another set for the other state. This will provide protection for you, should you become incapacitated in either state. You will not have to worry if your out-of-state documents will be honored.

If you have a Last Will and Testament that has been properly executed in another state and you die in Florida, that Will is valid and can be filed in

the Florida Probate Courts. However, it becomes much more time consuming, costly and difficult to probate an out of state Will in Florida. A Commissioner in the other state needs to be appointed by the Florida Judge. The Commissioner must take the sworn testimony of one of the witnesses to the Will before it can be admitted to the Florida Probate Court. Sometimes, particularly, if the Will was done a while ago, the witnesses cannot be located. If you have a Florida Will and it is properly executed and notarized, these extra requirements and court orders will not be necessary. Therefore, to make it easier, faster and less expensive to probate, you should consider making a new Florida Will, particularly if you are now a Florida resident.

If you wish to avoid probate on real estate that you own in Florida and in another state, it is a good idea to consider a Florida Revocable Living Trust and a Deed to transfer your Florida property into the Trust. When you return to the other state, have a lawyer do a Deed transferring that property to the Florida Trust. This will avoid two separate probates in two states upon your death.

This is just a summary of the law and why it is advisable to have Florida documents. I always offer a free consultation to review your current documents, whether from Florida or another state, and give specific advice regarding your circumstances.
