SPOTLIGHT ON JACK KUBASEK

This month's "Spotlight" honors Jack Kubasek, a 27-year employee of Wynmoor.

Jack grew up in White Plains, New York, and after high school, joined the Army. During his four-year military service, Jack was stationed in both Vietnam and South Korea. After returning home, Jack attended Mercy College in New York.

Following his education, Jack worked in New York in the transportation industry until 1991.

Shortly after moving to Florida in 1991, Jack was hired to work at Wynmoor. His first position involved running and operating the transportation department as well as oversee the construction of the new Clubhouse.

After a period of time, Jack became responsible for overseeing the maintenance of the council buildings. After Bruce Bandler was appointed Administrator of Wynmoor, Bandler appointed Kubasek as the Assistant Administrator.

During his 27-year career at Wynmoor, we asked Jack what sticks out the most in his mind. "It took over one year to re-build from that hurricane" claimed Kubasek.

In looking back, Jack was proud to be involved in helping Wynmoor to upgrade to modern systems such as its electronic lighting and computer operated air conditioning.

During the past 27 years, Jack Kubasek has worked for two Administrators, Pat Revo and Bruce Bandler. He has also worked for five Council Presidents: Jay Maisel, Al Hiller, Jerry Rockman, Sam Panetz, Harold Goldberg and our current President Jackie Railey.

Kubasek claims that the secret of Wynmoor of being such a great community is its great residents and in-house staff.

Outside of work, Jack has been very involved with the Moose Lodge, his church and with Veterans. All of his time with these organizations are aimed at raising money for charity or helping those in need.

Jack has been married for 49 years and has five children and eight grandchildren.

UPDATE ON THE TURNPIKE

As many of you know, the State of Florida Turnpike Authority wanted to expand its lanes directly outside the Wynmoor property line. Since that time, I introduced a motion to my fellow Broward County Commissioners to oppose such expansion. At the same time, the City of Coconut Creek Commissioners voted to oppose the expansion. Lastly, the Metropolitan Planning Organization of Broward County, agreed to take this project off of its immediate needs list. In conclusion, the Turnpike Authority has agreed to put this project on the "back burner" for at least five years where they will perform a study to determine whether such expansion is necessary. As your Broward County Commissioner, I will oppose any expansion of the turnpike!!

TEXTING WHILE DRIVING

Texting while operating a motor vehicle has caused thousands of accidents on our roadways. Recently, the Broward County Commission supported a resolution to

It was Christmas time and I was spending this festive holiday with my daughter on her horse ranch in Lakeland, Florida. They were made on Styrofoam balls, deco-rated with an average of 70-100 pearls, sequins and ribbons, all secured with straight pins!

My daughter had a six-year-old adorable member of our family called Tish, a Dalmatian. This dog was always hopping in the car whenever we wanted to leave or racing with the horses in the corral or stealing fresh baked cookies from the table as they were cooling!

One night my daughter and I, in holiday attire, went to Tampa to see the original cast of "Fiddler on the Roof"- telling Tish, with her soulful eyes, to take good care of the tree while we were gone, that we would be back soon, never dreaming of the amazing stunt she would pull. When we got home from that wonderful play, we walked into a sight that was most unbelievable to explain. Here was Tish, with her black and white face, looking up at us and her paws outstretched to display what was between them. There was one of our most decorated and elaborate balls, all naked, with straight pins in one pile and the pearls, ribbons and sequins in another pile! We took her to the vet to be sure that she had not swallowed anything. Nope, said the vet, she did a spanking clean job!

The look on Tish's face when we came through the door was priceless! It was as if to say to us: "You left me home; see what I can do? I'm talented also."

Today, the song "Fiddler on the Roof" has such a special meaning and an amazing beauty all of its own.

The following year Tish was hit by a car and had to be put to sleep, a heart break we still carry to this day. A Dalmatian so smart and loving, speaking the language of the heart to us as we came in. Pets are so special. They make more sense than most people sometimes and don't have to speak to show it!

Stories from Baghdad

The Iraqi Jews had a very hard life after the creation of the State of Israel in 1948.

No passports were issued, people were laid off their jobs; arrests and torture of innocent Jews was the norm.

Finally, in 1950 a law was enacted called the Tasqit. Basically, Tasqit means denationalization. Any Jewish person who wished to emigrate to Israel could

sign up to lose his Iraqi nationality and be permitted to leave the country and go to Israel. More than a hundred and twenty thousand signed up and were deported.

First laws were enacted right after the closing date of the Tasqit to freeze all assets in the banks of all the persons who signed plus all stocks and bonds. All homes and any real estate were confiscated by the government. Only \$150 was allowed per person and one suitcase.

One flight was caught in mid-air by a sandstorm and the pilot had to turn around and land back at the Baghdad airport. One woman rushed off the plane and went down on her hands and knees to the ground and kissed it repeatedly. She thought she reached the Promised Land. "Thank God I have reached this land, I will happily die for it!" An Iraqi guard was watching and he told her: "If you love the land so much why have you denationalized yourself?"

"Oh my God!" she exclaimed, "It's you again!?"

As for my family, my father and his brother and partner were tied up in real estate and business properties and did not have any money abroad. They decided to stay behind in the country they were born in for many generations and resisted the current.

Through the years, we had Jewish help in the house mostly Kurds from the North. After the Tasqit no more Jews were left and we had to hire Pakistani Moslems who came illegally to Iraq for the jobs. They lived and worked in the houses that employed them. Our old housekeeper Massouda was living in our homes forever since my father was a young boy. She was a great cook and had more authority in the house than our mother. She went and signed to denationalize herself like everybody else. As people left for Israel, they found living there at that time was terrible. There was no food, no housing no jobs and they were crowded into tents in terrible conditions. So she decided not to go and just stayed undetected behind.

One day Massouda and Mahmoud, the Pakistani help, had a huge fight. So Mahmoud went to the police and reported her as a denationalized Jew and hiding in the house without being deported to Israel. Immediately she was notified that she had to leave. As the flights to Israel were long terminated they had to arrange a special delivery to send her to Cypres at her own expense and then to Israel. The Arab countries had not recognized Israel and there was no direct connection. As for Mahmoud, she had also gone to the police and reported his illegal status. Two policemen accompanied him on the train to Basra, Iraq's only port which had borders with Iran and physically expelled him across the borders. A couple of weeks later a policeman rang the bell at our house in order to report to his superiors the facts of the deportation of the Pakistani illegal emigrant, as they spent a lot of money to transport three people on the train and send the guy across the border where he came from. Mahmoud opened the door!!

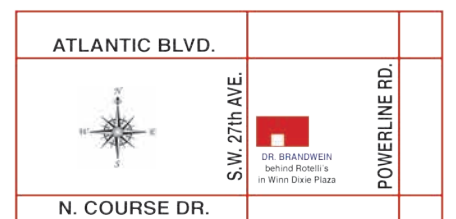

I also stated, "If Michael were my own son, I would make him repeat the 6th grade and when possible the same teachers, with the warning that if you want to get into the 7th grade, you have to earn it. I know this is a hard lesson but I believe that he will understand that if he is to succeed in this life you must earn it."

"Yes, he will lose a year but I believe he will learn a valuable lesson of life."

I also asked Mrs. Shows not to repeat what I said because I could get in trouble. She listened intently, thought about what I had said and left. Approximately 15 minutes later I heard on the school intercom, "Mr. Correia please report to the principal's office." I said to myself, "Oh my God what have I done wrong now."

As I entered the principal's office, there was Principal Frank Thompson, the school's student counselor, and the other five teachers of Michael Shows. It was at that moment I thought I was about to be fed to the lions. Principal Thompson said, "What in the name of heaven did you say to Mrs. Shows that made her drop Michael's name from the summer school list."

I replied, "Mr. Thompson you can ask anyone here who knows Michael that he is a bright young man but getting bad advice from his peers." I also said, "Yes he would lose a year but in return he would gain a lesson that to succeed in this world you have to earn it, life won't hand it to you on a silver platter."

Mr. Thompson excused me from the office and no one uttered a single word after I spoke. I never heard anything about my comments.

In August 1976, classes began as usual, my 3rd period class entered and there was Michael seated in the same desk he had the year before. I began the class with the same opening speech I gave all my classes that if they don't listen and work hard they will see me again next year. I no sooner finished when I could hear student's in the back of the class stating that their parents would let them take summer school and then would be placed in the 7th grade.

Then without prior warning Michael stood up and said, "You idiots are full of shit, I am sorry Mr. Correia for my language but they are nuts. Do you see where I am sitting this is the same desk I had last year, I listened to idiots like you. My mother, the principal, and the student counselor were all set for me to take summer school until they spoke to Mr. Correia and here I am. So, go ahead and play your silly games but you will be here next year"

After his short speech, you could hear a pin drop in that class. I then took roll call and continued with my lesson. Needless to say, Michael passed all his classes with flying colors. In the following May, Mr. Thompson asked me what kind of Voodoo magic did I employ because the number of students who needed summer school was 10% of what it was the previous year.

In 1993, I went to Humana Women and Children's Hospital pick up my wife who was a nurse. As I was about to enter I heard someone call my name, and to my surprise it was Michael Shows. I asked him what he was doing at

the hospital, he said he owned a small construction company and checking the work his men were doing. I congratulated him on his success but he said it is I who should thank you for teaching me how to succeed. We talked a little more and then went on our way.

You know it is not often that we teachers are appreciated but it does fill my heart with a great deal of satisfaction, to know that I was able in some small way to make a contribution in someone's life.

How Ma Bell Changed My Life

I owe the greatest happiness in my life to the Wisconsin Telephone Company. It happened when I was 14 years old, and it was the answer to a prayer. At that time, my parents and I lived in the small town of South Milwaukee (population 12,000 and about 20 miles from the much bigger city to the North). I was overwhelmingly unhappy.

I was one of only three Jewish children in the public-school system, and the only one in my grade. At that time, South Milwaukee allowed African Americans (called Negroes then) to enter the town to work at our largest industry - the Bucyrus Erie Steam Shovel Plant. However, they were not permitted to stay overnight. Things were a bit better for the five or six Jewish families. We could live in South Milwaukee, but we were certainly not welcome.

One of my most bitter memories was of a 5th grade class, where the teacher talked about celebrated African Americans, such as George Washington Carver. She certainly shifted gear when it came to Jews. Here, she spoke of the peddlers of Maxwell Street in Chicago, vividly described as sly merchants, Jews with long, filthy, flea-ridden beards. I recall that when class ended, one little boy, whose name I have never forgotten - Harlow Sinclair - told me that he knew that all Jews were not bearded because my physician father was clean shaven. He said these kind words just before he pushed me over another student's stooped back...

When I told all of this to my mother, she was afraid to confront my teacher and did nothing.

Then - MA Bell intervened! She ended the long-distance telephone rate between South Milwaukee and the nearby metropolis of Milwaukee. I don't remember if the cost of calls had been 5 or 10 cents, but with the elimination of any rate, my father was now willing to move. He had feared to do so earlier, lest his patients would stop phoning. Now, with this monetary obstacle removed, we left South Milwaukee - which could equally have been called

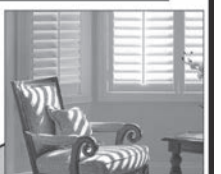

City Sidewalks

At the stroke of 7:00 AM, not a second before nor a second after, a jackhammer started up outside my bedroom window. Pulling the blankets up over my head was futile; no point in staying in bed, my peace was shattered. So, I dressed and went out to inspect the situation.

Mounted on the back of a front-end loader, a powerful hydraulic jackhammer was making short work of breaking up the sidewalk. To operate the beast required just one worker, the driver of the loader.

This brought to mind the days when mainly air driven jackhammers were used to break up sidewalks. Then, a man hung grimly on to the handles of the machine as it bucked up and down like a wild animal. Strong shoulders were needed and perfect aim to avoid a devastating foot injury. The noise and

vibration must have stunned the operator; the effects remaining with him for some time after work. Maybe the effects never left him. Maybe he bobbed up and down all night in bed.

More heavy equipment appeared on my street. Large flatbed trucks delivered the 18-inch shuttering necessary to form new slabs of concrete. Dump trucks arrived with stone aggregate for foundations. There were trucks to carry the smaller machines. We were still in the assembly stage.

There was much noise and movement up and down the street, with machines and trucks in reverse gear beeping continuously. Presumably, these beeps were a warning to the unsuspecting that the driver might be unable to see them. Although I did not make a study of the situation and could be wrong, I was of the opinion that most of the equipment spent most of the time reversing. My street was treated to a symphony of beeps. To lessen the monotony, maybe someone could come up with more melodious reversing sounds. For example: saxophones for dump trucks, clarinets for flatbeds, piccolos for fork lifts, the French horn for cement mixers and definitely the bagpipes for heavy road rollers.

The street became festooned with fluorescent cones denoting traffic lanes and unsafe areas. The cones were quite attractive in so far as traffic cones can be said to be attractive. Each was decorated with five pale green stripes, four orange stripes and five grey ones. All were mounted on a heavy black base. They appeared to be brand new, probably having just arrived in a container from China. Often, much to the confusion of motorists, the cones were moved as the work progressed.

With all the shuttering in place, the cement trucks made short work of pouring the concrete. It was remarkable how few workies were needed to lay the new sidewalks; placing the shuttering to form the concrete slabs required manpower but machines did most of the other work. Workers drove or directed the machines; a few stood around armed with shovels ready to trim the edges. All wore safety vests, but none wore hard hats.

The work is complete, and peace has returned to my neighborhood. About 50% of the sidewalk has been renewed; the remainder still bears the scars of snow removal. Sidewalk renewal has become an Annual ritual; it will happen again next Summer.

The Fall is now with us and Winter is lurking around the corner, waiting to send us clouds of the white stuff. In city garages, patiently awaiting the first snowfall, sits a great variety of snowplows. They come in all sizes. Large ones to bolt to the front of dump trucks, smaller ones for front-end loaders and others for various smaller trucks. One particular machine, which looks like a praying mantis, has a diagonal blade fitted midway between its front and rear wheels. For clearing sidewalks, there is a neat little plow with a blade just wide enough for the job. All are equipped with annoying reverse beepers.

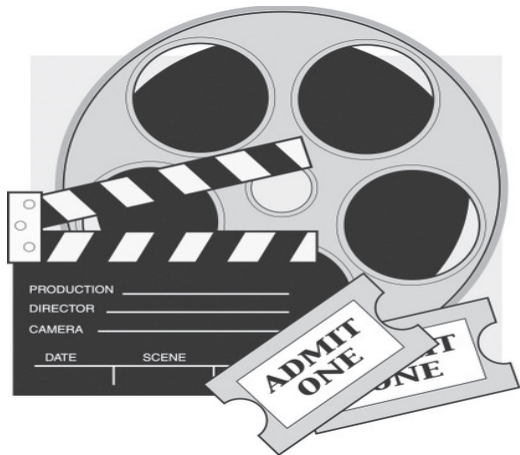

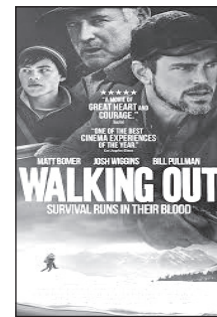

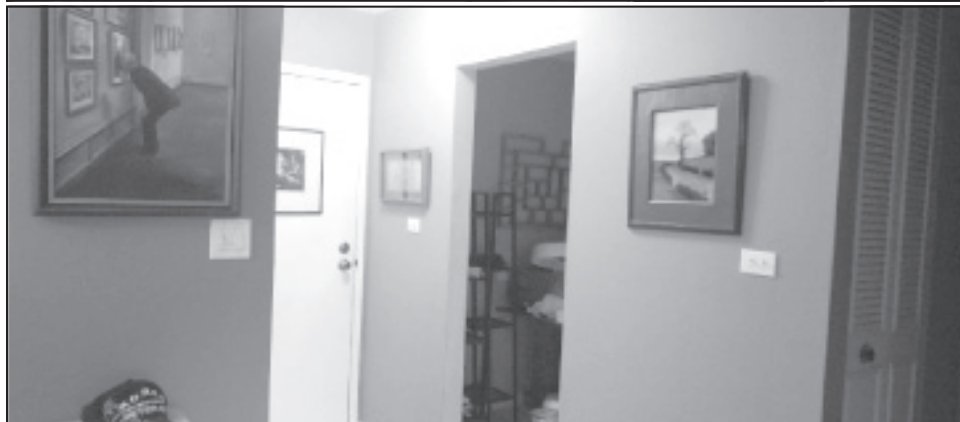

This is an interview with Lotte Lenya, when we both lived in Rockland County, and I was an active member of the Elmwood Playhouse. I thought it would be of interest to my Wynmoor friends and neighbors.

On February 6th, the Elmwood Community Players closed their production of Bertolt Brecht's "The Private Life of the Master Race," after a four week-end run. The play is a documentary-type drama turning back to an important era in history, that of Hitler's rise to power in Germany in the early 1930's and the immediate effect of the Nazi regime on the German people and the Jews.

Lotte Lenya, prominent film, stage and recording artist both in the United States and abroad, was very much a part of this era. She lived in Germany at the time and worked with Brecht and Kurt Weill, her husband for 28 years. A soft-spoken, slightly-built woman with clear, penetrating, yet gentle and sensitive eyes, her personal appearance almost belied the crafty, mysterious woman of the world in "The Roman Spring of Mrs. Stone," the bitter, downtrodden Jenny in "Three Penny Opera," and the independent, practical landlady in "Cabaret." Her home on South Mountain Road in Rockland County is her little niche where she can unwind, relax and slow down the hectic pace typical of a working, involved professional performer. There is an aura of the past which clings to Miss Lenya (now Mrs. Detwiler), and it is warmly and cozily reflected in her home, complete with dog, cats and fireplace. At the same time, one can immediately sense her vibrancy and involvement with the present and the future.

Miss Lenya spoke about her life in the theater in pre-Hitler Germany and her association with Weill and Brecht, who collaborated together on "Three Penny Opera" and "City of Mahagonny." They were at the time involved with a privately-owned repertory theater, now known as the Berlin Ensemble Repertory Theater. As opposed to the "legitimate" traditional Rhinehardt Theater, their theater was considered avantgarde and they were labeled young rebels. When Hitler came into power, they were put on the Black List, along with many other prominent actors. They left Germany secretly overnight in March 1933, in order to avoid arrest. She and Weill went to Paris, Brecht to Austria, Denmark, Russia and then to California; their paths never crossed professionally again. Through the years, Miss Lenya has performed in Brecht's plays and sung the music written by Brecht and Weill, both here and abroad.

The epic theater of Brecht and his theory of alienation have been widely discussed and written about. In traditional theater, or the Aristotelean concept of theater, the spectator is involved in a chain of emotional responses. Every scene preconditions the next in the organic development of the play and there is interest in the outcome of the action. Some experts state that according to Brecht, the play should act upon the spectator's intellect, making him an observer rather than a participant. The spectator is taught to think through conscious discovery of what is false and stupid in the world, and his will is aroused to action rather than emotional catharsis. Each scene is independent rather than having continuous flow and sequence, and the technique is often montage. Miss Lenya tried to clarify a few misconceptions. She feels that Brecht can be done successfully in this country and is enthusiastic about the talent of American actors, if not with directors. "Directors in this county misinterpret his alienation theory. No matter how you try to alienate yourself from the part of the audience from feeling, you can't stop tears, because of the situation itself. It has to be played as written. There is a danger of being too flat in trying to achieve alienation. In the Berlin Ensemble when Brecht is done, the audience cries; there is just as much emotion as in any other theater. When Americans approach a part, there is too much analyzing; it is all too cerebral. They pick it apart instead of just diving in. They shouldn't think so much of alienation or style, but absorb it, play it. American actors ooze talent, but there is a lack of good directors. For the sake of novelty, directors destroy theater. A prime example was last year's disastrous New York Production City of Mahagonny. There is no director of Brecht's caliber at this time... perhaps Jose Quintero, who has both sensitivity and violence as a director, and in a different field, Hal Prince. The genius of Brecht as a director was that he could make a horse act, rather than cast someone who just 'looked' the part. In this country directors type-cast. In Berlin, many actresses of different types played 'Mother Courage.' Weigel, Brecht's wife was of small build and frame. Therese Geis, who had the large build of Sophie

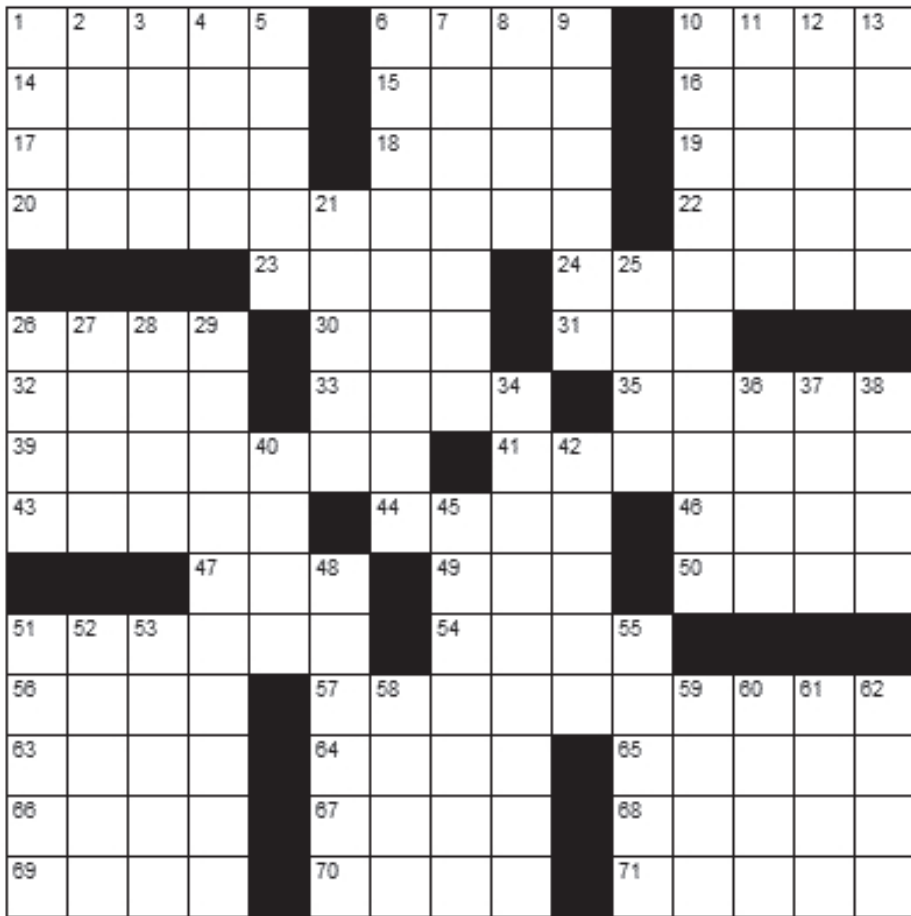

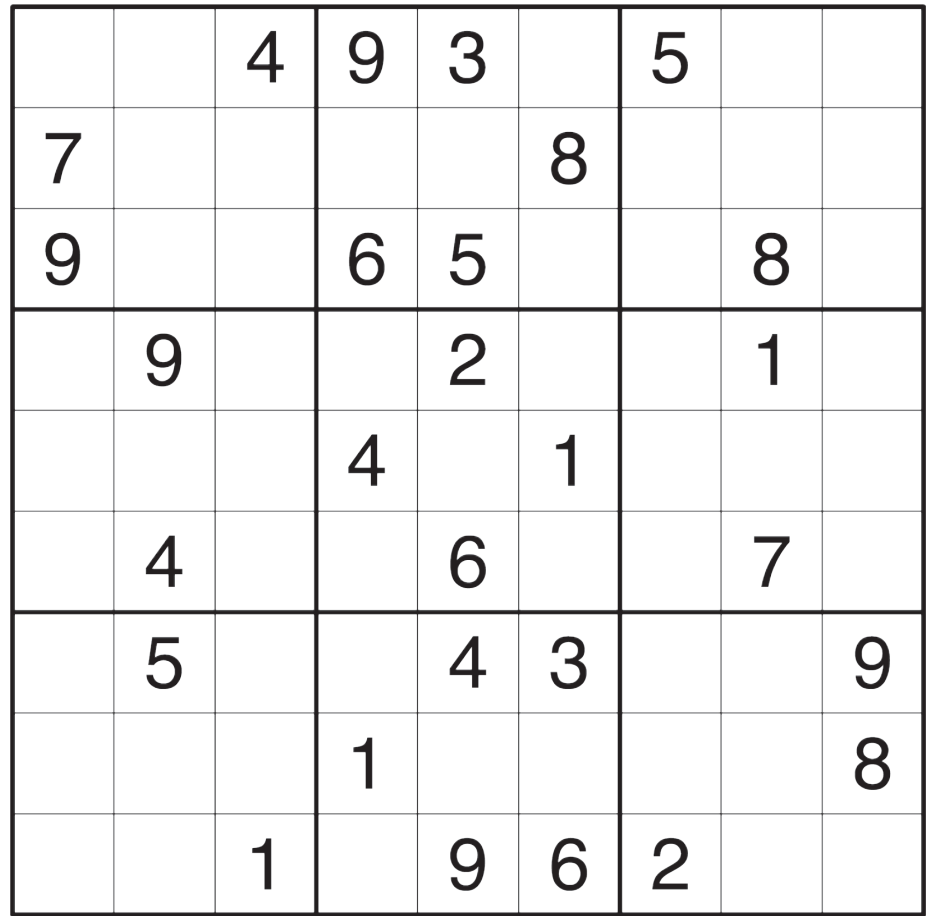

tucker, also played the part and did as well.”

Miss Lenya has great hope for the state of theater today, and finds the times exciting, as opposed to gloomy views of many others who reiterate that theater is dying. She mentioned the fantastic work of some of the experimental off-Broadway theater, such as The Living Theater, “The Connection,” “Jacques Brel Is Alive and Well and Living in Paris,” and “The Me Nobody Knows.” She believes we are undergoing a complete transition and slowly we will again wear clothes on stage and merge the new with the old tradition, enabling a different style of theater to emerge. “What is also exciting,” said Miss Lenya, “is that Broadway is no longer the center of theater. People can have good theater available to them in Community Theater, in colleges, in touring companies. It is difficult for actors to succeed here. Though I disapprove of much of the Actor’s Studio “Method”, it is needed here. Actors can grow and experiment. In Europe, we have Repertory Theater and actors can work continuously, playing many different roles in a short time. If we could develop Repertory Theater here, it would be marvelous. First, we must educate the audience. New York is geared to the “star system.” The Vivian Beaumont

Theater is the beginning of repertory theater, and it is important that we let it survive.”

Miss Lenya was delighted that Brecht was again being performed in Rockland County by the Elmwood Players, recalling how she enjoyed “Three Penny Opera,” another Brechtian endeavor a few seasons ago.

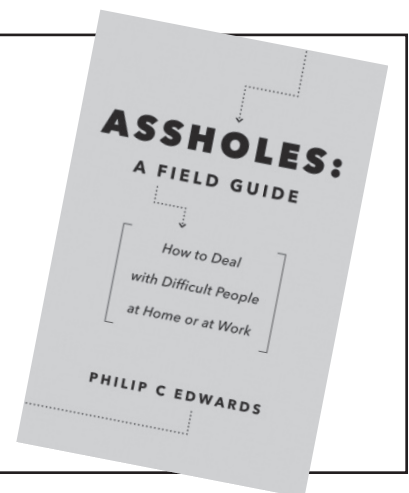

Same Sex Marriage Versus “Significant Other” Legal Issues In Florida

Same sex marriage is now legal in all states since June 26, 2015, when the U.S. Supreme Court ruled in Obergefell v. Hodges that state bans on same sex marriage are unconstitutional. This means that, if you are a same sex couple that has been legally married in any state, you are entitled to the same legal rights and benefits as heterosexual couples, both in Florida and in the United States. This covers everything from taxes to health insurance, life insurance and pension benefits, as well as property tax exemptions for widows or widowers and any other state or federal law that previously applied to traditional marriages. It also means that, in the event of a divorce, the same rules apply.

However, if you are not married but are living together as domestic partners or significant others, regardless of your sexual orientation, none of the laws for marriage apply. There is no “common law marriage” in Florida. Basically, you are each treated as a single person for all state and federal laws and tax purposes.

If you are living together but not married, it is particularly important that you have the basic legal documents in Florida to protect you, if either or both of you become incapacitated. This includes the Designation of Health Care Surrogate for making medical decisions, a Living Will or pulling the



plug document and the Durable Power of Attorney for legal and financial matters.

If you jointly own your home and/or other real estate, it is important to look at the benefits of a Revocable Living Trust or a Life Estate Deed to avoid probate when you both die.

Even if you are married, it is important to have these legal documents. If you were living together and got married after doing those documents, it is important to review them now for any changes, due to your new legal status.

If you are considering getting married, regardless of sexual orientation, you should review with an attorney the legal benefits and disadvantages of doing so.

Ultimately, a decision to marry should be based on love and compatibility; however, it is certainly important to also be aware of the legal and financial issues.

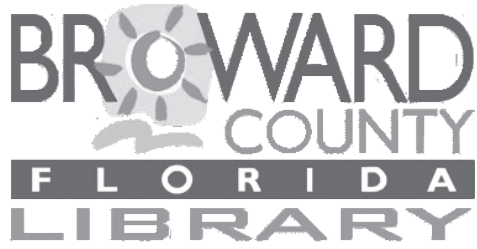

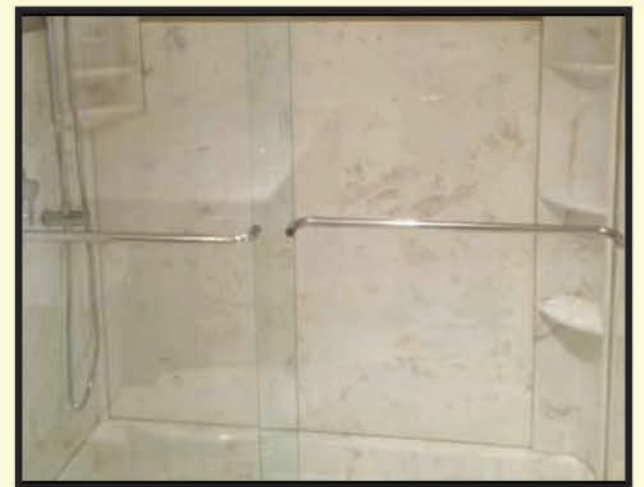

Dear Dr. Joy...

I won't be answering a single question this month, but rather a group of them, having to do with the same subject. For whatever reason, that I can only guess at, various people of different ages and situations have been asking about narcissism.

About seven years ago, while I was still living in New Jersey, I had been asked to address a group about my book, "Triumph Over Tragedy/Could the Person You Love Be a Narcissist?" I thought that not too many people would be interested in that particular subject, but agreed to do the presentation.

After my opening statements, which included a rather brief description of what Narcissism and Narcissistic Personality Disorder were, I asked the audience of about 200 people to raise their hands if they believed they had one of these people in their lives. To my amazement, about 150 hands went up. Some, as it turned out, were in the narcissist category, which is bad enough, but a great many fell into the category of NPD or Narcissistic Personality Disorder. NPD is much more serious and has its own set of characteristics. This is the category I'll write about here. All of this is covered in my book, so this will be a short, overview article.

To begin, there are two types of NPD and they can overlap. The first is the intellectual or cerebral type, which is characterized by a "know everything" attitude. This person knows it all or at least would like you to think so. There is a demeaning attitude towards the knowledge or ability of anyone else. They don't want to hear what you know or what you think. As long as you regard them as the ultimate teacher and authority, they are happy and treat you as a pet. If you have your own ideas and continue to voice them, you will be history. You must not disagree with them, confront them or intellectually antagonize them. In short, that's really all it's about for them. I go in too much more detail and examples in my book.

The other type is called the Somatic Narcissist. There are many more characteristics involved in this type. The main and overwhelmingly, the most malignant of these, is the fact that they are the only person in the universe who is "real." You, as a separate person with feelings, thoughts, perspectives, needs, etc. do not exist. They have no ability to see you as separate, but equal. You are merely a tool with which they get their needs met. These are known

as their narcissistic supply and it is your job to take care of them. Remember there is no "you" at all.

So, how do they go about getting these needs of theirs met? Any way they can is the short answer. In the beginning, they are most charming, will flatter and cajole you until you are so smitten, you will do whatever you need to in order to keep them with you. As long as you keep the supply coming, they will stick around until they get bored or tired of you or it's when you insist on getting your own needs met. Then they are gone, looking for a new supply. If you have any experience at all with one, all of this will ring true and sound very familiar.

Another characteristic is that they lie, about everything and anything. It doesn't matter as long as it keeps you off balance. Also, they are not at all forthcoming and open about themselves and when they do tell you something personal, it is just to manipulate you and is usually not true. They also have no compassion. You can be writhing on the floor in emotional pain and unless it suits their needs, they will pay you no mind.

This is the short version of a very big issue that a lot of people are unfortunately dealing with.

A woman I recently met said she was attracted to Narcissists. It is no wonder. They are extremely attractive. The great majority are about 75% of men. There are very few women who don't spend a great deal of time trying to change them. Whether they be their spouses, lovers, children, friends or employers, woman believe they can impact them positively and alter them. It can't happen. If you have one in your life and you enjoy being with them, then understand that they will never change, and you must take them as you find them. They can be a lot of fun, as long as, you realize what they are all about and don't expect anything more or different.

This is a subject I never thought I would write about, speak about or deal with ever again. As I said earlier, it has reared its head once again and I felt I had to address it another time. Since it's now out there, if you have any specific issue with this topic, please write to me.

And yes, this is a very personal topic for me. After my book came out in 2010, most of my private practice was devoted to those who were involved with this type of person. It was one of the reasons I retired in mid-2012 and moved to Wynmoor.

Use Your Tax Refund Wisely

It's tax time again, which for many Americans means that a tax refund is on its way. If you're going to get a refund this year, how can you use the money to your best advantage?

Of course, it's always tempting to spend the check from Uncle Sam on something fun. But a tax refund could be sizable. The average amount in 2016 was \$2,857, according to the IRS. So, putting this money to work could help boost your progress toward your financial goals.

Here are some possibilities for using your refund:

- *Help fund your IRA:* If you were to receive a tax refund of \$2,857, you'd have slightly more than half of the \$5,500 annual IRA contribution limit for 2017. Although, if you are 50 years or older, you can contribute an extra \$1,000. Consequently, you may find it much easier to fully fund your IRA for the year and you should do exactly that, because an IRA is a great retirement savings vehicle.

If you have a traditional IRA, your contributions may be fully or partially deductible, depending on your income, while your earnings can grow tax deferred. (Taxes are due upon withdrawal, and withdrawals prior to age 59-1/2 may be subject to a 10% IRS penalty.) With a Roth IRA, your contributions are not deductible, but your earnings are distributed tax-free, provided you don't start taking withdrawals until you're 59-1/2 and you've had your account at least five years.

- *Help diversify your portfolio:* If a market downturn hits one asset class, and that's where you keep most of your money, you could take a big hit. Owning an array of investments, such as stocks, bonds, certificates of

deposit, and so on, can help prepare your portfolio to weather the effects of market volatility. By adding new investments, or increasing your holdings of existing investments, you may be able to further diversify your portfolio and you can use your refund for this purpose. (Keep in mind, though, that diversification, by itself, can't guarantee profits or protect against loss.)

- *Contribute to a 529 plan:* If you have children or grandchildren whom you'd like to help send to college, consider using your tax refund to help fund a 529 plan. Your 529 plan contributions may be deductible from your state taxes, and your earnings are distributed tax-free, provided they are used for qualified higher education expenses. (However, withdrawals not used for higher education expenses may be subject to both income tax and a 10% penalty.)

- *Pay off some debts:* You can help improve your financial picture by reducing your debt load. It may make sense to prioritize these debts. For example, rather than make an extra mortgage payment, you might want to first tackle those debts or loans that carry a high interest rate and that don't allow you to deduct interest payments. After all, your monthly mortgage payment will remain the same even if you make an extra payment, but if you can get rid of some smaller debts, you will free up some cash that you could use to invest for your future.

Think carefully about how to use your tax refund. It represents an opportunity that you won't want to waste.

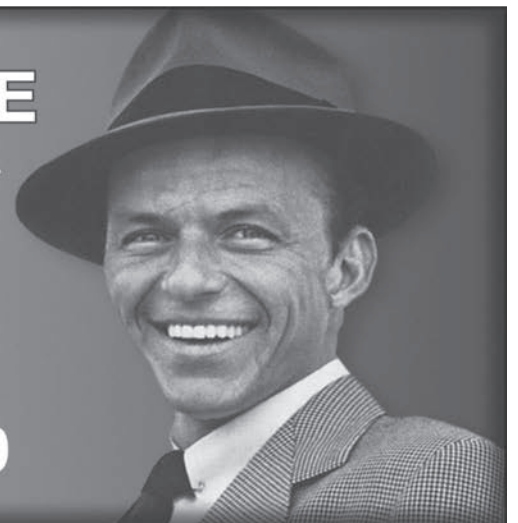

HISTORY CORNER

NAPOLEON: GENIUS and JERK

THE GENIUS: The best compliment one can receive is from one's arch rival. The Duke of Wellington, who defeated Napoleon in Spain and at Waterloo, despised Napoleon, calling him a liar, cheat, and a fraud. However, concerning his military genius, Wellington said, "Boney's not a gentleman; [but] on the field of battle, his hat is worth 50,000 men. I have seen most of the other marshals and I have no doubt that, as a general, Bonaparte was the best of them." Many consider Napoleon one of the greatest military strategists of all time. He gave up strong positions intentionally, only to immediately counterattack when the enemy was out of position and unorganized. Rather than commit his troops to battle, Napoleon had his artillery shell a frozen lake where enemy troops were located, drowning thousands of soldiers. It was said by opposing generals, "Napoleon can feel a battle and he knows the right time to act." His strategies are still studied by militaries around the world.

THE JERK: The French decapitated the King and Queen of France and established a Democracy. That did not work out so well, and Napoleon offered a new structure. He would become Emperor of France. He invited the Pope and other leading church and political leaders to legitimize his coronation. In a prearranged ceremony, the Pope lifted the crown towards Napoleon, and Napoleon placed it on his own head and then crowned his wife's head. This was to demonstrate his break with tradition and show that he was subject to no one, but himself.

During his Egyptian campaign, Napoleon learned of his wife's affair with a young handsome cavalry officer. This began a long list of affairs that Napoleon had with numerous mistresses, some of whom were wives of his officers. Several days before his coronation as Emperor, Josephine caught him in bed with her lady-in-waiting. Napoleon threatened to divorce her if she protested. Later, because she did not provide an heir to the throne, he divorced her for an eighteen-year-old.

Napoleon wanted to punish Russia for trading with England, so he decided

to invade Russia with the largest army ever assembled in Europe. With close to 700,000 men from France, Poland, Germany, Switzerland, Italy, Belgium and other provinces, Napoleon crossed into Russia on June 24, 1812.

His army basically walked across Russia with only two major engagements at Smolensk, on August 16, and the battle of Borodino, on September 7, 1812, which is only 75 miles from Moscow. Seven days later, Napoleon entered Moscow, expecting capitulation by the Tzar and leading generals. No one was there. According to customs of the time, everyone was supposed to surrender when one's capital was lost. They all retreated further into Russia, reinforced the army, consolidated forces, and waited for "Mother Winter."

Shortly after taking Moscow, three-fourths of the city burned to the ground. When the first snowflakes fell a month later in October, Napoleon abandoned Moscow and began his trek back to France. "Mother Winter" set in, with a vengeance of heavy snow and temperatures thirty degrees below zero. Constant attacks, freezing weather, little supplies, a scorched earth policy by the Russians devastated the French army.

Out of the 700,000 men who went into Russia, only about 30,000 crossed back into France. Death, disease, capture, and desertion ravaged the army. What did Napoleon do? At the French border, he left his army and raced to Paris in a carriage. He wanted to be the first, so he could spin and shape public opinion and raise new troops to ward off any rebellion.

Because of his control of the government, the military, the press, the judicial system, and his popularity, Napoleon raised other armies and attempted to regain his hold on Europe at the cost of another 100,000 lives.

Yes, he was a military genius, but he was also a jerk. We do owe him a great deal of gratitude for selling us the land of the Louisiana Purchase in 1802, which became twelve states in the mid-west. He did this to finance his up-and-coming war with England. The only losers were the native-Americans who had lived there for thousands of years.

Low-Income Senior's Additional Homestead Exemption

Many Broward County seniors are eligible to claim an additional \$25,000 tax-saving exemption, which applies only to the county's portion of the property taxes and city taxes for residents of cities who have also adopted the additional exemption. By local option, the county and cities may adopt an ordinance increasing this exemption "up to \$50,000" and/or the Long-term Residency Senior Exemption. To qualify for the Low-Income Senior Exemption for 2018, an applicant must be 65 or older as of January 1, receive Homestead Exemption on the property, AND have a combined household adjusted gross income for 2018 which cannot be exceeding the income limit set by the State of Florida.

The 2017 income limit was \$28,841. This amount is adjusted annually to reflect the percentage change in the average cost-of-living index. Please contact my office at 954-357-6830 for the 2018 income limit for this valuable exemption.

To qualify for the Long-term Residency Senior Exemption, the applicant must have maintained permanent residence on the property for at least 25 years, meet the age and income requirement for the Low-Income Senior Exemption, AND the applicant's property must have a just value less than \$250,000 for the initial year of application. The Long-term Senior Residency

Exemption exempts the ad valorem city taxes for qualified residents of the following cities: Cooper City, Dania Beach, Hallandale Beach, Hollywood, Miramar, Oakland Park, Pembroke Pines, Pompano Beach, Sunrise, and Weston.

You are entitled to a 2018 Homestead Exemption and other tax-saving exemptions if, as of January 1, you have made the property your permanent home or the permanent home of a person who is legally or naturally dependent on you.

MAKING SURE YOUR WATER IS SAFE!

Television's Dr. Oz and Cleveland Clinic's, Dr. Roizen, report on health, wellness and quality of life.

We are a water-crazy country, with more than 195 brands of bottled water. We drink 12.8 billion gallons of it each year, enough for every American to down almost 40 gallons annually. Fortunately, whether filtered from your local water supply or shipped halfway around the world from some South Seas island, bottled water generally is safe, although there are occasional recalls for contamination with bacteria, like E. Coli. Often, it's no cleaner than your local water supply.

Bottled water health issues aren't just about the water. There's the impact of the plastic bottles themselves. At least now the Food and Drug Administration mandates that they be made from a more stable material, PET (polyethylene terephthalate). In the past, plastics for water bottles were permeable, meaning, ink from the label could seep through into the liquid, and so could cause, who-knows-what! But all that PET plastic, floating like some sci-fi monster in our lakes, streams, and oceans, dissolving into micro-bits, ingested by marine life, is a hazard to the whole planet. We don't like anything that's got hormone-disrupting phthalates in it, as PET does.

So, let's look at water you get from the tap at home, either from a community water service or a well.

The water in municipal systems is regulated, but there are ongoing rollbacks to the Clean Water Act (signed into law in 1972) and that comes at a time when our knowledge of contamination problems and our health risks are increasing!

By now, most folks are aware of the lead contamination in the water supply of Flint, Michigan, but that may just be the tip of the iceberg. A National Resources Defense Fund report last year found that 18 million Americans are served by water systems that are in violation of Environmental Protection Agency standards for lead and copper. Serious violations affect more than 1,100 community water systems, serving 3.9 million people. Excess copper can damage the liver and kidneys, and lead (there is no safe level) can cause permanent brain damage in children and nerve and immune system damage in adults.

Enforcement of on-the-books regulations would go a long way to



reducing the risk. Allowing stricter regulation would be even better. Here's why: Columbia University's Mailman School of Public Health has released a study showing that after the EPA instituted a regulation on maximum levels of arsenic in drinking water, urinary arsenic levels declined for 17 percent of folks drinking municipally supplied water. The authors estimated that that can eliminate between 200 and 900 cases of lung and bladder cancer every year.

In private wells, it's another story. There's no regulation of well water. It's up to the 45 million folks in the U.S. who use well water to monitor its safety. If it is contaminated, as it can be from agricultural or industrial runoff, or inherent contaminants in soil and rocks, it can be hard to

figure out how to clean it up.

In homes supplied with municipal water, it's possible that contamination happens when the water reaches the pipes in your house or apartment building. They may leach lead, copper and rust. So, testing your water is smart even if you believe your basic water supply is safe. You can find a reliable lab by calling the Safe Drinking Water Hotline at 800-426-4791 or visiting www.epa.gov/safewater/labs

Well water should be tested at least once a year. To find out what you should test for, go to cdc.gov and search for "well testing." Shallow wells that use surface water should be tested seasonally. Test the water at the source and coming out of your tap.

If you find your water needs purification, install a filter. They're not all created equal. To find out what type of filter eliminates which contaminants, check out the NSF International certification on the filter's label and look up specific products in the NSF database at www.nsf.org. Don't skimp on the cost. A good filter could save your health, your life.

And when someone speaks or writes about the windows of the soul I try to imagine the emotions these people feel for it glistens wetly in their eyes.

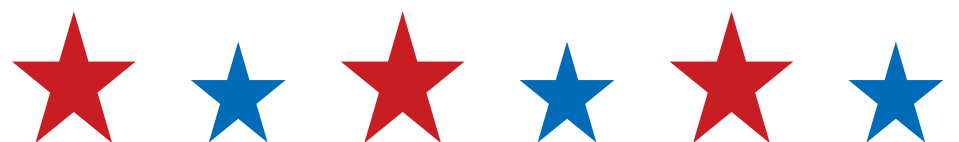

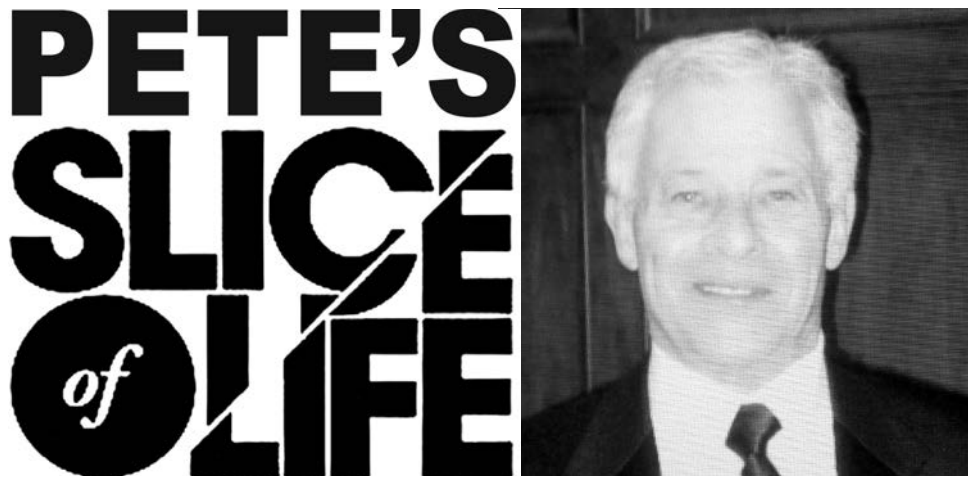

I Should Have Never Gone To My Bar Mitzvah!

PART I: Prelude to Disaster

On the very day I turned 12 my grandmother approached my parents and told them, "I DECIDED THAT PETER HAS TO HAVE A BAR MITZVAH!"

Given that my parents were anything but religious, they had no intention or plan for me to have a bar mitzvah. For me, not having a bar mitzvah was the best bar mitzvah gift my parents could have given me. So when they informed me that they were willing to go along with grandma's crazy idea, I was in shock.

All of this nonsense was going on at the time when my grandmother was living with us. She was a very stubborn, domineering, meddlesome woman who NEVER took "no" for an answer. She certainly made life very unpleasant for all of us. Because of the way she was and the amount of turmoil she was capable of causing, there was only one way for my parents to deal with her; they never disagreed with anything she said or with anything she wanted.

When they came to me to inform me that I was going to have a bar mitzvah, I asked them why they were so willing to agree with her? They explained that it just wasn't worth getting into a big fight with her about. Then I asked them, "what if grandma wanted to have me shot? Would that be something not worth getting into a big fight with her about?" As I recall, their answer was "so far, she hasn't asked us to have you shot. If she does, we will tell you our decision will be before we do it."

As it was, my mother and father gave grandma full permission to take care of all the details in planning my bar mitzvah. They also gave her permission to spend whatever she thought she needed in order to fulfill her dream to see me be miraculously transformed from a boy into a man. Given all this leeway she wasted no time in getting down to the business of employing everything in her power to ruin the entire 12th year of my life. Here are just a few of the things she did:

First, she set her sights on finding the most elegantly appointed synagogue where my bar mitzvah was to take place. By way of extensive research she finally settled on "the very beautiful, the very prestigious, the very orthodox," and to my parent's dismay, "the very expensive" Hebrew Institute and Synagogue, located on University Avenue and 180th street in the Bronx.

Because we weren't members of their congregation, grandma had to enter

into very tough and high-level negotiations with the president of the synagogue in order to secure a bar mitzvah date for me. In the end, they were able to hammer out the following agreements:

1. She would have to pay \$1,600 to cover the cost of the 2 years I DIDN'T attend their hebrew school prior to my bar mitzvah.
2. She would have to pay \$800 for me to attend their hebrew high school after my bar mitzvah. They agreed that I would not be required to attend the H.S., but it had to be paid for anyway.
3. She had to pay \$1,000 for the synagogue's own Cantor Flussberg to prepare me for my reading and singing from the torah on the day of my bar mitzvah.
4. She had to pay \$2,000 to cover the cost of the catered kiddish party, which would be held after services. Our family would be limited to having 60 guests to attend the kiddish, whereas we would be required to invite the entire synagogue's congregation of about 75 people to the kiddish party, in spite of the fact that we didn't know any of them.
5. She also had to agree to make a \$1,000 "contribution" to the synagogue's "Ambulance Fund" for their intended purchase of buying an ambulance for the newly established state of Israel.

As soon as grandma was able to give the president the total amount of \$6,400 to cover all of the expenses she managed to incur, then it was agreed that I would be "booked" into The Hebrew Institute and Synagogue in order for me to perform in front of their very distinguished crowd of orthodox worshippers on Saturday, November 19, 1955 at 9:00 AM. Grandma apparently was so giddy about what she accomplished that she momentarily lost her mind and decided to put \$2,000 of her own money toward this event she created. For her, this was quite a remarkable feat given that no one had any recollection of ever seeing grandma spend even one nickel of her own money on anything.

As soon as everything was in place she contacted Cantor Flussberg telling him to be very strict with me while he was preparing me for my bar mitzvah. She began calling him once a week to check on the progress I was making. In one such call he told her he felt that I was a slow learner and that I should be evaluated. The next thing I knew I was in a child psychiatrist's office taking a battery of psychological tests. For his fee of \$750, Dr. Schwartz rendered his "professional opinion:"

His diagnosis was that he "thought" I suffered from dyslexia, attention deficit disorder and perhaps 3 or 4 other mental disorders. Based on his "expert analysis," my grandmother had me transferred from the 7th grade class I was in, to the "slowest" 7th grade class in the school. This in spite of the fact that my teacher insisted that I was a wonderful student. When I asked my parents why I had to be switched, they told me that it just wasn't worth having a big fight with her about.

So for one entire year leading up to my bar mitzvah you can see how this very narcissistic woman was having the time of her life, while she was destroying mine. All I could think of during that entire year was how I could make my grandmother disappear from the face of the earth. Not a very nice thing to think about, but when you are 12 years old it made perfect sense to me.

At this point you have been brought up to date on all the preparations that were made for my bar mitzvah. Next month, in PART II, you will be invited to come to my bar mitzvah so you can see for yourself exactly why "I Should Never Have Gone To My Bar Mitzvah!"

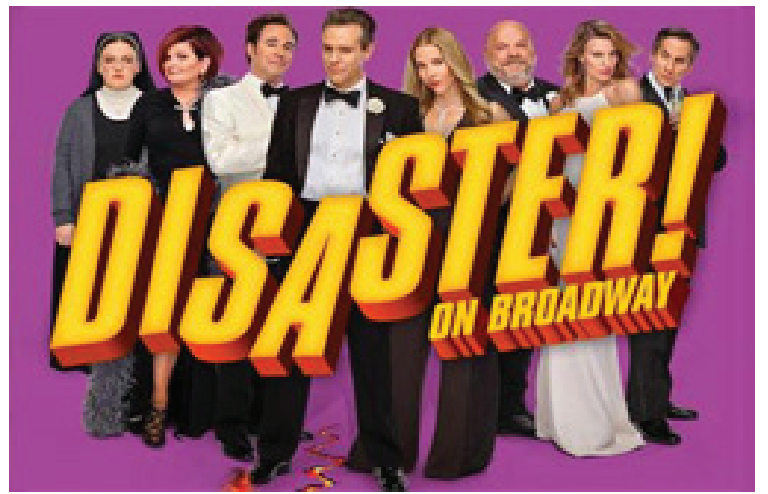

Shortgame Tips: Putting, Chipping, Pitching



When faced with your short shots around the green, first decide whether you need to loft the ball or hit a low-running chip shot.

Chipping is characterized by a shot with a minimum of airtime and a maximum of ground time or roll. Because of the use of your putting swing while chipping, you will not have the ability to loft the shot very high. Covering a long distance on the ground is not a problem.

An old Shortgame adage is "your worst putt is your best chip." Hence,

when it's possible to putt off the fringe of the green, choose your putter.

Club selection: putter, SW, PW, 9i, 8i, 7iron.

Pitching is characterized by a shot that has a maximum of airtime and a minimum of ground time. Allowing for your wrists to hinge will give your shot the height to land softly on the green.

LIVING IN BALANCE

The Power of Stories

Last week, I was listening to a talk by Timber Hawkeye. Timber spoke about the difference between having a feeling and building a story around that feeling. He said that a feeling only lasts about forty-five seconds to a minute and a half, but we can prolong certain feelings for decades if we add fuel to them. His example was that if someone cuts you off in traffic and you get angry, a minute later, you can be singing and happy if one of your favorite songs plays on the radio. Our feelings shift all the time and a new one replaces the previous. However, when we build a story around the feeling and feed it, it can last for ten years. This happens a lot with family members and is why there can be decades where people don't talk, due to grudges and bitter emotions.

I noticed a difference right away when I tried something he suggested. Timber said, "to see the reaction if you thought that the person who cut you off had to do that, due to a medical emergency." Of course, often people are cutting us off due to being in a rush, not noticing their blind spots or out of being distracted. Nonetheless, the simple exercise showed me that the story I have in mind after the feeling, can alter it significantly. The mind is such an important factor in how each situation is interpreted.

We can train our minds to try to catch the stories we repeat to ourselves. Does the story sap your energy? Can we question the stories? Byron Katie said, "I have discovered that in every language and every country I have visited, there are no new stories. They're all recycled. The same stressful thoughts arise in each mind one way or another, sooner or later."

It is an interesting observation, that we share variations of the same stories. Since there are universal themes in literature across the centuries, this isn't surprising. This can also be helpful to remember when we feel trapped in a negative emotion. Byron says that, "we can, through inquiry, unravel out painful stories and find freedom. They are a door that releases us from self-pity, envy or circling in drama."

I read this each morning last week before breakfast and it was a good reminder. Timber said, "Do you wake up each morning and habitually grab your phone to check on other people's lives, or do you wake up and think about everything in your own life to be grateful for? Don't wait until you have a stuffy nose to appreciate the ability to inhale without much effort, for example, or until something else is taken away from you before you appreciate having it in the first place (health, a bed, a roof over your head, etc.). We are creatures of habit, so make sure you're not habitually comparing your life to someone's highlight reel on Facebook or Instagram. Comparison is the thief of joy. Just look within and celebrate the gifts in your own life, the gift of life."

Start your day with something that gets you on a good track, whether it's a quote, meditation, prayer or movie clip.

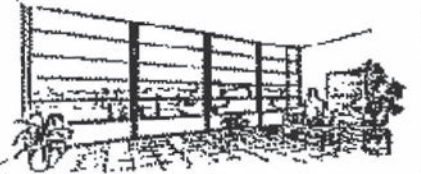

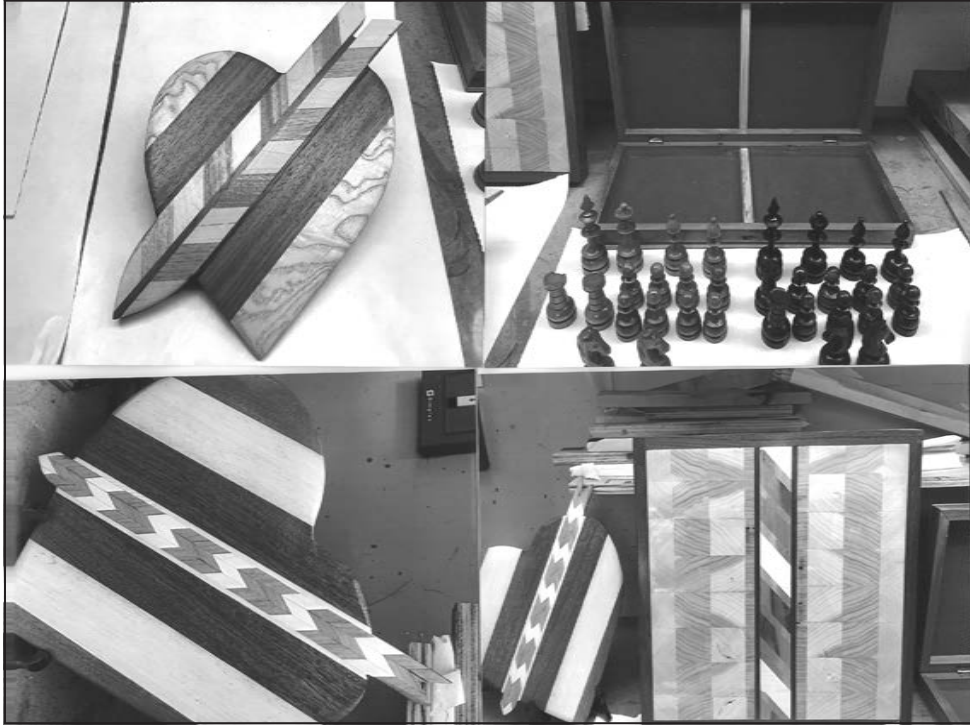

Appreciating Fine Depictions of Icelandic Life In 2 Small Art Museums

In late November, I was in Reykjavik, Iceland, the Capital of a nation known for its natural splendor. It was relatively cold, since I have lived in South Florida a long time. It was also very windy, during my brief visit. Since very few art museums in the United States have works of art produced by Icelandic Painters and Sculptors, this review relates to the fine paintings I enjoyed in the National Gallery of Iceland. Most of the paintings depicted the natural beauty of this country with its history of so much volcanic activity. At this art museum, I saw fine depictions of the beauty of Iceland by; Jan Stefansson. "Summer Night," Emanuel Larsen, "Geysir," Porarrin Porlafsson, "Thingvellir," Jan Engelbert, "Evening in Coastal Village," and the most famous of Icelandic Masters, Johannes Kjarval "Iceland and Melody," among others.

I found Kjarval's style of painting to be extremely inventive.

Later on, after spending three and a half hours in the National Gallery of Art, I walked about a mile and a half through Reykjavik's icy streets to the Kjarval Art Museum which is dedicated to this revered Master of Icelandic Art. My favorite painting at the Kjarval Art Museum was "Mountain Milk." Several paintings at this art museum had Surreal qualities.

Most foreign visitors to Iceland concentrate strictly on Iceland's geysers, hot pools, waterfalls, black sand beaches, and volcanic craters as well as walking the streets of Reykjavik. However, Iceland also has a tradition of having fine painters and sculptors.
