GAS STATIONS:

You need gas and pull into a gas station. What you do not know is that a scammer has secretly rigged the gas pump so when you slide your credit card to pay for the gas, your credit card information is being stolen. The State of Florida inspectors found approximately 1,000 gas pumps have been rigged to steal your credit card information.

Never use a debit card at a gas station. If someone steals your card number and pin, they can empty your account. With a credit card, you can at least dispute the charges. To protect yourself, pay for your gas inside the gas station or pay in cash.

IRS:

You get a phone call from someone claiming to be with the IRS who tells you that you owe money. The person on the phone wants to fax or email you a document that is forged to look like an IRS document. Just remember that the IRS does *not* generally call people. If someone calls you claiming to be from the IRS, just hang up the phone. If you receive a letter from the IRS and you do not know whether it is legitimate, just give me a call at my commission office at 954-357-7002.

STORE SCAM:

You receive a phone call from someone claiming to be from a local store. The goal of the scammer is for you to give them your credit card number over the phone. The person on the phone claims your credit card number is being used and they want to verify your number. Do not give your credit card number to someone calling you.

BANK SCAMS:

If someone from your bank calls you and wants to discuss any information, just hang up the phone and call the bank directly by looking up the number.

TRAVEL OR VACATION SCAM:

You receive a call or email telling you that you won a trip. A free weekend stay somewhere. The only thing you have to do is to pay the taxes or fees for the trip. Unfortunately, there is no trip. You have been scammed.

LOTTERY SCAM:

You get a call or a letter telling you that you won a lottery. You are told that to claim your money you only have to pay the taxes. The scammer tries to get you to believe you need to wire money in order to get paid.

Unfortunately, many people have wired their money to only find out that they were scammed. Good rule to follow: people do not call you to tell you that you won the lottery.

FAKE DEBT COLLECTOR CALLING YOU:

You get a phone call or letter from someone claiming that they are either a debt collector, law enforcement officer or attorney. The person claims you owe money. Just hang up the phone. No need to ask any questions. They will lie or try to intimidate you.

CREDIT CARD SCAM:

Here, someone is claiming to be from your bank or credit card company. The person tells

you that your credit card number has been compromised. The scammer will ask for your credit card information telling you he or she needs it to verify a charge. Again, do not give out any information to a person calling you.

JURY DUTY SCAM:

You receive a phone call from someone claiming that a warrant for your arrest has been issued because you missed your jury duty. The scammer claims to be from a court or is a law enforcement official. You are told that if you pay a fine, you will not be arrested. Again, when you get a call asking for money, hang up the phone.

GRANDPARENTS OR FAMILY SCAM:

You get a call or email from a person claiming to be your family member. Maybe a grandchild, nephew or relative. You are told that they are in a foreign country, arrested or out of money and need you to wire money. You are told not to tell anyone so the other family members will not get upset. The scammers somehow get the names of your family members and it appears to be real. Do not be fooled.

HOW TO AVOID SCAMS:

Anytime a caller is asking you for any information, hang up the phone. If someone calling you claims to be law enforcement, the IRS or any official asking you to pay money, hang up the phone. If you have any questions, please call me at my county commission office at 954-357-7002. Also, Add your telephone numbers to the "Florida Do Not Call List" at 1-800-435-7352 or at www.800helpfla.com and the "National Do Not Call List" at 1-888-382-1222 or at www.donotcall.gov

This will help prevent callers from contacting you to solicit unwanted services.

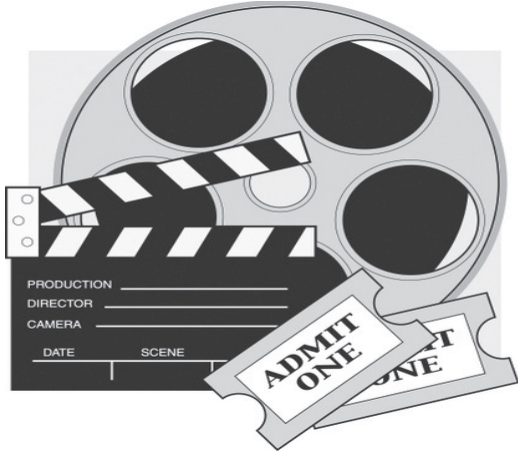

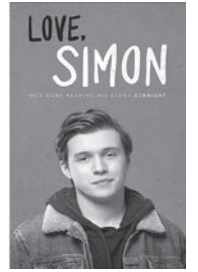

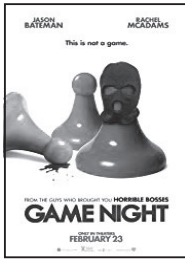

He was delighted, and even though David is now in high school, I believe he still has this toy, complete with ribbon.

3. THE PASSOVER PROBLEM (or three new plagues):

Over the years, as I hosted an Annual Seder for 30 to 50 guests in a local

hotel. We had had several plaguing problems. The first two were minor, but the last was a real challenge.

One year, the brisket did not seem to be the right color. It was red. This turned out to be a corned beef brisket. Therefore, we wrote a warning for next year's menu, requesting meal choices of chicken, salmon, white fish, or Brisket, but not corned beef!

Then, there was another year when my religious daughter, Tracy told me in a horrified voice that there were noodles in the Matzah Ball Soup! (Keep in mind that nothing in this Seder is Kosher). I dashed into the kitchen and solved the problem by having the chef strain out the noodles. My Annual menu now requests Matzah Ball Soup with matzah balls and NO NOODLES.

However, the most unsolvable, recurrent plague seems to lie in the matzah balls themselves: they were as hard as hockey pucks. Each year, when the hotel asks for my evaluation, not only do I complain about these dumplings, I also reveal the solution: just have the chef separate the egg whites and yolks and beat the whites stiff prior to combining all the ingredients.

This year, I altered the pattern, and when approving the menu, which stated no brisket or noodles, I also asked the hotel catering department to add a note to the chef, requesting this new method of preparation.

And - HE DID IT!

For the first time in all the years of Annual Seders, we had soft matzah balls. The entire wait staff came out to see me bite into the delicacy and waited for my reaction. "Soft," I cried out with delight. He did it. I was thrilled. The wait staff was thrilled and rushed back into the kitchen to tell the chef. Everyone was happy. Some of my guests said that this was the best Seder ever. I think it was because of the matzah balls.

Think of the far-reaching possibilities: Every Seder in the hotel this year and in future years will now have fluffy matzah balls. If the chef moves on, he will carry this secret technique with him. It might change our whole city

(or at least the suburbs). Not only did I happily tip the wait staff, as usual, but I also sent a tip in for the chef: money very well spent.

I shall carry this triumph in my heart forever. I am not domestic, but I can make microwave scrambled eggs and perfect matzah balls. Just ask me.

My Jihadist God?

It scares me when people who commit murderous acts against others say, "God told me to do it." There is something within our human nature that screams out and says, "no, God did not tell you to do that. You are just a deranged individual." I trained for eight years to be a Protestant Minister and served as a Clergyman for twenty-three years. Some aspects of my faith gnawed at my soul. For example, I never believed in an eternal hell. It seemed harsh to me that a loving God would condemn people to an eternity of torment for not believing a certain way.

In the beginning, I shrugged off the notion that my Christian God was a genocide type of God. However, this disturbing concept shot its way to the forefront of my concern as the world decried the murderous actions of Islamic extremists. My anger welled up as I watched the Twin Towers fall and innocent victims being blown up in cafes or on trains in different countries around the world. To add insult to injury, the perpetrators of the offenses

claimed that God called them to do it. Honestly, what kind of a God is this? However, in still quiet moments, I remembered my own faith and the God I followed.

In Deuteronomy 20:20:16-17, God ordered his Hebrew followers to exterminate all the inhabitants in the "Promised Land." This is not an isolated case. In the Imprecatory Psalms, Joshua, I Samuel, Isaiah, Hosea, and other books of the Bible, God orders the mass murder of non-Jews. The orders included ripping open pregnant women, bashing babies against the city walls, and killing every living creature. Unlike the story of Abraham, God did not provide a scapegoat for the thousands upon thousands that were murdered. For over two thousand years, Christian and Jewish theologians have endeavored to rationalize these actions. Early in my faith, I accepted these attempts to justify the unjustifiable.

Unfortunately, we can't dodge the fact that Christianity, Judaism, and Islam share a woeful strand. That common thread is that our God(s) commands the faithful to commit genocide, the horrific extermination of other human beings. Personally, I am left with a few difficult choices. On the one hand, the text and its authors are wrong, and if they are wrong in communicating God's commands here, where else in the Bible are they wrong? However, if they are correct, then the very nature of God comes into question. Both of these options leave me bewildered and rather empty.

This genocidal approach to conflict management is not the best community building model available to us. Rather than theology, perhaps the old adage we learned as kids is helpful. "Do unto others as you would have them do unto you." To extend that thought, "if it's wrong for their God to do it, it is wrong for my God to do it."

Passover: Then and Now

Looking back when I was just a little boy, I felt that Passover was big at my house. It was such a rich experience that I never realized how poor we were.

Mom would work very hard to clean the kitchen of all leavened bread products and that was our Spring-cleaning. Dad had a grape press where he made wine for the holidays. So much had to be done. We had two sets of everything: dishes, pots and pans, and cutlery. Mom washed everything by hand.

My uncle from Dubuque, Iowa, who had a cleaning plant and delivery truck, would bring live fresh-from-the-farm chickens, cases of eggs and all kinds of produce to our house. Another uncle from the South side arrived to take his share.

I remember going to the precinct captain in our neighborhood and getting boxes of free matzahs.

Mom was a great cook and made everything herself: kishke, tzimmes, gefilte fish, and chicken soup with matzah balls. Sometimes the soup had unfertilized egg yolks, which were a high treat.

This continued until my mother died. I was only 10 at the time. Our Seders ceased and from then on, we went to my Uncle's house, but it was never the same.

It wasn't until I got married that I felt I was at my own Seder. Bobbie worked as hard as my mother had, although the meals were no longer Kosher. We had 49 happy years together, celebrating many holidays.

When Bobbie died, I took up the torch and prepared the holiday dinners. Two weeks before, I would go to Costco and get a large brisket, cook it, slice it, and freeze it. I would also make sweet and sour meatballs, which my granddaughter Ruthie just loved. I would prepare the table a week in advance and move all the furniture in my one-bedroom condo to the wall.

This made room to expand the dining room table, which could hold up to 17 family and friends.

Two days before, I would make my matzah ball soup and get my store-bought kishke. My boys loved the whole meal. They would bring salads, vegetables, and dessert.

After the meal, I would sit down in my recliner while my daughters-in-law cleaned up and my sons broke down the table to its original size. The grandkids vacuumed and cleaned up everything.

I always made too much food and my rules were that if any of my guests wanted leftovers they had to bring their own containers. However, they had to leave at least two meals for me.

This year, Passover is early and the Seder will be held on the last Friday in March. We will fly down on the Wednesday before with me carrying 10 small gifts for the grandchildren to trade for the afikomen. This is a usual tradition where we hide a special piece of matzah that the children must find and return to us so we can finish the meal. We must pay a ransom to get it back.

All of this happens at the Seder Beverly hosts for 40 plus people: my family and hers, and our friends at a hotel. Her daughter, Tracy leads the service and often creates her own, modern Haggadah, starting a new tradition for future generations.

We met back in 1986 when I visited my late husband Jim Friend, who had been teaching English at Nanjing University. Xu was the first person Jim met in China, and Jim was the first Jew Xu Xin had ever met - important because he had just begun teaching a course in Jewish American Authors. What a friendship that arose!

In his diary, Jim wrote that he had the kind of conversation with Xu Xin that he had always wanted to have had with his own brother (and never achieved). The next year, Xu came to live with us in the United States while teaching at Chicago State University where Jim chaired the English department. What a year that was:

The very first week Xu lived with us, we attended the Bat Mitzvah of a cousin in Milwaukee. Of course, he went with us. Later, he wrote of this experience: "it was the first time in my life that I had ever attended any religious service. What I found there was very touching and moving: man's relationship to his fellow man was so beautiful that I began to feel that the Jewish synagogue was nothing but a home which is graced by many customs and ceremonies, illumined by the sacred lights of festivals and cheered by songs of joy and faith."

When the High Holidays were celebrated, Xu attended services with us. On Rosh Hashannah, we took him to our synagogue, the Jewish Reconstructionist Congregation in Evanston. On Yom Kippur, we all traveled to a tiny synagogue in Alpena, Michigan near the military base where our daughter, Tracy, was living. He rode with us to services through rural countryside where deer darted out from behind hedges as we wended our way from Wurtsmith Air Force Base to the tiny temple and a visiting, circuit Rabbi from Montreal.

On Simchas Torah, we were back at the Jewish Reconstructionist Congregation in Evanston. We wanted him to see and experience the magnificent sight of the Torah unfurled - held, cherished, shared by the congregation. And he marched with us as we celebrated Torah.

And so, the year progressed: Purim, Passover. Of the Seder, Xu later wrote, "the special decoration of the table, the symbols of the feast, the Haggadah readings, meant more than ceremony because it integrated tradition with

contemporary values that applied that tradition to modern society." Since then, when he has visited our country, he has again shared this special occasion with us.

All through that first year, Xu read books on Jewish history and religious practices. He lectured at an Oneg Shabbat in our temple on the many similarities between Jewish and Chinese Civilizations:

He stated that both cultures are old civilizations which have suffered, yet never lost their beliefs in the high value of their cultures; both share strong family traditions and close family relationships; both value education.

After Xu attended the Jewish wedding of the daughter of very close friends, Sharon and Dr. Roland Rudnick, a beautiful affair at the Drake Hotel, he asked, "what part of the wedding was Jewish and what part American?" It was hard for us to answer that question.

He experienced two Jewish funerals. The first was the funeral of the mother of a dear friend, Mark Symons. As Xu looked around at the mourners, he said to me, "in China, they would be more sad." I told him that most of us had not known the woman but were there as friends of Mark and his wife, Carol, to share their grief and honor their loss. I also said that she had lived to the ripe old age of 86 and after all, and it was not so sad as the loss of a child would have been.

He looked at me, startled, and replied that it was much worse to lose an older person than to lose a child. I thought I had misheard him and asked, "what would be worse for you? The loss of your father or the loss of your son?" (His son was seven years old at the time.)

He responded promptly, "oh, the loss of my father. I can always have another son; but where can I get another father?" And thus, I learned an important insight from him: something I had thought an absolute value was really culturally conditioned.

The second Jewish funeral Xu experienced was Jim's in December 1987, after my 55-year-old husband was felled by a heart attack. At this funeral, Xu was a participant, a mourner, one who came up to the open microphone

to pay his own, personal tribute.

Ironically, when Xu did return to China, he discovered that his own father had also died in December, just four days after Jim, but that his family had unanimously agreed not to notify him. They had not wished to interfere with his studies in the U.S. Thus, as he later wrote, he had lost not one, but two fathers.

As he did not know of his own father's death, he did not hurry back to China. He had always planned to visit England and France on the way home, and now, because of his Judaic studies, he decided to try to add Israel, especially Jerusalem, to his itinerary, because he feared that once he returned to China, he might never again have the opportunity. But how to get the funds? Xu was nothing if not enterprising. First, he wrote an article for The Sentinel, stating his position as a Chinese scholar of Judaism, setting forth his dream of visiting Israel, and then stating that while he had saved every penny while living and working in the United States, he could "use a few dimes." Small sums came in.

Next, he visited representatives from El Al airlines and the Israeli Consulate in Chicago. They responded handsomely to his plea, with El Al sponsoring the flight, and the Harry S. Truman Research Institute for the Advancement of Peace at Hebrew University covering his expenses in return for lectures at the school on "Jews and Judaism through Chinese Eyes."

He told the Jerusalem Post that Israel, to the Chinese, is "an alien and mysterious country, even more so than the countries of the Western Hemisphere," and that what little the Chinese do know is negative. "We learned that Israel was the running dog of the Western imperialist powers," he said.

And despite his extensive reading of American Jewish authors, he acknowledged that, like most Chinese, he knew little factually about Jews or Judaism as practically no literature exists on the subject in China. In fact, until he came to Chicago, he had thought that Hebrew was a dead rather than a spoken language. Until he visited Israel, he had never heard of a Kibbutz.

But Xu's desire to learn more about Judaism did not end with his trip to Israel. Upon his return to Nanjing, he established a China Judaic Studies As-

sociation and this has grown and grown until it is now the Diane and Guilford Glazer Institute for Jewish and Israeli Studies at Nanjing.

What a scholar he is. In his 40 years of teaching, he has accomplished more than what similar scholars achieved in 400 years. How many trips to Israel? Immeasurable. How hard he has studied -- at an Ulpan in Israel to learn Hebrew, at Yivo in New York to learn Yiddish, at Hebrew Union College in Cincinnati, to learn Torah, Talmud and religious studies and Jewish history. In addition, whatever he has learned he has taught, in formal and informal classes, in synagogues and lecture halls worldwide. I am sure that somewhere in this volume will be lists and lists of where he has gone and what he has told, veritable, Johnny Appleseed uncovering and spreading historical information to a thirsty academic world.

However, for me, as much as I am impressed by and admire his scholarship, I am more touched by his kindness in friendship. In the seven trips I have made to China over the past thirty plus years, he has always been at my side. In the fifteen or plus trips he has made to the United States, he has always visited me in Illinois and in Florida and once we even met in California. I must have heard him lecture over 100 times and have learned something new and valuable each time. No one I have ever seen has shown the dedication and love of learning that Xu Xin expresses with every cell of his body. He has created what did not exist before and left a legacy for all who follow. He is unique, the most unforgettable person of my life and a link to a beloved husband whose friendship sparked Xu's remarkable journey, even though, sadly, Jim saw only the glimmer of the beginning.

With this essay, I try to say some of the things my late husband would like to say if he could only stand here now, shake Xu's hand, and tell him how he, I and our whole family are so very proud to have been blessed to know him.

School News, Student Concerns

I am a student at Clifton High School. Every time I set foot in this building, I fear that any step could be my last. With the recent school shootings in Florida and Alabama, there has been a surge of support for gun control and regulation. A popular argument being disputed upon is whether teachers should be armed in the classroom. I feel strongly that teachers should not be armed. Adding more guns to the situation will make it worse, not better. Whoever thought handing untrained teachers guns was a good idea... well, you get the point.

Let's say for argument's sake that each teacher was given the proper instruction needed to safely operate a firearm. The National Center for Educational Statistics (NCES) reports that there are just over 3.6 million teachers in the United States. Shooting lessons do not come cheap. I found a site online that charges a flat fee of \$185 an hour for a lesson.

Let's say that each teacher needs roughly 3 hours to get acclimated with a gun and feel comfortable shooting it. This means that it would cost roughly \$1,998,000,000 to train every teacher. However, 3 hours will not give you the precision and accuracy that comes with constant practice. In a Quora discussion on how long it takes the average person to become proficient with a gun, the estimated answer is around 40 hours and 1,500 rounds.

Where would this money come from? \$1,998,000,000 is not pocket change. President Trump openly aired his support on his Twitter account. This leads us to believe the federal government might get involved and implement a law in which arming a teacher is mandatory. The US is a debtor nation with approximately \$19.84 trillion owed. How does arming teachers fit into our budget? Even if the arming of teachers was dealt with on a state or local level, the money to do so

is virtually nonexistent. Clifton High is underfunded as it is. Enforcing this idea would be emptying our already empty coffers.

This idea, while outlandish and vastly disapproved of by many teachers, is still gaining traction. The harsh reality is students simply won't feel safe as long as teachers are armed. And teachers won't feel safe as well. Josh Grubs, a college professor and long-time gun owner uploaded his two cents on Twitter on February 21, 2018. Grubs felt that while being a decent shot, he was not capable of safely and capably defending a classroom. He went on to say if he felt he couldn't, how would other teachers feel without any of his training?

There is also the very real possibility of a stray bullet hitting a student. A gun is no laughing matter. No matter how skilled or proficient you are, a firearm is still a firearm. Dangerous.

We should not be focusing on how to arm teachers; we should be focusing on how to protect students. Students should walk through the halls worrying about assignments and tests, not gunmen. Gun control must be closely regulated and monitored. Metal detectors should be placed in front of every doorway and entrance. Security should be increased. I don't know about you, but if Mother Nature were a woman, I'd have given her one heck of a kiss for this arctic reprieve.

This month, my friends thought I should write about living alone. This is something I've been doing for the past almost 9 years and have come to really like a lot. When I first embarked upon this new way of living, I didn't know if I would like it or even get used to it. I had been living with someone my entire life. First my parents and then I got married at 20. I had spent time alone, even as much as a month at a time, but that kind of alone is very different. I was spending time alone but I wasn't really "alone." A good friend at that time told me it would become an acquired taste and I would come to love it. I thought he was crazy but as it turned out, he was right. At least for me.

However, people have very different experiences of this condition. Some, like myself, enjoy it while others absolutely loathe it and are desperate to find someone to live with. My eavesdropping and observing have led me to believe that fear is the biggest reason for this. So, I guess this article will be more about fear than aloneness.

Fear is different depending upon your age, financial situation, family situation, friend situation, etc. I could probably go on and on with various reasons for fear. At the ages of many Wynmoor residents, the fear is often about becoming ill or infirm and not being able to care for ourselves. That is a valid concern. If you are financially able, you can hire a daily or live-in aide which alleviates that problem. If you are in financial hardship, it becomes more of an issue. Some Medicare plans and Medicare advantage plans will enable you to have the help you need, at least part of the time.

Here is where there will be overlap with the friends and family situation. Should this be the main reason to want to live with someone? That depends upon the state of your present health and your age. Would you want to live with another person if it were that person who needed the assistance and care? That is just as likely to occur. Something to think about.

Another fear is fear of loneliness. This is similar to the prior issue because if it falls into the fear category, it's really just about being alone if something happens. There is a separate category which is just plain loneliness, without the fear. If this is your reason for wanting to live with someone, it may work out well but it also may backfire. If it's about your need to have someone, can you really be discriminating or will the neediness lead to living with the first available and willing partner? And will that person stick around when you fall ill or infirm? Will you be willing to become the caregiver?

Here is where friends and family come into play. Here in Wynmoor, you really don't have to be alone unless you want to be. Unless of course, you are ill and housebound, which brings us back to the beginning of this article.

But, if you are youngish and able-bodied, you can join so many classes, courses and social events that you will wonder how you ever had time to do those necessary tasks like buying food or doing laundry. There is so much to do that you may be happy to come home to an empty apartment, kick off your shoes and collapse on the couch without anyone asking what's for dinner. A crucial aspect of this is that Wynmoor is very much a couple community and the world is also very much couple oriented. That doesn't mean you need to live with someone on a full-time basis. You can enjoy each other's company and then go home to your separate residences.

There are really so many choices that I don't know why I hear so many men and woman being so distressed over this subject. If you feel like you absolutely want to live with someone, I believe that you can find someone of like-mind. Does it have to be an opposite sex person? Does it have to be a romantic involvement or do you just want company in your home? If that is the case, it may be relatively easy to resolve this. If you are looking for a spouse or intimate partner, you may have to do a little more searching.... but it is doable.

I think the important thing here is to find out from yourself just what you are looking for. If you are bored, there are many solutions to that. If you want someone to eat with, there are dinner clubs all over Wynmoor. I met some wonderful friends having breakfast at the 19th Hole. There is no reason for you to be isolated. Once you know what you are looking for, it will become easier for you to find it.

I will be writing an article for June and hopefully when I get back, my mailbox will be full of questions. Remember they are all anonymous and no one, not even me, will know who you are.

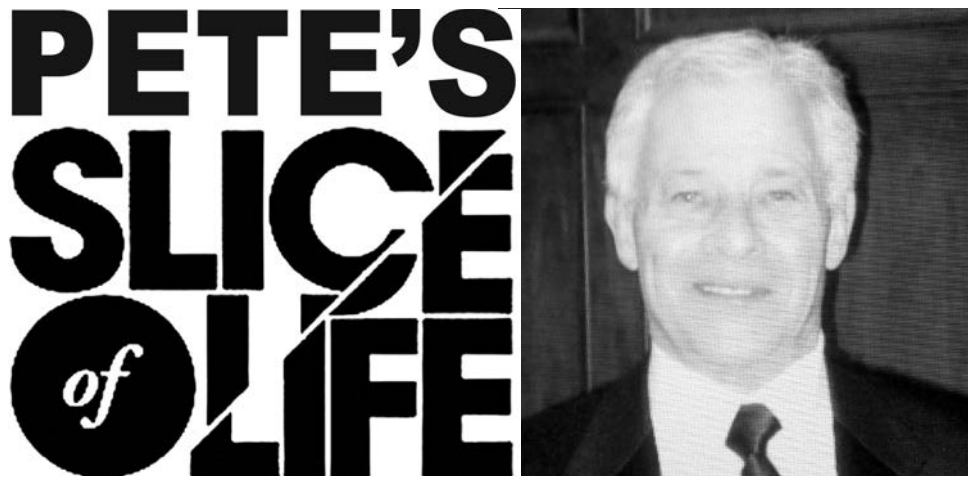

Diversify Your Investments...But Consolidate Your Providers

You have probably heard that diversification is a key to investment success. You might think that if diversifying your investments is a good idea, it might also be wise to diversify your investment *providers*. After all, aren't two (or more) heads better than one?

Before we look at that issue, let's consider the first half of the "diversification" question. Namely, how does diversifying your investment portfolio help you?

Consider the two broadest categories of investments: stocks and bonds. Stock prices will move up and down in response to many different factors, including good or bad corporate earnings, corporate management issues, political developments and even natural disasters. Bond prices are not immune to these dynamics, but they are usually more strongly driven by changes in interest rates. To illustrate: If your existing bond pays 2 percent interest, and new bonds are being issued at 3 percent, the value of your bond will fall, because no one will pay you full price for it. Of course, it may not matter to you anyway, especially if you planned to hold your bond until maturity, at which point you can expect to get your full investment back, providing the bond issuer doesn't default.

Here's the key point: stocks and bonds often move in different directions. If you only own U.S. stocks, you could take a big hit during a market downturn, but if you own domestic and international stocks, bonds, government securities, certificates of deposit or other types of investments, your portfolio may be better protected against market volatility, and you'll have more opportunities for positive results. Keep in mind, though, that even a diversified

portfolio can't prevent all losses or guarantee profits.

It clearly is a good idea to diversify your investment portfolio. Now, let's move on to diversifying financial service providers. Why shouldn't you have one IRA here and another one there, or enlist one advisor to help you with some types of investments and a different advisor assisting you with others?

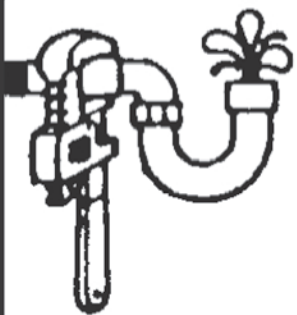
Actually, some good reasons exist to consider consolidating all your investment accounts with one provider. For one thing, you'll keep better track of your assets. Many people do misplace or forget about some of their savings and investments, but this will be far less likely to happen to you if you hold all your accounts in one place.

Also, if you have accounts with several different financial service providers, you might be incurring a lot of paperwork and many fees. You can cut down on clutter and expense by consolidating your accounts.

Most importantly, by placing all your accounts with a single provider, possibly under the supervision of a single financial advisor, you will find it much easier to follow a single, unified investment strategy, based on your goals, risk tolerance and time horizon. You won't get conflicting advice and you'll receive clear guidance on important issues, such as the amounts you can afford to withdraw each year from your retirement accounts once you do retire.

Diversification and consolidation. One is good for building an investment portfolio, while the other can help you invest more efficiently and effectively. Put the two concepts together and make them work for you.

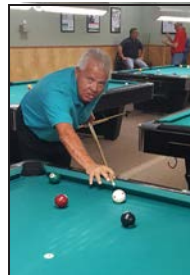


Weekly Open 9 Ball Tournament Results

HISTORY CORNER

ALICE PAUL: Overpowered - NEVER BROKEN

She was always on the forefront and always two steps ahead of those on the front lines. At first, she and her fellow Suffragists wanted the right to vote for women. Alice wanted more. In 1905, Alice Paul earned a degree in Biology from the University of Pennsylvania. She went on to earn a Masters, a Ph.D. in Sociology and a Law Degree from Washington College. Alice was bright, educated, determined, fearless, and paid an appalling price for her convictions.

While in England studying, Alice joined the Suffragist Movement. When she confronted the Minister of Foreign Affairs with a question about women's rights, she was forced out of the meeting and arrested. Time and again, police would stand by and ignore men beating up the Suffragettes as they peacefully demonstrated. Along with other women, Alice was imprisoned repeatedly for protesting for women's right to vote.

Rather than being treated as political prisoners, the Suffragettes were put in prisons that had horrible conditions, infested food, and poor sanitation. They were abused and beaten by the prison staff. In silent grievance against their treatment in prison, several women staged hunger strikes. The wardens responded with force-feedings, which was the most torturous aspect of prison life.

There were two methods of force-feedings. While being held down by staff, those on hunger strike had a nasal tube rammed up the nose and then a mixture of raw eggs and milk were poured into a funnel at the top of the tube. The second method, which did the most damage, was to hold the victim down, force the mouth open, and push a wide throat tube down the esophagus. This method damaged Alice Paul so much that she was taken from prison to the hospital and treated for severe gastritis. The damage caused by this force feeding resulted in pain throughout her life. She endured this brutality numerous times in both England and the United States, just to bring awareness to women's right to vote.

After the passage in 1920 of the 19th Amendment, which gave women the right to vote, Alice Paul and a few other Suffragettes broke with the main body of women activists. Alice campaigned for and wrote an Equal Rights

Amendment in 1921. For the next fifty-one years, she challenged Presidents, Congress and activists for an Equal Rights Act which "provided legal equality of the sexes and prohibited discrimination on the basis of sex." In 1972, Congress passed the ERA but needed 38 states to ratify it. By 1977, 35 states ratified the Amendment. Florida was one of the states that did NOT and still has not ratified the Equal Rights Amendment.

Alice Paul never wavered. She was a major voice in helping pass the Civil Rights Act of 1964. She died in July, 1977 seeing many of her dreams come to fruition. However, there must have been some bad taste in her mouth from the brutality and resistance she fought against all her life. Dear Reader,

When was the last time you had a day with NOTHING to do? No work, no chores, no family obligations, no required phone calls, NOTHING – NOTHING?

I bet most people can't EVER recall such a day! For some people, this kind of imagining can make them panic. The concept of not rushing or having a full agenda can send terror through their systems since they've become so accustomed to the adrenaline rush of their GO-GO-GO lifestyles! Checking things off their to-do lists, making calls and getting things done can enliven lots of people until one day they just feel utterly DRAINED! Then, another sort of panic kicks in!

What to do? More java? More green drinks? Adding more exercise? Perhaps a better sleep aid? The temptation to find an instant fix to the adrenal fatigue can set in and soon folks are adding more of this and more of that to an already over packed schedule. What if I told you scheduling a NOTHING DAY is the cure? Better yet, what if you don't believe me and you try it for yourself?!

The benefits of the day lasted for weeks. I felt calmer, clearer, more loving and more aware that I have choices in every moment of every day of how to respond to my environment and to the barrage of stressors that come my way. I no longer see my phone as my boss who I must instantly please and

respond to. Instead, my phone works for me as a faithful administrative assistant who merely informs me of who wishes to get my attention and I decide who gets access and when. This simple shift has been beyond empowering, as I am genuinely focused on whomever I am with and not a slave to instant responding to whoever is texting or calling me.

I am sure we have all been in the annoying presence of someone who literally can't help themselves from reading and responding to every stream of communication as it flows into their little device. How quickly the focus shifts from the people in the room at the present moment to those on the other end of the line. Try choosing to give your full presence to whomever you are with and leave your phone on silent and watch how sweet the connectedness becomes. Notice how your spouse or child light up when they see your full consciousness open and focused on them!

My eleven-year-old daughter actually squeals with delight when I ask her to go for a "no-phone" walk with me! She knows it's going to be hand-holding and sharing our heart moment. While it seems so simple, it's benefits are monumental.

I have since indulged in several one-day Transcendental Meditation Retreats to reboot and re-emerge as a softer, more loving version of myself. My husband and I also luxuriate in our own NOTHING days where we make arrangements for our children to be cared for by others, and we completely unplug from the outside world so we can fully surrender and get reacquainted with ourselves and one another. Some days, we opt to explore a new nature trail. Other days, we literally stay home and enjoy how the quiet allows us to hear the humming of birds and the gentle breezes outside our windows.

The world does not need a PIECE of you. What the world needs is the PEACE of YOU!

If you do NOTHING else, schedule your NOTHING day soon. You can thank me later, but certainly NOT on your NOTHING day or you will have to start over!

Here's to NOTHING opening the pathways to EVERYTHING for you!

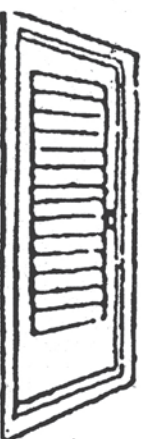

Specializing In Success

By air or by sea, and on the ground, the Broward Sheriff's Office's specialized units are devoted to keeping all of the county's 1.9 million residents and millions of Annual visitors safer. In fact, these countywide units, when working in tandem with our dedicated men and women on the streets, provide exceptional service to all the cities in Broward County, not just those policed by BSO.

I'd like to tell you about a few of these units and how they serve our communities.

We've all seen police forensics shows like "C.S.I." and how they amazingly use DNA and other forensic evidence to catch a criminal within an hour-long episode. But, in real life, this sort of work takes weeks or even months.

This meticulous work requires patience and precision and qualities the roughly 50 dedicated professionals in BSO's Crime Laboratory display every day. In fact, our crime lab is a nationally-recognized leader in the forensic science community as the first sheriff's office crime laboratory to become internationally accredited by the prestigious American Society of Crime Laboratory Directors/Laboratory Accreditation Board.



BSO's Special Weapons and Tactics (SWAT) team has been bravely serving Broward for more than four decades. During that time, SWAT has responded to some of the county's most dangerous law enforcement situations, including barricaded subjects, hostage-taking situations, violent felon search/arrest warrant operations and other tactical operations. Today, nearly 40 deputies, nine county firefighter/paramedics and 12 negotiators staff this team.

It also takes a special type of person to run toward a potential explosive and attempt to defuse it. But that's exactly what our BSO Bomb Squad technicians do. This unit coordinates the investigations of situations involving the use of bombs, explosives and mass-destruction weapons at post-blast explosion scenes. The unit's highly-trained and skilled members are equipped with state-of-the-art tools including two custom-designed bomb disposal

response vehicles, a full-containment explosive vessel with transport, the newest remote bomb disposal robot and two additional remote-control robots.

BSO must also give thanks to the furry friends in our K-9 unit who help sniff out crime. These loyal canine deputies of various breeds are specially bred and trained for a variety of tasks. Some canines track and apprehend criminals, while others search for and find missing persons. Other BSO dogs sniff out narcotics and bombs and even find contraband smuggled into our jails. Today, we have 55 dogs assigned throughout the agency available around the clock for immediate response.

Our countywide units are not limited to the land. The BSO Marine Unit provides critical help in our waterways, and our Aviation Unit helicopters are our eyes in the sky, helping to locate and apprehend violent criminals. They also routinely perform emergency medical transports and assist with rescue missions in the Florida Everglades.

All of these services, which are called "regional services," are made available upon request to help assist law enforcement departments in every corner of Broward.

At BSO, our tasks may be varied, but our mission is the same: to serve and protect all of Broward.

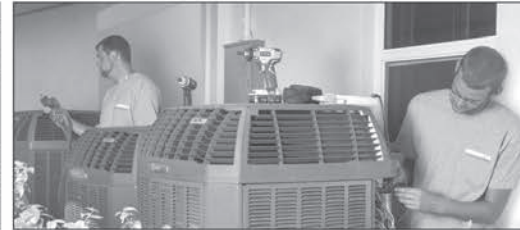

Each Individual Can Help Unclog Our Court System

As an attorney for forty-four years, I have learned not to discuss with my clients, politics, sex or religion. So, I'm not going to start now.

What I do discuss is how each person can make a difference in lessening the burden on our court system, particularly the probate courts in Dade, Broward and Palm Beach Counties.

When I first started practicing, I could file a Petition for Administration of a Will and receive a signed copy of the Letters of Administration (Court Order appointing the Personal Representative) within a week or two. If I had questions about a case or a particular type of filing, I could call the clerk and receive helpful assistance to make things easier for myself and my client.

Today, the judges and clerks are burdened with so many cases that it often takes months to get that same court order. The delay results in lawyers going to court for hearings to appoint the Personal Representative, thereby taking up the judge's time that could be utilized for more substantial matters. Even getting into court for a simple, non-contested hearing can take over a month.

If I were to talk about politics, I would suggest getting additional money in the budgets for more judges, clerks and judicial assistants. But, I said I wasn't going to discuss politics.

There is an answer that does not require more money in the budget: take the initiative in your own life so that court administration will not be necessary. If you do a Life Estate Deed or a Revocable Living Trust, you can avoid probate on any property that you own when you die. If you do a Durable Power of Attorney, Designation of Health Care Surrogate and Living Will, you can avoid a Guardianship in court if you become incapacitated.



For many years, I was a family and civil mediator certified by the Florida Supreme Court. While mediators are used once a lawsuit has been filed, they can best be used prior to litigation. Seeking a mediator before filing for a divorce and reaching an amicable agreement for an uncontested divorce will save you thousands of dollars in attorney's fees and court costs as well as lessen the increasing burden on the Family Law Division of the court. Seeking a mediator on a civil matter can avoid a lawsuit in the Civil Division.

With the availability of unlimited information via the internet, it is amazing that so many people still end up further clogging the Courts while they are alive and when they die. Most mediators and many lawyers prefer not to go to Court if legal documents or pre-litigation agreements can be created.

I encourage all adults to put their own house in order. We cannot completely control our own lives, however, we can take steps to ensure that our lives and deaths will be as simple, painless and inexpensive as possible by staying away from our court system unless absolutely necessary. If every person did one thing to lessen the burden on the legal system, maybe we could roll back the clock a little to where our court systems ran smoother and faster.

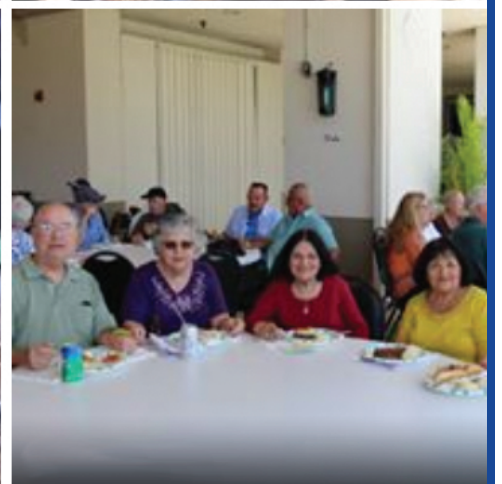
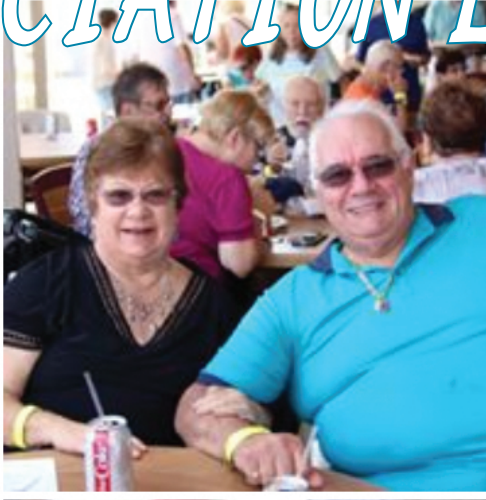

The process involves:

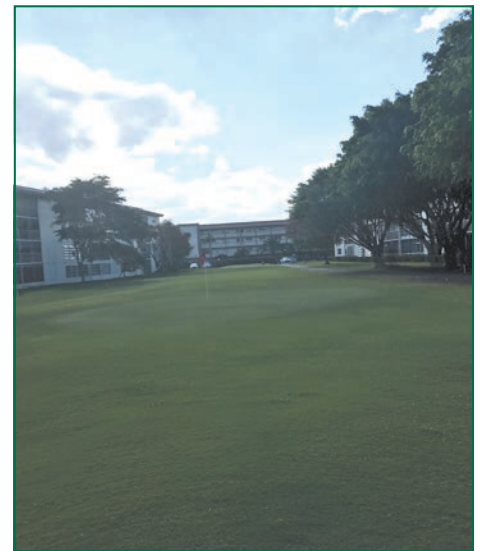
- Stripping the green of Bermuda grass
- Amendments - sand organics
- Till
- Fumigate
- Final grading
- Sprigging the green with Platinum Paspalum

Plans for sprigging the greens and tees will commence last week in April and hopefully be completed and playable by the end of July.

The greens that are being prepared now have temporary greens with a white circle around them. A local rule of two putts within the circle is in effect. The growing season is upon us and it should be fun to see the completion of all the greens replaced with the Platinum Paspalum grass this Summer. 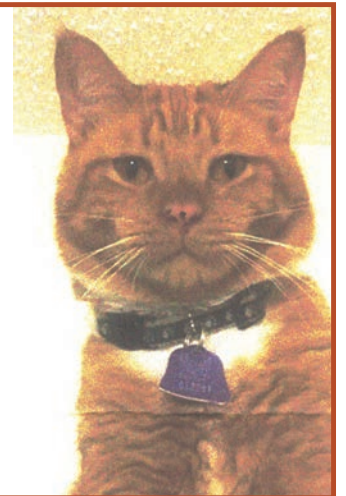

Stepping Out To The Theatre

No dialogue! **TIME STEP** has no story! Just singing, dancing, dancing, and dancing. Oh, it is easy to imagine a story, starting when the cast enters, spritely tapping their way up and down a magnificent staircase to *The Lullaby of Broadway*. They all carry suitcases. Are they coming or going? The next song answers the question - *42nd Street!* They have arrived, full of energy and it is assured that these fresh, happy faces, five dancers and two singers, now in the Big Apple, will end up on theater billboards.

If this is their story, each of the 23 routines that ensues could be following moments in their careers as they offer more and more complicated and varied routines. They are Spanish when performing *Besame Mucho*, Irish with *Danny Boy*, and Italian with *Volare*. They perform jazz with *This Joint is Jumping* and are smooth and gliding in *Tuxedo Junction*. This is only the tip of an iceberg that also includes a European Jig, Flamenco, Reel Steps, Clog and African Rhythms, often brilliantly combined.

It is such a multi-talented cast. With fine, full voices, Sandra Marante and Matthew Staley handle the songs, while Staley sometimes provides accompaniment on the guitar. Lithesome MacKenzie Cutliffe and Ariel Seidman-Wright are the spritely female dancers, with Seidman-Wright who also displays talent as a fiddler Dancer/choreographer. Sebastian Goldberg was joined by Stephen James Potter and Nathaniel J. Washington in many non-stop, energetic numbers.

Kudos must go to costume designer, Jerry Sturdefant, for the bright,

colorful costumes (and to the whole cast for their quick-change ability), to choreographers, Goldberg, Allison C Scott, Ashley Bachner, McKayla Cephas, Alessandra Torres, and to Stage Manager, Jose-Luis Ramos, for the dazzling staircase and the films projected on the back wall which provided wonderful visuals for the numbers. The highest praise is reserved for Kevin Black for his brilliant conception and direction.

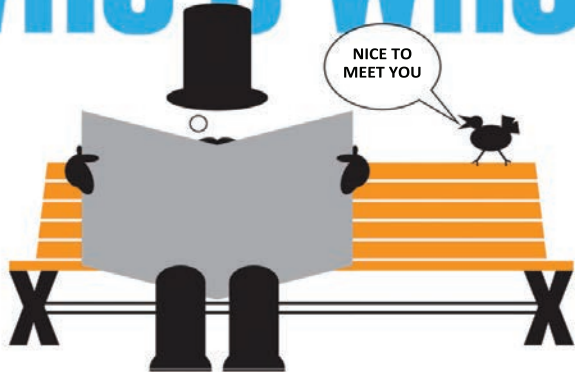
many interesting things to say on a number of topics.

On his "down time," Jack enjoys relaxing and sitting with his friends outside his complex. One of his friends, Lillian is 102 years old!

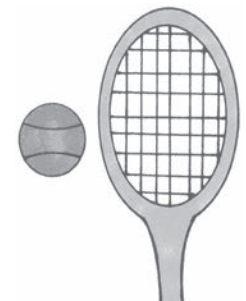

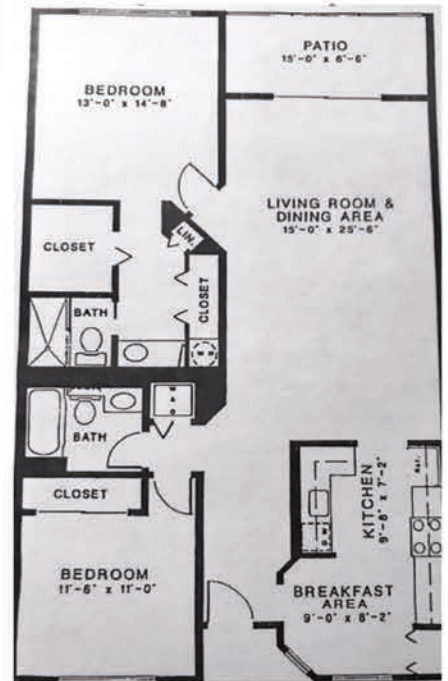
