# Bike Safety

There is only one road and it is up to bicyclists and motorists to treat each other with care and respect.

In Florida, the bicycle is legally defined as a vehicle and the bicyclist is a driver. Bicyclists have the same rights to the roadways, and must obey the same traffic laws as the drivers of other vehicles.

These laws include stopping for stop signs and red lights, riding with the flow of traffic, using lights at night, yielding the right of way when entering a roadway and yielding to pedestrians in a crosswalk.

## Light Up to Ride Out Safety Tips for Cycling in the Dark



Below are a few tips that will help you stay safe while riding in the dark.

**Lights:** Having lights on your bike is vitally important to night riding - to see where you're going, of course, but more importantly, to be seen by others. Having lights on your bike is the law. At a minimum, you should have a white constant light in the front and a blinking red light at the rear.

**Reflectives:** While lights are obviously critical for riding at night, don't discount the value of reflective clothing or tape. The idea is to make yourself as visible as possible. Adding reflective tape to your bike frame can also be an option.

**Plan your route:** Depending on what you want to get out of your ride, whether it's a structured training session or just a case of getting the miles in, plan ahead and have a route in your head or on a computer. Try to choose routes you're very familiar with when biking at night.

**Ride with a partner or group:** Riding with a friend or a group is a good way to approach night rides. Having a group of friends is a good incentive and just the motivation you might need to head out into the dark. There is also safety in numbers.

“God, it didn’t have to be coffee. God, it didn’t have to be Jack’s, but, but, God, it has to be better than this man...”

And I learned to be careful what you pray for.

The third occasion was just this week as we planned our newest and bravest airline journey to Florida. I had not feared coming to this state or the risk of the flight itself, as Irv and I had taken both Moderna shots plus the booster. What I had feared was what we would experience once the plane landed – how to get from the airport to our condo.

Usually, Irv drove down with one of his sons and I flew – sending my car mounted on an auto transport. Once I landed, I would phone the number of an airport parking garage where a shuttle would then arrive and take me to the car. Then I would wend my way home.

I would vary the route. On days when I was cheerful and peppy, I would travel Federal Highway, veering to A1A in Fort Lauderdale to enjoy viewing the picturesque beaches, and then ultimately turn right when I got to Commercial Blvd.

Then, I would drive the few blocks east towards the ocean, stopping at the Aruba Restaurant. I would order a favorite lunch – Shrimp Louis – sit back and bask in the ambience. When I resumed my trip, I would make one more stop – at the Flea Market (of course) – where I would browse several aisles and make sure I got the vouchers for future discounts. This was especially important if we were still in October because I could get vouchers for that month and then a few days later get more for November—what happiness. I would also have a snack and call my cousin Harriet in Milwaukee, so I could start the conversation with, “Greetings from the Flea Market” before heading to the condo.

Sometimes, I would drive directly up Highway 95 from the Airport to Wynmoor, but that was a rare choice. and I NEVER faced the toll road.

On this trip, however, I needed to be concerned about two of us. Irv is unfamiliar with this stretch and is notable for his erratic sense of direction. I am uncomfortable as either a leader or follower of a two-car safari. Should I attempt Aruba, or just take the highway? Would he get lost? In addition, we would be going to a new condo (my fourth in all these years). After Bermuda, Portofino, and Granada, it would now be Lucaya.

Yes, Irv has a navigator and he reassured me all would be well. Nothing fazes him.

I fretted for weeks and made other suggestions. For example, we could ship both cars directly to Wynmoor and just take an uber or a cab home. Or we could ship just one car and drive the second car companionably together. He refused.

On November 2nd, we awoke at dawn – 5:00 a.m. - picked up at 6:00 a.m. and boarded our American Airlines flight at 8:30 a.m. Just prior to boarding, I phoned the Florida parking facility to tell them when we would be arriving.

Our cars were not there yet but not to worry. They said to call again when we landed around noon. That is what we did. Our cars hadn’t arrived. They knew nothing more except that one of the transporters (ours) had broken down enroute.

The experience of being driven was so comforting that I have resolved that now and forever more we will have the cars delivered directly -- no matter what the cost – especially when I learned the car keys could be left in the automobiles when the doors were locked if we only wrapped them in tin foil.

Actually, as I sit here on the lanai writing this while the rising sun reflects on the sparkling water below my fourth-floor window and a goose graze on the green shore grass, all my prayers are answered.

## I Should Never Have Gone To My Bar Mitzvah Part II

My grandson is more of a Jew than you’ll ever be! You better sit down and shut up before I come down there and straighten you

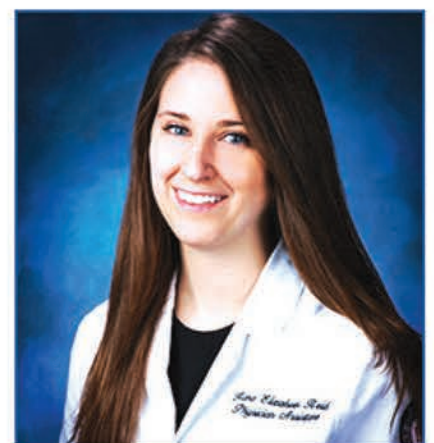

out!" While this exchange was taking place I thought I was going to throw up, collapse, and die.

At this point the rabbi took me by my hand and led me over to a gigantic chair next to the torah ark. He told me to sit down in it. The problem was that I was so tiny and felt so weak from the tumult my grandma caused that I couldn't lift myself up enough to get into the chair. Cantor Flussberg then came over. He picked me up and put me into the chair just as if he was putting a baby into a high chair. Once in the chair I heard my grandmother say to my mother, "where is he? I can't see him! What's going on down there? Is he still here?" All the while I was saying to myself, "How do I get out of this place? This woman is destroying me!"

My father was given the honor of opening the ark curtain revealing the biggest torah I had ever seen in my life. The rabbi then lifted me out of the chair and told me to go over to the ark and take the torah out so that the next honoree, Uncle Morris, could remove the covering the torah was wrapped in. I grabbed the handles of the torah and removed it from the ark. When uncle Morris came up I whispered to him, "I don't think I can hold onto the torah much longer, it's too heavy for me." Uncle Morris said, "you are doing just fine. Don't worry! We are all so proud of you!" Then the rabbi, who was standing right next to me told me to raise the torah high above my head and

bring it over to the rabbi's lectern. I started to lift it high above my head but then I lost control of it. As the torah fell from my hands it hit the rabbi on his head with a tremendous thud, then it bounced off his shoulder causing the rabbi to fall to the floor with the torah following him. When it hit the ground it began to completely unravel with the torah scroll stretching from one end of the bema to the other. At that moment there was a loud outburst of crying and wailing by the horrified congregants. Many rushed up to the bema to try to save the torah. They were kissing it and saying prayers over it as they tried to roll the scroll back into it so that it could at least resemble a torah once again. As soon as the rabbi was able to get himself up off the floor he said to me, "I will not allow you to continue. YOU MUST LEAVE NOW!" Then he called out to my parents, "You must take your son and get him out of the synagogue immediately!"

When the rabbi said, "YOU MUST LEAVE NOW!," I wanted to kiss him. When I looked around I noticed that he seemed very unsteady on his legs and suddenly he fell to the floor once again. "Get that kid out of here, get him out!" At that point I left the synagogue and that finally brought to a close just about the worst year I ever had. Oh, and before I forget, because my grandmother was so impressed with my bar mitzvah performance, she never spoke to me again. THE END!

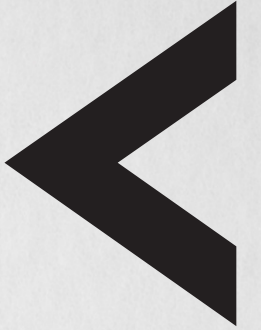

## Don't Avoid 'Taboo' Topics With Older Parents

If your parents are getting close to retirement age, or are already retired, it may be time to talk with them about financial and aging issues, some of which may involve difficult conversations. For the sake of everyone in your family, don't avoid these "taboo" topics.

You'll need to be careful about approaching these subjects with your parents. Mention ahead of time that you'd like to talk to them about their future plans and reassure them that you want to understand their wishes, so their affairs will be taken care of as they would like.

If your parents are agreeable, choose a location comfortable for them and ask whom they might like to invite (or not invite). Then, think about how to open the conversation, preferably not with what they want to do with their money – this could be interpreted as your seeking information about your inheritance or being skeptical about their financial decisions. Instead, build a broad-based discussion about their vision for their aging years. A series of shorter conversations may allow you to cover topics more comfortably, one by one, rather than trying to solve everything at once.

### Try to address these areas:

- **Health care** – You'll want to learn if your parents have established the appropriate health-related legal documents – a health care power of attorney, which gives someone the authority to make important decisions about their medical care if they become unable to do so themselves, and a living will, which spells out the extraordinary medical treatments they may or may not want.

- **Independence** – As people age, they may begin to lose their independence. Have your parents considered any options for long-term care, such as a nursing home stay, or the services of a home health aide? And do they have plans

in place? If they plan to receive support from family members, do their expectations match yours?

- **Financial goals** – Focusing on the personal and financial aspects of the legacy your parents want to leave can be a valuable conversation. Have your parents updated their will or other arrangements, such as a living trust? Have they named a financial power of attorney to make decisions on their behalf if they become incapacitated? Do they have the proper beneficiary designations on their insurance policies and retirement plan accounts? If you can position these issues as being more about your parents' control over their financial destiny, rather than "who will get what," you'll more likely have a productive conversation.

- **Last wishes** – You'll want to find out if your parents have left instructions in their will about their funerals and last wishes. Express to them that you, or another close family member, should know who is responsible for making sure their wishes are met.

Money, independence, and aging can be sensitive topics. Don't think you have to go it alone – you can enlist help from another close family member. Or, if you know your parents are working with a trusted advisor, such as an attorney or financial professional, you could see if they'd be willing to have this person participate in your talks. You might even be able to introduce them to one of your advisors.

In any case, keep talking. These conversations can be challenging, but, if handled correctly, can be of great benefit to your parents and your entire family.

## Senior Golfing Tips

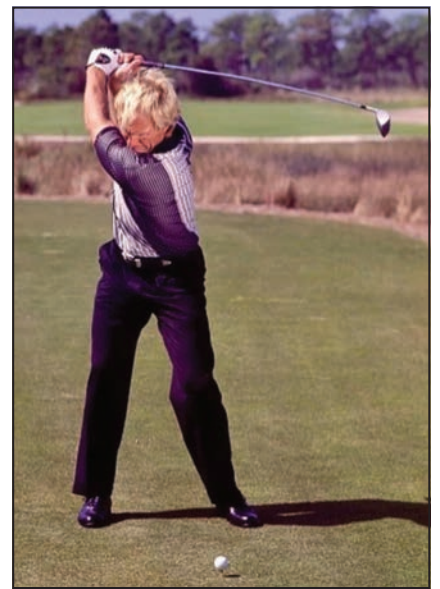


Many PGA professionals have weighed in on how to maintain their distance on the long clubs as they approach competing on the Champions Tour. As a senior golfer we are also faced with maintaining the length of swing to create speed. Obviously, the likes of John Daly and his extra-long

and supple swing isn't normal for seniors. But, we can observe and strive for a more supple swing with even some bend in the lead arm. The list is quite lengthy of the players that had a softer lead arm in their backswing. From Jack Nicklaus, Tom Watson, Greg Norman, Fuzzy Zoeller, Fred Couples, Curtis Strange to Phil Michelson, their backswing length was full and supple. On their downswings the lead arm would straighten as they approached the ball from inside but this is the effect of a good downswing.

A recent picture of Lee Trevino exhibits a closed stance, the trail foot pulled behind the lead foot at address creates a more inside take away and thus producing a bigger hip and shoulder turn. Ben Hogan, referred to this as his power stance and even played a slight fade. Finally, take more time on your longer clubs and "enjoy the walk."

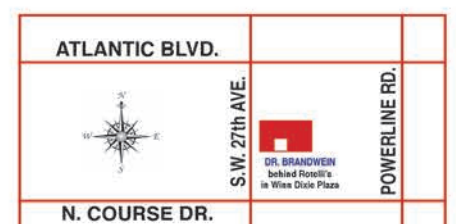

# The Chinese Medicine Art of "Bankes"... I mean Cupping

Back in 2004, when I moved to South Florida, my mother was having some problems with one of her hips.

My mom was not one to complain but reported that it most always pained her to some degree and that certain movements and activities were getting harder and harder to do. She could no longer take extended, leisurely walks with her Mahjong buddies without suffering for days afterward. Even standing in the kitchen and cooking became problematic as she would have to constantly shift her weight from side to side or lean forward on the counter to relieve the dull ache in her hip.

As an Acupuncture Physician, I had been able to help her now and again over the years, providing her with Chinese herbal formulas to help reduce the pain and inflammation in her hands from rheumatoid arthritis or congestion and pain from sinus inflammation.

She had always been supportive of me and my chosen vocation and although I never understood why, she would often clip and send newspaper articles to me about acupuncture and Asian medicine. I'm guessing it was some sort of validation in HER mind for what I was doing although on more than one occasion she said to me "but you're not a REAL doctor." I understood this viewpoint, common among many people, that if I couldn't prescribe medication then I must not be a "real" doctor. It never occurred to her that the Chinese herbal formulas she had been taking for years could be considered medication, although no prescription was needed nor were there side-effects of any kind.

And it was because she had experienced such a high degree of relief in her hands and in her nose from those herbs that she listened with undivided attention when I suggested she allow me to do some cupping for her hip. I explained to her that the procedure involved placing a few small plastic bell-shaped cups on her hip and then drawing the air from them with a hand pump and leaving them in place for a few minutes. I had not yet finished this description when she said,

"Oh. You mean bankes."

"What?" I replied.

"Bankes," she repeated.

"What's bankes," I asked.

"I remember when I was a little girl in New York, she started, "that we had neighbors who would come over and my father would have them lay on the sofa and he would put something like that on their back and I was told it always made them feel better afterwards. He called it 'bankes'."

Since that discussion with my mom, I have had literally dozens of patients, who, after I open my "cupping case" say "Oh, your gonna do bankes, aren't you?"

Turns out that such cupping procedures are common to many cultures: Asian, Eastern European, Middle Eastern and Latin American alike. And who can forget the 2016 Rio Olympics when American swimming champ Michael Phelps appeared at pool-side with a "cupping mark" on the back of his shoulder? Who would have thought that "bankes" would make it to the Olympics?

## 2022 HOMESTEAD EXEMPTION

All qualified Florida residents are eligible to receive a Homestead Exemption on their homes, condominiums, co-op apartments, and certain mobile home lots. To qualify for Homestead Exemption, you must own and make the property your permanent residence on January 1st of the year for which you are applying for this valuable exemption. Pursuant to Florida law, all assessments and exemptions are based upon the status of the property on January 1st. If you purchased and/or made the property your permanent residence in 2021 and have not applied for Homestead Exemption, you can apply for 2022 exemptions at any time – there is no need to wait until 2022 to file your exemption application with the property appraiser's office. You can easily apply online at <https://web.bcpa.net>

**The timely deadline to file for all 2022 exemptions is March 1, 2022.** You must make the property your permanent residence by January 1, 2022

in order qualify; however, you have until March 1st to timely file your application with the property appraiser's office. The late filing deadline for all 2022 exemptions is September 19, 2022. For information about all the other exemptions available to qualified applicants, please visit the "Exemptions & Classifications" page on our website <https://web.bcpa.net/bcpaclient/#/Homestead>

Once approved, your Homestead Exemption automatically renews each year provided there is no change in the ownership or use of the property. If you have already applied and been approved for Homestead Exemption at your current property, you do not need to reapply for this exemption. You will receive a Homestead Exemption renewal card next month to keep for your records.

Recently, I spent a very informative day at the Boca Raton Museum of Art improving my knowledge of Ancient Peruvian Cultures at the temporary “Macchu Picchu and Golden Empires” Exhibit. I learned about such Peruvian Ancient Cultures as; The Chavin, Peru’s earliest recorded ancient culture, the Wari, the Salinar, the Lambeyeque, the Vitu, the Moche, the Chimu, and the Inca and the artifacts from these civilizations. I learned about the majesty of the Inca Culture and Macchu Picchu which came later than the other cultures that I studied. At this exhibit, the Moche Culture from 100 to 800AD was extremely well-represented and its mythological hero, Ai Apaec.

I saw splendid ceramic creations from early Peruvian Cultures with Annette McKinney. We especially appreciated the following works; “Funerary Mask of Ai Apaec” from the Moche Culture, 100 to 800AD, Coastal Culture, “Feline-Bird-Snake Hybrid Being” - Vitu Culture, 500 BCE to 300 BCE, Coastal Culture, “Reproductive Union Between Ancestral Beings” Salinar Culture, 500 BCE to 300 AD, Coastal, and “Hunter Offering Deer,” Chancay Culture, 1200-1400 AD, Coastal.

I saw fine gold creations from the different ancient Peruvian Cultures. I was especially intrigued with; “Chavin Gold Crown,” 1200BCE to 1 BCE, Peruvian Highlands, “Imperial Burial Regalia of Gold by the Chimu Culture, 1100 to 1420 AD, and the “Moche Funerary Headress Made of Gold and Sodalite,” 100 AD to 800 AD, Coastal.

I was also fascinated with the Incan Quipu made of animal hairs at this exhibit. Quipus were used by the Incas as record-keeping devices. Perhaps, the Quipus were forerunners of the 21st Century Computers. At this exhibit, there was excellent information about the beauty of Macchu Picchu and the inventiveness of the agrarian ancient Incan Community.

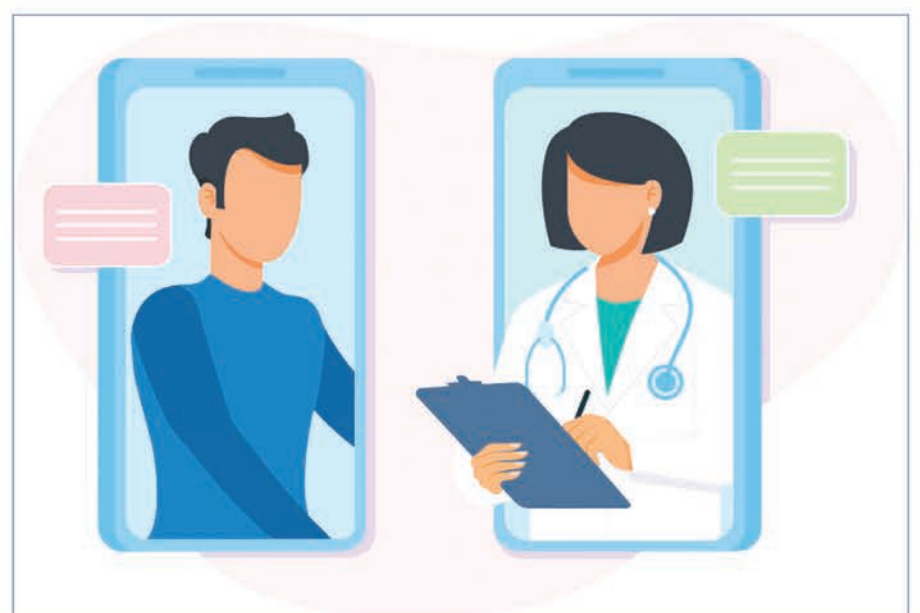

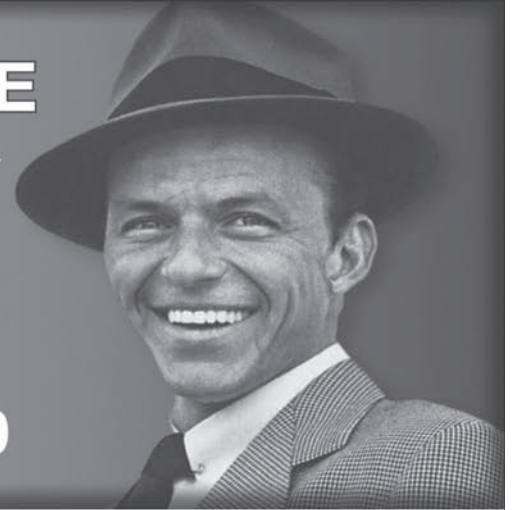

## What is Senior Touchline?

Senior Touchline is a free service that offers a daily telephone call for people over 60 years of age who live alone. The purpose of the program is to ensure that older adults can maintain their sense of well-being while remaining in their homes.

Touchline calls also provide social and emotional support. The 2-1-1 counselor establishes a relationship with the senior and provides them with a sense of security and safety. One simple phone call can help give a client peace of mind knowing that a volunteer will be checking in with them at the same time each day.

## How Does Touchline Work?

Each day, within a pre-determined period, a 2-1-1 counselor calls registered seniors to make sure they are safe and well. If the 2-1-1 counselor is unsuccessful in reaching the senior after one hour of repeated attempts, the designated emergency contacts will be called and asked to check on the senior's well-being. If we cannot reach anyone, we contact the local police department to perform a senior wellness check to confirm their safety.

### How long do you want to sleep?

Many of us are familiar with the adage 'there's nothing like a good night's sleep.' Well, this saying is as popular as it is accurate. Numerous studies have shown that sleep is imperative to our overall health and wellbeing. Yet studies have also found that 1/3 of Americans do not get an adequate amount of sleep. This lack of sleep can be attributed to a multitude of reasons: demanding work schedules, daily stressors, poor sleeping environments, etc. However, there is still a number of people who simply do not know how to manage their sleep.

### The Right Amount of Sleep

A common question we hear is exactly how much sleep should the average person be getting? Studies have found that, as a person grows and develops, the necessary amount of sleep decreases. For example, a newborn baby needs 14-17 hours of sleep while an adolescent child needs only 9-11 hours. Even these numbers continue to dip as a person enters their teens and then, of course, adulthood. The National Sleep Foundation recommends that adults get 7-9 hours of sleep per night. It is important to note that these are just general recommendations. Every individual is different, so the needs of others in the same age range may differ.

### Behind the Hourly Recommendations

Another frequent inquiry is how the amount of sleep different age groups need is determined. Researchers have based their sleep recommendations on the 4 stages of the sleep cycle. The first three stages of sleep are collectively referred to as non-rapid eye movement sleep (NREM). Stages 1 and 2 are lighter sleep in which the mind and body slowly descends into relaxation. Stage 3 is a deeper sleep, which is vital for your body's physical and mental restoration. Finally, the last stage of sleep is rapid eye movement (REM). During this stage of sleep, the body is paralyzed (temporarily) but the brain is flooded with activity. This is where your dreams would occur which, in turn, empower your memory and complex thinking skills. With all of this information in mind, experts choose an amount of time that will allow you to go through multiple sleep cycles. From start to finish, a sleep cycle takes about 90 minutes to complete. 7-9 hours of sleep is equivalent to 5-6 sleep cycles. Ideally, you'll wake up at the end of a sleep cycle rather than in the middle of one. In doing so, you feel more refreshed and invigorated throughout your day.

### The True Importance of Sleep

Everyone is aware that sleep is important but not everyone is aware just how important it is. Getting enough sleep isn't just about not feeling tired. Sleep is essential for every bodily system. In fact, sleep deprivation has long-term and short-term consequences on your physical, emotional, and cognitive health. In the short-term, a lack of sleep can cause:

- excessive daytime sleepiness
- worsened reaction time
- irritability and mood swings
- fragmented memory and decreased problem-solving skills

### Additionally, long-term effects can include:

- hindered immune system leading to increased risk of infections
- weight gain and obesity
- depression and anxiety
- hormonal abnormalities

These are just a few of the damaging effects that stem from sleep deprivation. Thus, sleep is crucial to your well-being throughout your entire life.

It cannot be stressed enough that the amount of sleep we get is extremely important. Be that as it may, it can still be difficult for any person to get their appropriate amount of sleep. You can further improve your sleep hygiene by curating a healthy sleeping environment. Such an environment can be easily manifested by putting away and turning off electronics, creating a quiet atmosphere, and choosing a supportive mattress.

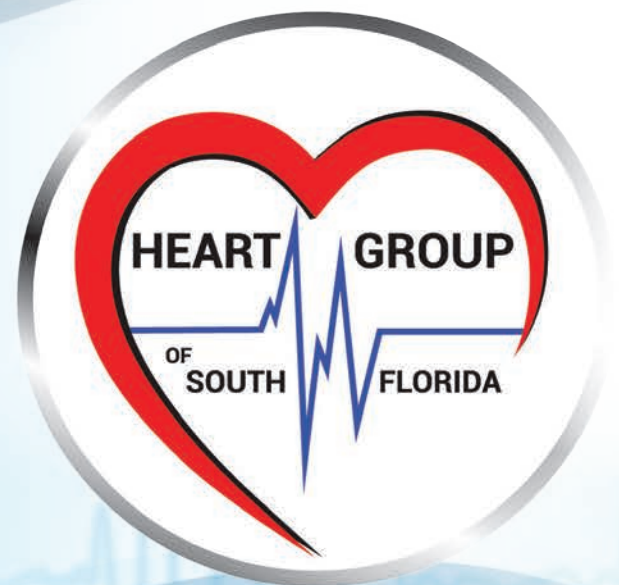

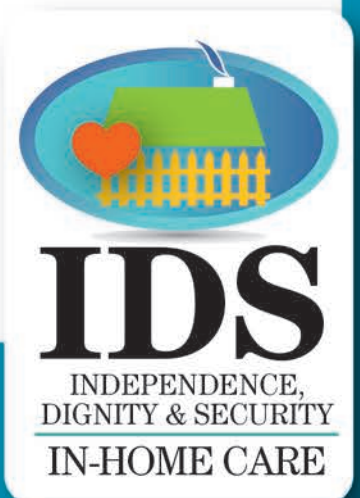

# There Has Been a Misunderstanding



November 1, 2021

We've had people say to us "what's the big deal about a 5.91% yield? My current investment allocations are getting much more than that!"

Well, herein lies a problem. This is the classic misunderstanding of the difference between investing for growth and investing for income.

Maybe you can open your quarterly statement from your 401(k), or your brokerage account and see a YTD "return" figure that is higher. However, what you are seeing is that your account balance is higher because the market value of the shares that you own have increased since the beginning of the year. If the market value of the shares decreases (which can happen at any time) those "gains" will have disappeared. Let me explain. If you purchased 1,000 shares of XYZ stock or ABC mutual fund at \$100 per share, you would have an account balance of \$100,000 as of that moment. If the share price of that stock or mutual fund went up to \$112, your statement would show an account balance of \$112,000. The average person would see that and say, "I made \$12,000!" or 12%. The truth is, unless you SELL those shares at \$112 per share, you haven't made anything. The \$112,000 account balance is simply a representation of the 1,000 shares at \$112 per share at that moment. If the market value of those shares drops back down to \$100 in the next couple of weeks, your account balance will have dropped back down to \$100,000. Of course, you'd then be likely to say, "I lost \$12,000!" but that wouldn't be true, either, because you never "had" the other \$12,000 anyway. That is investing for growth.

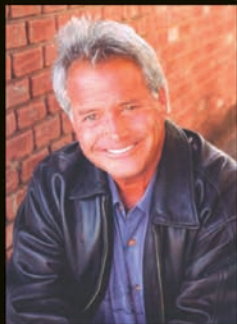

different. To use the same example, you may purchase 1,000 shares or units of a particular income producing security at \$100 per, with a dividend or interest rate attached of 5.91%. Upon making the purchase, you will have the same account balance of \$100,000. However, in this case, you would also have an income stream from those dividends or interest payments of \$5,910 per year. This is cash, separate from the investment itself, which allows you the freedom to spend money without invading your principal (selling shares). If you are not yet spending, then your dividends or interest are being reinvested, purchasing more shares of income producing securities. Perhaps this allows you to see why, when it comes to planning for or thriving in retirement, investing for income makes much more sense. By the way, in case you are gripped by the "fear of missing out" when it comes to shifting to income, just know that our actively managed accounts of fixed income investments have increased in market value by between 14-17% over the last 12 months, as well!

- Use credit cards to buy items instead of bank cards. Credit card companies are easier to work with in case you get scammed or someone steals your identity.

- Watch for "porch pirates," or thieves who steal unattended packages right off your doorstep.

**If you're out driving:**

- Never drive distracted.
- If you have had a few drinks at a party, call a cab, Uber, or Lyft to get home.
- Plan for increased traffic congestion during the holiday season.

**Protecting your residence (though burglaries are rare in Wynmoor):**

- Lock your doors and windows.
- Leave outdoor lights on at night.
- Lock your vehicle and never leave anything valuable in plain view.

As always, if you see or hear anything suspicious, please call 911. The scam artists will keep up their usual attempts to fleece somebody using their phones or try to find a way to take over the computers of unsuspecting victims. I have read police reports from Wynmoor in recent weeks where residents have gotten scammed by a pop-up ad that appears on their computers claiming that they are infected with malware or some other nefarious computer virus. The scammers charged these victims hundreds, sometimes thousands, of dollars to "fix" their computers. We know it was a scam because the victims paid the scammers by loading gift cards full of their money and then giving the fraudsters the numbers on those gift cards.

Getting scammed is not a good way to spend the holidays, and I think I speak for everyone here at the Coconut Creek Police Department when I wish you a Happy Hanukkah or a Merry Christmas! # Estate Planning When Your Spouse or Partner Dies

Losing your spouse, partner or significant other is a very traumatic event. It is most important for your physical and emotional well-being to give yourself time for the grieving process.

Once you feel mentally and emotionally able to do so, you should schedule an appointment with an attorney to review all Estate Planning legal documents.

You should bring your Will and/or Revocable Living Trust, Deed to your home and any other real estate, certified copy of the death certificate and, if married, date of your marriage. If you have advanced care directives such as a Living Will, Durable Power of Attorney and Designation of Health Care Surrogate, you should bring those as well.

If everything you owned was in both names, it is not necessary to probate the Will. However, regarding your home, and any other real estate, it is important to "Clear the Title." The lawyer will prepare, and have you sign a "Continuous Marriage Affidavit," which is why you need the date of your marriage. The Affidavit will state that you were married on a certain date and remained continuously married without divorce until the date of death. It will provide the legal description of your home and other real estate and indicate your intention to clear title. This document will be recorded, along with an Affidavit of No Florida Estate Tax Due and the Death Certificate without the cause of death. Recording these documents will clear title and allow you the option to do a new Deed to avoid probate when you die. If you were not married but owned your home (or any other property) jointly, it is still important to clear title. Of course, a Continuous Marriage Affidavit will not be necessary.

If you do not have a Revocable Living Trust, this appointment will be a good opportunity to discuss the creation of a Trust and

preparation of a Deed in order to avoid probate on your home and other real estate. You can also discuss the option of a Life Estate Deed to avoid probate.

If you do have a Trust, this may be an appropriate time to consider doing an Amendment to the Trust based on new circumstances. Your home and other real estate (in Florida and out-of-state) should be owned by you as Trustee of the Trust. You may wish to name one of your children as Co-Trustee to make it easier to manage the assets in your Trust if you become incapacitated. You may also wish to make changes in your Living Will, Durable Power of Attorney and Designation of Health Care Surrogate or create those documents if you do not have them.

In most cases, there is no urgency to contact an attorney. It is much better to have peace of mind and clarity. Some lawyers, including myself, will offer a free consultation. This consultation should include your options and give you the opportunity to sleep on it before finalizing any new legal documents.

In addition, when you are ready, there are actions you should take for which you do not need an attorney. This includes rolling over your spouse's IRA to yours, claiming life insurance benefits and naming beneficiaries on any joint accounts. However, your lawyer can advise you on these matters.
