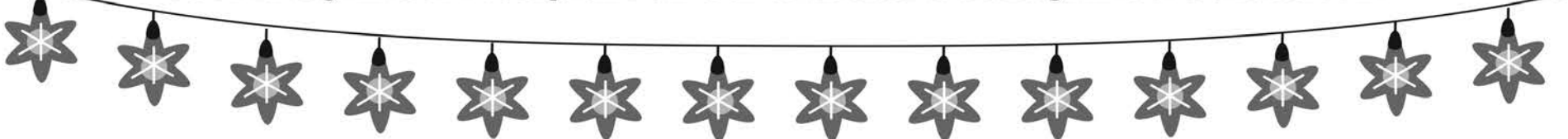

The condominium owner owns his/her unit and an undivided share of the common elements (shared portions) of the condominium. This means for example, the unit

owners all own undivided shares of the pool, the elevator, hallways, etc. In a HOA, owners own parcels, or lots, and the improvements thereon. While the two might sound similar to most, it is legally very different. The Florida Condominium Act, Chapter 718 of the Florida Statutes, governs condominiums in the state such as Wynmoor and The Florida Homeowners Association Act, Chapter 720 of the Florida Statutes governs HOA's.

I would like to take this opportunity to say "thank you" to all the association boards, building directors, etc. Their job is not an easy task. They selflessly devote their time and efforts to what is often a thankless job. Their contribution of time and effort is the perfect example of community living. It allows the great majority of residents to go about their day never noticing what it takes to keep their building and grounds looking great!

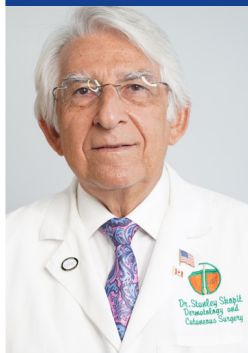

Studying Fine 20th Century Art in Broward County, Florida

Recently, I spent a pleasant day at the NSU Fort Lauderdale Art Museum. The NSU Fort Lauderdale Art Museum is primarily a museum of 20th Century and Contemporary Art. While its art collections are lacking in range, I still appreciate its outstanding collection of paintings and illustrations by American Impressionist, William Glackens. I saw fine portraiture by William Glackens such as these oil paintings; "Lenna in Chinese Costume" (Lenna was Glackens' daughter), "Portrait of Glackens' Wife, Daughter, and Son, Ira in the Living Room" (incomplete painting), "Lenna Drawing," and "Artist's Wife, Edith and Son, Ira." As usual, I appreciated these delightful paintings by William Glackens; "Cape Cod Pier" (marvelous shadows), "Tugboat and Lighter," "Lake Bathers," and "Bayshore." I also saw oil paintings worthy of praise by these painters who were associated with William Glackens; Ernest Lawson "Little House on Peggy's Cove," Maurice Prendergast "Ira Glackens at Five," "Landscape With Carriage," and Charles Prendergast "Bounding Deer." In many respects, I consider Maurice Prendergast's and Ernest Lawson's style of painting to be even more inventive than William Glackens' style of painting. I also saw splendid illustrations by Glackens of crowded life on the Lower Eastside of New

York City in the very early 20th Century (these works had a plethora of details). I especially studied the illustration, "4th of July Celebration" in a very assiduous manner.

The NSU Fort Lauderdale Art Museum has a fine collection of ceramic works by Pablo Picasso including; "Owl," "Large Bird," "Woman Lamp," and "Hand With Fish." The ceramic works on display were done, during Picasso's later years. Picasso in his later years enjoyed working with clay.

Another specialty of the NSU Fort Lauderdale Art Museum is its collection of COBRA Art. COBRA is an acronym for Copenhagen, Brussels, and Amsterdam. COBRA was a major European Art School, after World War Two until the later part of the 20th Century in Denmark, Belgium, and Holland. I saw fine works by these pioneering COBRA artists; Karel Appel "Couple," Maggi Giles "Maquette" ceramic creation, Henry Heerop "Moon Girl," and Lucibert "Blue Boy," among others.

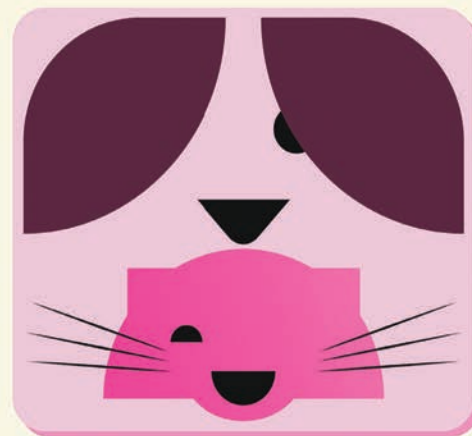

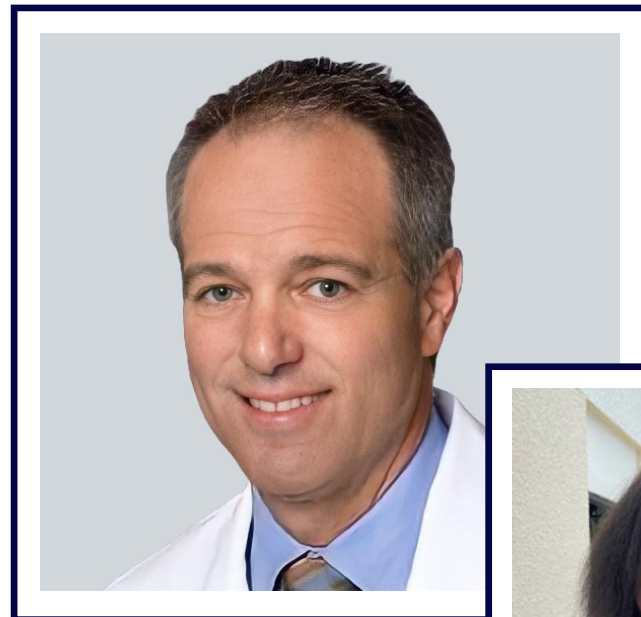

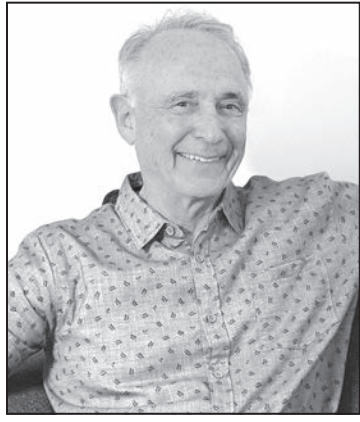

240th Anniversary of the Newburgh Conspiracy

In the spring of 1783, the Continental Army was stationed at Newburgh, NY, keeping an eye on the British who still occupied New York City. The shooting war had ended in October of 1781 with the surrender of General Cornwallis and his army at Yorktown Heights, Virginia. Peace treaty negotiations were proceeding slowly at Paris. A message took six weeks to

cross the Atlantic, and many messages were lost at sea. France, a participant in the negotiations, had its own agenda. The Continental currency was rapidly declining in value.

The United States had entered a new, but still perilous period. The main cable that tied the States together, Britain as a common enemy, was gone. Some feared America would evolve like Europe, as a collection of sovereign states, geographically bunched up against each other. The Articles of Confederation, which created the Congress, were deeply flawed from the point of view of the Centralists: James Madison, Alexander Hamilton, Robert Morris, and many others who wanted a strong central government. The Congress was weak and ineffectual. Almost all the power resided in the States. Although Congress had the responsibility to maintain the army, it had no power to raise money. Congress could only ask the states to pay but had no power to force them. All the money and taxing power resided in the states. Although the states had grudgingly agreed to a Confederation, they wanted a weak Congress. Having just eliminated one far away oppressor, the States were in no mood to establish another, even though closer by. In effect, they were 13 separate sovereign countries tied together by a weak Congress.

Robert Morris, Superintendent of Finance (forerunner to Secretary of the Treasury), stopped paying the Continental soldiers in the spring of 1782. There were no funds to pay them, and the States would not pay. Congress was \$6 million in debt.

In the fall of 1782, Morris begged the three holdout governors of Massachusetts, Maryland, and Rhode Island to vote for an import tax to allow Congress to raise funds. Morris said: "Let me repeat that the hope of our Enemy is the derangement of our Finances, and let me add, that when revenue is given, that hope must cease." This proposed import tax, however, was defeated in Congress in November, 1782. David Howell of Rhode Island led the movement which doomed the measure to failure.

In December, senior officers and soldiers petitioned Congress to try to get funding for the army restored. A letter, drafted by senior army officers including Major General Henry Knox, was circulated in Congress. Henry Knox, one of Washington's most trusted Generals, was no mutineer. He lent much creditability to the petition and letter. When later asked about Congress' neglect of the troops and what might be the army's reaction, Knox acknowledged the limits of the Continental Army, describing it as: "... a very sharp point which I hope in God will never be directed than against the Enemies of the liberties of America."

The letter asked for a lump sum payment and back pay instead of the lifetime payment the Congress had judged too expensive. The letter also included a threat: "Any further experiments on the Army's patience may

have fatal effects." Further, George Washington, himself, said at the time: "The Army is a dangerous instrument to play with."

In February 1783, many in the army became increasingly unhappy. Hamilton urged George Washington to come out in support of the army. Washington said at the time: "To me...it is clearly my opinion, unless Congress have powers competent to all general purposes, that the distresses we have encountered, the expenses we have incurred, and the blood we have spilt in the course of an Eight years war, will avail us nothing." Washington, who had the utmost respect for civilian authority, urged patience.

In March 1783 an anonymous letter circulated in the army calling for a mutiny. It urged that if they were not paid, the soldiers should either leave the colonies and go west or take up arms against the Congress and gain their rightful pay by force. A meeting was set by the conspirators, but George Washington got wind of it. He rescheduled the meeting for March 15th and implied that he would not attend. The conspirators, apparently led by Major General Horatio Gates, a long time Washington detractor, took heart. To everyone's surprise, however, Washington did attend, and Gates ceded the floor to Washington. Washington delivered a stirring and memorable address to his officers that day, restoring calm among the disheartened troops.

Washington's eloquent Newburgh Address circulated widely. Shortly afterwards, on March 19th, 1783, Congress voted to enact a pension of five years full pay for the Continental soldiers. Washington's masterful handling of this mutinous plot diffused a potential disaster. He securely planted in the new and evolving American form of government, the idea of civilian control of the military and the desirability of a republican form of government.

Epilogue

Despite Washington's persuading the soldiers to remain patient, in June 1783, some army units did mutiny in Philadelphia and demand their pay. Congress, which had been in-session there, was insulted. Hoping to call attention to Congress' ineffectual condition, the congressmen abruptly left Philadelphia and resumed their session in Princeton New Jersey.

Consider Financial Gifts For Grandchildren

If you have grandchildren, you probably enjoy spending time with them and watching them grow. And to help them achieve a bright future, you might like to make some financial gifts — but which ones?

You have several options. Let's look at three of them:

• **529 plans** — When you invest in a 529 education savings plan, any earnings growth is distributed federally tax free, as long as withdrawals are used for qualified education expenses. (Withdrawals used for expenses other than qualified education expenses may be subject to federal and state taxes, plus a 10% penalty.) And in-state residents who invest in their home state's 529 plan may also receive state tax incentives. A 529 plan can be used for college, approved trade school programs, qualified student loan repayments and even some K-12 costs. And if the grandchild you've named as a beneficiary of a 529 plan decides to forego further education, you can generally switch beneficiaries to another immediate family member. You can contribute up to \$17,000 in 2023, per grandchild, to a 529 plan without incurring gift taxes. Furthermore, as of the 2024–25 school year, grandparent-owned 529 plans won't affect financial aid eligibility. However, tax issues for 529 plans can be complex, so consult with your tax advisor about your situation.

• **Roth IRA** — Any earnings growth in a Roth IRA is distributed tax free, provided the owner is at least 59½ and has had the account at least five years. If your grandchildren earn money from babysitting or a part-time job, they can open a Roth IRA with the help of a parent or other adult. You could “match” your grandchildren's contributions, possibly on a dollar-for-dollar basis, to provide them with an incentive for saving. In fact, you could fully fund the Roth IRA, up to the annual contribution limit, which is \$6,500 or the amount of your grandchild's taxable compensation, whichever is less.

(The annual limit is \$7,500 for those 50 or older.) And your grandchildren can withdraw the contributions — not the earnings — at any time to pay for college or anything else.

• **Custodial account** — You can open a custodial account, also known as an UGMA or UTMA account, for a grandchild, and fund it with most types of investments: stocks, mutual funds, bonds and so on. For that reason, it can be a good way to teach grandchildren about the nature of investing — risks, returns and the value of holding investments for the long term. Plus, there's an initial tax benefit to custodial accounts: The first \$1,250 of your grandchild's investment income (dividends, interest, capital gains) is tax free, and the next \$1,250 is taxed at the child's rate. Anything above that amount is taxed at the parents' marginal tax rate. However, once your grandchildren reach the age of termination — usually 18 or 21, depending on where they live — they take control of the account and can do whatever they choose with the money. So, while a custodial account could be considered as a funding source for college, it might alternatively serve as a gift that could eventually enable your grandchild to fulfill another desire or goal — take an overseas trip, pay for a car, or maybe even start on a path to entrepreneurship.

Making financial gifts to your grandchildren can be rewarding — for them and for you. So, consider the possibilities carefully and put your generosity to work.

Have you ever heard of Ben Yehuda Street in Jerusalem? Who was Ben Yehuda? He was a man with a vision-to bring the Hebrew language up to modern standards and make it real for everyday use. Eliezer Ben Yehuda was a Russian Jewish linguist born in 1858 (died 1922).

He was the lexicographer of the first Hebrew dictionary, the editor of one of the first Hebrew newspapers published in the Land of Israel, and the main force behind the revival of the Hebrew language. He was a graduate of the Sorbonne University.

Eliazer Yitzhak Perlman, who later became Eliezer Ben Yehuda was born to Yehuda Leib and Tzipora Pearlman who were Chabad Hasidim, his native language was Yiddish. Languages came easy to him, and he was fluent in French, German and Russian. When he was at the Sorbonne, he met a man from Jerusalem who spoke Hebrew with him. This conversation convinced him that Hebrew could be revived as the language of a nation.

In 1881, Ben Yehuda. Join the first Aliyah and immigrated to Palestine, then ruled by the Ottoman Empire and settled in Jerusalem. He set out to replace Yiddish and other regional dialects with a modern Hebrew to use as a means of everyday communication between Jews who moved to the Land of Israel from various regions of the world. His son became the first native speaker of Hebrew

in modern times. His daughter also only spoke Hebrew.

He was one of the founders of the Academy of the Hebrew Language, an organization which still exists today. He used ancient languages and Modern Standard Arabic as sources in his work. He used many words and rules of grammar from Semitic roots: Aramaic, Canaanite and Egyptian.

Many Orthodox Jews of the time were against what he was doing. They believed that Hebrew, which they learned as a biblical language, should not be used to discuss such mundane and non-holy things. At one point, in 1893, he and his father-in-law were imprisoned by the Ottoman authorities in Jerusalem following accusations by members of the Jewish community that they were inciting rebellion against the government.

He had two wives, his first wife died of tuberculosis, leaving him with five small children. Her final wish was that Eliezer marry her younger sister Paul, which he did. She took the Hebrew name Hemda. She became an accomplished journalist and author herself, and she completed the Hebrew Dictionary decades after a late Eliza's death.

Now, when you hear a play by play of a Tennis match in Hebrew or see a recipe or say a curse word in Hebrew, think of Ben Yehuda, not as a street, but as a singular human being trying to attain a goal many did not want. He did succeed.

My Third Act #12 – A Cautionary Tale

I woke up in the morning with a scratchy throat and immediately thought COVID! I don't catastrophize, but I also don't get sore throats. Plus, Covid is once again spreading like crazy - I keep hearing about people in my community who have it. I got myself a cup of coffee and, by the time I had finished drinking it, my throat was fine, and I felt like I had dodged a bullet.

By afternoon I felt like I was getting a cold. I felt a little stuffed up and I had a bit of a headache. Now I was a little worried. I usually don't get colds. Once I quit smoking 43 years ago while living up north, I stopped getting colds. And, almost never got sick.

I decided, if I was not better by morning, I would make an appointment and get tested for Covid. To be on the safe side, I did decide to stay in. I wouldn't want anyone else to get sick.

Some history - I had gotten Covid in July 2021 two years ago before

vaccinations were available. My friend and I were performing in a small theater and people were not wearing masks in the audience. After the performance, one of the women I knew came up to see me. I could tell she was under the weather. Two days later I woke up sick with a cold which got worse as the day went on. My temperature spiked to over 102.5. I called my boss and told her I wouldn't be working because I had a cold. She strongly suggested that I get tested for Covid and told me the clinic to go to. I went there with a mask on, signed in and was told to wait in my car where they would text me when they were ready to do the test. After the test I went home and waited for the results which turned out to be positive. Since I had COPD I was very scared of Covid going into my chest. I slept upright and, thankfully, it didn't travel to my chest. I admit, for the first few days until the fever broke, I was a little scared because I was sicker than I ever had remembered being. The greatest fear was that I would have to go to the hospital - I really didn't want to go there because so many had gone and not come out again. It was only after I got better that I told some friends about the temperature - one said I should have gone to the hospital immediately. I'm glad I kept my mouth shut!

Back to the present. By morning, the cold was a little worse than the day before so I made an appointment for that afternoon at the Minute Clinic. I really didn't think I had Covid because it wasn't anything like the last time when I was really sick. I had had all 5 previous vaccinations and was planning on getting the current one the following week. The nurse took the test, and we spent the time waiting for the results chatting about this and that. Once she got the results the look on her face told me all I needed to know. As shocked as I was, I knew this time I would be able to handle this easily. Also, I was relieved that I had found out so I could contact everyone I had been in contact with. Only one of the two friends I had been with the day before also got Covid. Both of us found it easy to manage except for the fatigue which has eased but are still experiencing almost a month later.

I decided to write this as a cautionary tale because people are walking around with Covid and spreading it not realizing they have it. Choosing the Best Acupuncturist for Your Needs

Let's say that through your research about acupuncture and how it may be able to help you, you've decided to give it a try. You've written down a few names from the internet, from friends or relatives who have had successful treatment, or perhaps your primary care physician or your health insurance company have given you the names of a few providers who are in-network with your policy. But how do you go about making the right choice?

Here are a few things you may wish to consider when choosing any new specialist. Look for someone who

1. Asks and Answers Questions

An acupuncturist who asks questions is a good acupuncturist. This allows them to get to the root of your health issues and make a determination if acupuncture is the appropriate course of action.

Are they willing and able to answer all of your questions? You should feel comfortable asking questions about anything from their experience treating your specific health issues to their professional qualifications to questions about self-care.

Before receiving any treatment, make sure the provider has clearly explained their assessment of your condition, their short-term and long-term treatment goals for you, the methods they intend to use to achieve those goals, and what you should expect as their patient. They should be clear in their estimate of how many treatments they feel will be needed to resolve your health issues and how long it will take before you can expect to experience positive results. Ask about any follow-up or maintenance care that may be necessary to help keep you well.

2. Spends Plenty of Time with You

No one should have to endure an acupuncture session with a practitioner who appears rushed and distracted. Whether they stay in the treatment room with you during the entire session, or leave to attend to other patients simultaneously, you should always feel safe and supported, and that you will be taken care of.

3. Is Up-front About Cost

There should be no surprises regarding the cost of your care. Discuss the exact cost of the initial session and each follow-up visit. Ask about insurance billing for your care and any out-of-pocket expenses.

4. Is Convenient

The location of the practice and hours of operation are often just as important as the acupuncturist. Look for a practitioner that is easy to get to and close to your home. Take note of the hours of operation as many acupuncturists have limited availability. Ask about their policy regarding appointment cancellations and rescheduling. Pay attention to the small details as well. Is there ample parking? Is there an elevator or are they located on the first floor? If you use a wheelchair is the office wheelchair accessible?

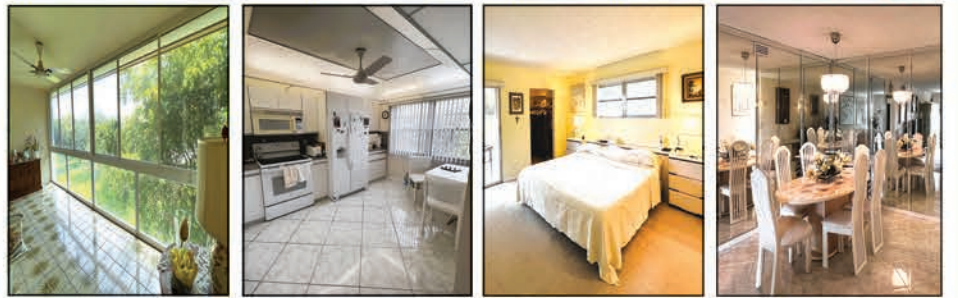

Achieving Excellence, Exceeding Expectations

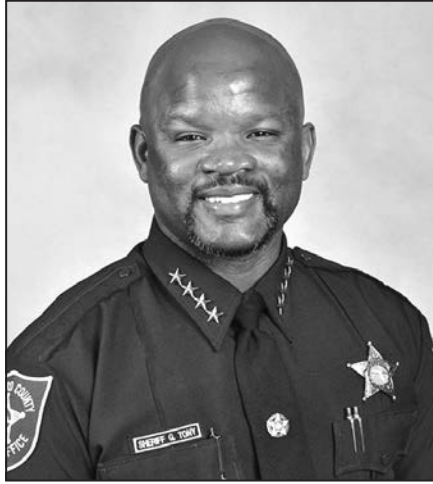
As the holiday season approaches, the Broward Sheriff's Office is filled with gratitude for the privilege of serving you. During this time of reflection and celebration, I want to share some of the remarkable achievements we have made throughout the year. In 2023, BSO has continued developing innovative solutions focused on the safety and well-being of Broward County. These efforts have made us an even more accountable, efficient organization and a true leader in public safety.

PUBLIC SAFETY: Our commitment to keeping the public safe remains our top priority. By utilizing advanced technology, our Real Time Crime Center (RTCC) can proactively detect potential threats and prevent acts of mass violence before they occur. Our success has been met with an increase in funding, allowing for the expansion of our technological capabilities, further elevating our proactive policing. Our other bold policing initiatives include the Burglary Apprehension Team (BAT) and Violent Intervention Proactive Enforcement Response (VIPER) units. Collectively, these units have brought violent offenders to justice, thwarted dangerous, illegal street racing and participated in various countywide operations to combat violence in our community.

SCHOOL SAFETY: In addition to the RTCC, we continue to implement new programs, bolster training and forge partnerships with local, state and federal law enforcement to enhance school safety. This year, our efforts expanded to address a fast-emerging crime targeting our youth: financial sextortion. We partnered with Broward County Public Schools and the South Florida Internet Crimes Against Children (ICAC) Task Force to launch an educational campaign to raise awareness and prevent further victimization.

TRAINING AND PREPAREDNESS: Training and preparedness are paramount to public safety. As we approach the grand opening of our Research, Development and Training Center (RDTC), we will stay committed to elevating the training techniques, tactics and education for all our first responders and civilian staff. The 108,000-square-foot state-of-the-art training center will be like no other in the state and will serve as a model for other public safety agencies to follow.

COMMUNITY ENGAGEMENT: The innovative initiatives we've implemented this year have worked to continue enhancing our relationship with our residents and build trust within our community. Our Neighborhood Support Team is reaching out and collaborating with communities that traditionally shied away from law enforcement. The Park, Walk and Talk



program has yielded more than 77,000 encounters with individuals in the community, building bonds of support and resiliency. This year, we had the privilege of investing \$880,000 back into the community, supporting non-profit organizations focused on crime prevention, empowerment and creating lasting and meaningful change in the lives of countless individuals throughout Broward County. In addition, we've launched vital mental health programs to support individuals experiencing mental health crises and connect them to critical community resources instead of putting them in jail.

DIVERSITY: Since day one, I have promoted people from within the organization, which has undoubtedly contributed to our operational success due to the years of valuable institutional knowledge. This year was no exception. I was honored to promote additional women and minorities to leadership positions, further diversifying the organization to reflect our community. I am proud to say that today, BSO has the most diverse command staff in the agency's 108-year history.

ACCOUNTABILITY AND TRANSPARENCY: BSO remains a beacon of accountability and transparency, exemplified by our actions. This year, we welcomed new members to BSO's Social Justice Task Force (SJTF). The task force, launched in 2020 following the murder of George Floyd and the deaths of other persons of color, is comprised of Broward residents, community stakeholders and BSO leaders, who take an active role in addressing community concerns. These efforts achieved transformative and everlasting change for all our residents. In addition, our Office of Inspector General, created in 2021 to ensure the organization runs efficiently, economically and responsibly, continued to investigate employee misconduct allegations thoroughly.

While our primary mission is to ensure the safety and well-being of our residents, we have been recognized locally, nationally and internationally for the exceptional work we do to serve Broward County. 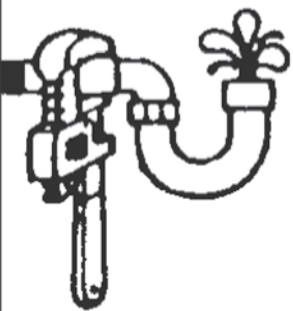

Revocable Living Trust Important for Out of State Property

Are you a snowbird just returning to Florida for the winter? Some of my clients have their homestead in Florida; others declare their legal residence in another state.

In either case, a Revocable Living Trust is very useful to avoid probate in both states. If you are a Florida resident, you can own your homestead property via a Revocable Living Trust without losing your homestead exemption. In addition, you are eliminating the need for probate when you pass away. You can also transfer real estate owned in any other state to your Florida Trust. Generally, a Florida lawyer will prepare the Revocable Living Trust and Quit Claim Deed to transfer the Florida property into the Trust. If you are a Florida resident, the lawyer will also prepare a new Florida Last Will and Testament called a Pourover Will. This provides for the transfer to your Trust upon your death of any other assets not in the Trust or which do not have beneficiaries already designated. It is a security blanket to cover any assets payable to your Estate. For example, if you were killed in a car accident due to the negligence of another driver, your Personal Representative would be able to settle your Estate's wrongful death claim and "pourover" the proceeds into your Trust.

If you are not a Florida resident, you can still create a Revocable Living Trust and execute a Quit Claim Deed to put your Florida property into the Trust. Your Last Will and Testament will be done by a lawyer in the state in which you have your legal residence. In addition, that lawyer can prepare a Deed to transfer the out of state property into the Florida Trust. You can also do the Trust in your state of residence and have a Florida lawyer transfer your Florida property to that Trust.

For Canadian citizens, there are possible tax aspects to be considered before you create a Florida Trust. These should be discussed with your Canadian



accountant or tax attorney. In general, you will have to weigh the tax consequences versus the money and time that your heirs would save by avoiding probate in Florida.

Another favorable factor in creating a Revocable Living Trust is that you can always amend the Trust without having to change the Deed. In addition, once you create the Trust, you can always buy new properties in any state in the name of the Trust.

The Revocable Living Trust is recommended by most lawyers over a Deed which includes names of other persons, either as joint tenants, tenants in common or a Life Estate Deed. Once another person's name is on a Deed, there are potential risks to you and your property. These include the possibility that the other person may undergo a divorce, bankruptcy, have a judgment against that person, or die before you or with you in a common accident. It may also affect your homestead exemption. All of these risks should be discussed with your attorney before deciding to put someone else's name on your Deed. By contrast, the Revocable Living Trust eliminates those risks since no other name is on the Deed. You simply transfer it from yourself to yourself as Trustee of your Trust.

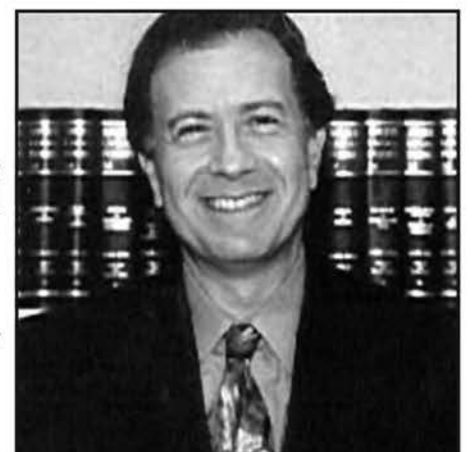

ASK DR. JOY

Mind and Body

After reading an article by Andrea de Michaelis, publisher of Horizons magazines, I thought I would rewrite it here using my words along with Andrea's. Most of these ideas are in my book, *The Pursuit of Happiness*, but it's time for a refresher article on the subject.

Every time you have a thought your brain produces a chemical. If you think happy thoughts you will make chemicals that produce even happier feel-good feelings. And conversely thinking negative thoughts will produce chemicals that will make you feel worse.

Imagine having an insecure thought. Since our thoughts produce our feelings, the next thing that happens is that you begin to feel insecure. Then the loop begins and you begin the momentum of thinking more insecure thoughts and feeling more insecure. Momentum takes on a life of its own and on and on we go.

We then start feeling our thoughts instead of thinking them and the body, rather than the conscious mind, is running the show. When this happens, a person can't do anything but think the way they feel. Instead of the body being the servant of the mind, the mind becomes the servant of the body.

For some people this awareness becomes the turning point in their lives and they begin asking themselves some critical questions. Questions that the majority of people either don't have the time, awareness or desire to ask. Questions like: What would it feel like to be happier and feel better? Who do I know who is happy and positive thinking? What would I have to change in myself to live that way? At what point did I lose my joy and believe this is who I am?

At that point we can stop our automatic programs. Our brains switch gears and reassemble allowing the answers to these questions to rewire it so it becomes available to conscious volitional thoughts. Once that happens our brains are ours to carry out our new thoughts and produce a new reality. We can then keep on producing those chemical pathways to more positive thought which lead to new beliefs and then new belief systems so the momentum shifts so completely that it actually becomes difficult to hold on to a negative thought.

Some people begin to feel anxious at the thought of changing so drastically and become afraid to even take the first step towards growth. The thing is, if you want to take small steps you can and if you really want to and go ahead and jump into a change of consciousness like a quantum leap or aha moment you can do that too. Go at your own pace. Whatever way you do it happiness will follow.

I just finished reading a wonderful book called *You Can't Afford a Negative Thought*. How true. Negative thinking always leads to negative feelings which all too often leads to negative physical conditions. The reverse is also true. Please take a moment to answer the above questions. It's never too late to change gears.

This is a short article but packed with good information. When you master this concept good things will begin to automatically flow into your life. It requires some reflection and then some mindfulness but it will definitely be well worth it.

2024 Homestead Exemption

All qualified Florida residents are eligible to receive a Homestead Exemption on their homes, condominiums, co-op apartments, and certain mobile home lots. To qualify for Homestead Exemption, you must own and make the property your permanent residence on January 1st of the year for which you are applying for this valuable exemption. Pursuant to Florida law, all assessments and exemptions are based upon the status of the property on January 1st. If you acquired the property as your permanent residence in 2023 and have not applied for Homestead Exemption, you can apply for 2024 exemptions at any time – there is no need to wait until 2024 to file your exemption application. You can easily apply online at <https://web.bcpa.net/bcpaclient/#/HomesteadExemption>

The timely deadline to file for all 2024 exemptions is March 1, 2024. You must make the property your permanent residence by January 1, 2024 in order to qualify; however, you have until March 1st to timely file your application with the property appraiser’s office. The late filing deadline for all 2024 exemptions is September 18, 2024. For information about all the other exemptions available, please visit the “Exemptions & Classifications” page

on our website <https://web.bcpa.net/bcpaclient/#/Homestead>

Once approved, your Homestead Exemption automatically renews each year provided there is no change in the ownership or use of the property. If you have already applied and been approved for Homestead Exemption at your current property, you do not need to reapply for this exemption. You will receive a Homestead Exemption renewal card next month to keep for your records.

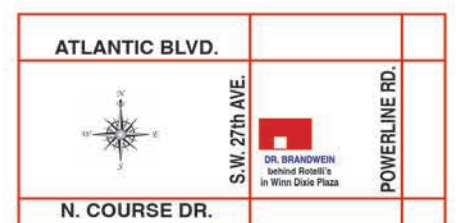

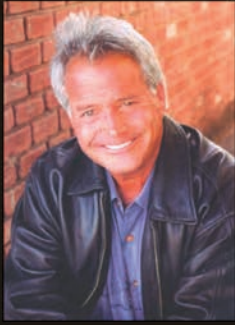

bed. About 60% of our vehicle burglary cases involve either unlocked car doors or no sign of forced entry.

2) Lock everything up when you go for a walk, run, or go out to walk the dog. Again, it's just a good habit to get into.

3) Shut your garage door. We have a lot of things stolen from open garage areas, not only this time of year but all times of the year.

4) Track your package deliveries to make sure you are home. If you're not at home, try having them delivered to work or tell your neighbor to pick them up off your front doorstep. We typically see an increase in porch pirates this time of year.

If you're out shopping-

1) Don't leave your purse or wallet laying around. Always keep it on you.

2) Park in well-lit areas.

3) Get into the habit of having your keys in your hand when you approach your car. It streamlines the process of getting in and can be used as an improvised weapon if you really get in a pinch.

4) Don't bury your face in your phone when you're walking to and from your car into or out of the shopping mall or store. You need to always be situationally aware and be in tune with your surroundings.
